It prohibits health care workers from profiting from these referrals. And it had no opposition in committee. I believe that there are a lot of very satisfied parties that are... we are moving forward to legitimize alcohol and drug abuse treatment. I would appreciate an 'aye' vote."

Speaker Lang: "Mr. Breen."

Breen: "And Representative, just to confirm, you're adding to our Consumer Fraud & Deceptive Business Practices Act about seeking mental health disorder and substance use disorder treatment outside of the State of Illinois. What... what's the... what was the need for this particular regulation about misleading or false advertising about treatment outside the State of Illinois?"

Feigenholtz: "There have been a lot of internet trollers, Representative Breen, who have essentially, I guess we could label them patient brokers that are less than reputable, shall we say, and do not follow appropriate guidelines and actual treatment plans that are falsely encouraging patients and families who are desperately seeking solutions for addiction treatment and mental health treatment and trying to lure them

outside of Illinois. Many of these people do not have coverage for these out-of-network and out-of-state places and the travel costs are extreme. And this is our way of ebbing that in our State of Illinois for our constituents."

- Breen: "And then... just so that I'm clear, is it... is it also currently an unlawful practice to engage in misleading and false advertising or promotion to misrepresent that treatment in the State of Illinois? Is that already barred by our Act?"
- Feigenholtz: "I'm going to have to get back to you on that. I don't have the answer to that, but I believe that it is covered."
- Breen: "Okay. And then I see that you're... you're... it appears to be you're adding a requirement for all advertising or marketing about mental health disorders or substance use disorders that they must display the physical address of the treatment program, include a link to the State of Illinois Department of Human Services, that they must state that the treatment may be available for a reduced cost or free for Illinois residents within the State of Illinois. Is that... that's right that we're adding that requirement on all advertising directed into the State of Illinois?"
- Feigenholtz: "Yes. You know... Representative Breen, something of note that I think you would be interested in is that we had to do something similar when it came to adoption agencies in the State of Illinois back in 20... 2005 where, because of what happens on the internet, it was very important that out-of-state providers have a nexus. And we really have to be mindful of deceptive practices and the cost that some of our people who are desperately seeking help incur because their hope and

dream is that their loved one will be able to achieve recovery and they're willing to do just about anything. So, I appreciate your questions and hope I've answered them."

Breen: "Okay. And I guess... part of the problem is that sometimes when somebody puts out an advertisement on the internet, there's no nexus to the state and so, saying that if they're advertising Illinois residents do they... I mean, does just generally, let's say, does the Mayo Clinic have to put a disclaimer for Illinois residents on their primary website just because they might happen to reach folks in Illinois or they certainly want to have folks from Illinois come to them. Say, not a fly-by-night institution, but say the Mayo Clinic or someone like that. I mean, a real, an actual, legit behavioral health provider like the Mayo Clinic. Do they have to do this? Do they have to have a separate webpage for... you know, with an Illinois set of disclaimers?"

Feigenholtz: "Well, I think another problem that we're going to have, Representative, is ultimately we're prohibiting fee splitting. And I mean, I think your questions are very legitimate. You're trying to figure out where the hammer is here. Is that what the question is? How are we going to know who's the good guys and who's the bad guys?"

Breen: "Well, and it's not just that. It's also that we are enforcing... it is a compelled speech. So certainly the First Amendment folks have a right to advertise. The Commerce clause, I mean, you can... the right to travel, that sort of thing. You do have a right to, if you're an out-of-state behavioral health provider, you can try to get folks from Illinois to come to you and giving perfectly legitimate

- reasons. You might have an expertise or what have you. So, I would just... I'm little bit worried about the language."
- Feigenholtz: "And honestly, the way that that is dealt with in the Bill is the link to the Department of Human Services where they monitor who the legitimate providers are and who are not."
- Breen: "Right. And then... I'm wondering, when you say directed at Illinois residents, so again, what does that mean for... again, the Mayo Clinic, is not located in Illinois. I'm assuming they want... we have plenty of folks from Illinois who go there or may have... you may have a specialized treatment center somewhere. How do you delineate an advertisement directed at an Illinois resident and one just on the internet offered to any... anyone in the country to come and you know, come to that facility?"
- Feigenholtz: "Well, these are... we're talking about out-of-state facilities..."
- Breen: "Right. The Mayo Clinic, for instance, obviously not a fly-by-night institution."
- Feigenholtz: "Correct."
- Breen: "I mean, you know, one of the finest in the country recognized by all or you know the Cleveland clinics, those sort of folks."
- Feigenholtz: "It... it... This..."
- Breen: "What are they... what are they going to be bound to do under this Act, if anything?"
- Feigenholtz: "...this Bill does not prevent them from advertising or it doesn't apply to Illinois health insurers or managed care organizations."

Breen: "But it... I'm confused. So, if... I mean, those out-of-state... So, I'm wondering are we... are we putting a burden on out-of-state providers that they've got to do disclaimers on any page that is viewed by Illinoisans or directed... 'cause I see it is directed Illinois residents. I'm wondering, I mean, is there any limiting principle on your Bill?"

Feigenholtz: "We are not in any way trying to discourage reputable, out-of-state providers, Representative Breen, in this Act. I..."

Breen: "I didn't mean discourage..."

Feigenholtz: "...I think you..."

Breen: "...but they are now going to be required."

Feigenholtz: "...I think you should read the language of the Bill.

And..."

Breen: "Right. It says any marketing, advertising, promotional, or sales materials directed to Illinois residents concerning mental health disorder or substance use disorder must have these... have these particular points. And..."

Feigenholtz: "Can you cite what Section you're looking at?"

Breen: "As I understand it, it's the… your Amendment to the Consumer Fraud and Deceptive Business Practice Act. I believe it's in that part of your Bill."

Feigenholtz: "I would like to..."

Breen: "It's page 6, lines 12 through 24 of your Bill."

Feigenholtz: "I have to read the whole Consumer Fraud & Business
Practice Act..."

Breen: "No, no, no. In your Bill, page 6, lines 12 through 24.

So, I understand what you're doing. You know, you're saying it's an... we're explicitly stating it's an unlawful practice

to engage in misleading or false advertising about out-of-state mental health, substance abuse disorder treatment. I'm more concerned about what requirements are we placing on... by placing a... we're placing a burden of a particular set of information on every marketing, advertising, promotional, or sales material directed to Illinois residents in... concerning, which is a broad word, mental health disorder, substance abuse disorder treatment. It's a pretty broad requirement. And I'm wondering does it apply to every out-of-state... is it every facility in the country?"

Feigenholtz: "So, Representative, I... with a little bit of assistance, I think that the belief is that reputable organizations know how to manage and work... currently work with the Department of Insurance and know how to set up their websites so they are not part of this very distinct group of brokers and the actual bad actors that we're trying to get to. So, ultimately, if they are good brokers and they're good providers, they've got nothing to hide and they are free to advertise. If they're not and they're perpetrators, then they will be cited and now we are bringing them under this Act. I hope that answers your question."

Breen: "Well, I'm still getting you out of it. So, you're adding a requirement that every mental health or substance abuse disorder advertisement or promotional material include several disclaimers. I understand that and I understand for Illinois... for folks that are in Illinois or you're serving ads directly to Illinois, so be it. What does the Mayo Clinic have to do under your Bill? Do they have to put these disclaimers on their website? Does every mental health

provider in the country that receives patients from Illinois have to put this on their website? Where is the limit to your new requirement?"

Feigenholtz: "Representative, I'm going to momentarily take this out of the record to get that answer for you."

Breen: "Thank you."

Speaker Turner: "Mr. Clerk, please take this Bill out of the record. Representative Demmer is recognized."

Demmer: "Thank you, Mr. Speaker. Please let the record reflect that Representative Reick is excused for the day."

Speaker Turner: "Thank you, Representative. House Bill 4397, Leader Lang. Mr. Clerk, please read the Bill. 4397."

Clerk Hollman: "House Bill 4397, a Bill for an Act concerning education. Third Reading of this House Bill."

In the process, we exempted actual debt collectors from this Act but neglected to exempt attorneys who do debt collection from this Act. That's all the Bill does."

Speaker Turner: "Chair recognizes Representative Breen."

Breen: "Will the Sponsor yield?"

Speaker Turner: "Sponsor indicates that he will yield."

Breen: "Thank you. And Representative, I just wanted to make sure that it's clear that the proponents are folks like community

bankers, credit union league, and that there are no opponents to the Bill."

Lang: "As far as I know, there are no opponents and I do not recall any in committee, Sir."

Breen: "Okay. Thank you."

Speaker Turner: "Lang to close."

Speaker Turner: "The question is, 'Shall House Bill 4397 pass?'
