as *Cleared for Takeoff*. This African-American figure from Southern Illinois is this day's figure in black history. Thank you, Mr. Speaker."

He marched across Italy in 1943, he stormed the beaches of Normandy in 1944, and the following year he pushed through France. He was a recipient of the Purple Heart for a leq wound. He also received a second Purple Heart and the Oak Leaf Clusters for injuries incurred while being literally blown out of a foxhole. He received three Campaign Stars as well as a Presidential Citation. Mr. Boose said, and I quote, the life ... 'The key to a happy life is a good woman.' Also, 'the key to a long life is to not overeat, keep moving, and eat eggs every day. Two is fine.' Would you join me in a moment of silence for the greatest generation?"

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to add Section 2.5 to Article IV of the Illinois Constitution as follows:

#### ARTICLE IV

#### THE LEGISLATURE

SECTION 2.5. TERM LIMITS

A person may not be elected to the office of State Senator or State Representative, or a combination of those offices, for terms totalling more than ten years. No person may be elected or appointed as a State Senator or State Representative if, upon completion of that term of office, he or she will have been a member of the General Assembly for more than ten years. Service before the second Wednesday in January of 2021 shall not be considered in the calculation of a person's service.

#### SCHEDULE

This Constitutional Amendment takes effect upon being declared adopted in accordance with Section 7 of the Illinois Constitutional Amendment Act. #### ARTICLE V

#### THE EXECUTIVE

SECTION 2. TERMS

These elected officers of the Executive Branch shall hold office for four years beginning on the second Monday of January after their election and, except in the case of the Lieutenant Governor, until their successors are qualified. They shall be elected at the general election in 1978 and every four years thereafter. A person may not be elected to any single Executive Branch office for more than two terms in each office. Service before the second Monday in January of 2023 shall not be considered in the calculation of a person's service.

This Constitutional Amendment takes effect upon being declared adopted in accordance with Section 7 of the Illinois Constitutional Amendment Act.
