When the gunman applied for a concealed carry license in March 2014, only then did the State Police revoke his FOID card and sent him a notice to surrender his firearm and submit a Firearm Deposition

the steps of the Lincoln Memorial, a group of black women working at the Langley Memorial Aeronautical Laboratory in Hampton, Virginia were helping America dominate aeronautics, space research, and computer technology, carving out a place for themselves as female mathematicians who were also black, black mathematicians, who were also female. Katherine Goble Johnson, Dorothy Vaughan, Mary Jackson, Christine Darden, who in a time when black women faced seemingly insurmountable obstacles, went to work as calculators at NASA. With pencils, paper, and slide rules they transformed airplane, rocket, and satellite designs and helped ensure a World War II victory. Despite the social and political climate at the height of Jim Crowe, these women rose up and became integral to the project that put the first man on the moon, from World War II to the Cold War, to the Civil Rights Movement, to the Space Race, these remarkable women's contributions to science led to some of NASA's greatest successes. Katherine Goble Johnson was a mathematician who exhibited such skills since childhood, a wonder child. She was the one who performed all of the math. Katherine Johnson went on to perform calculations for the Apollo II Mission to the moon and space shuttle. In 2016, NASA dedicated the Katherine G. Johnson Computation Building in honor of her groundbreaking work in space travel. She became the backbone of NASA in terms of her mathematical calculations for exact locations needed for space travel. Dorothy Vaughan became the first ever African American supervisor in NASA. Since she was a Fortran specialist, the best in electronics computing, she was known to be one of NASA's most brilliant minds. She fought to make sure that

women were paid fairly for their titles and their duties. Mary Jackson was a gifted child and a very talented engineer. She became NASA's first-ever female and African American aeronautical engineer. Her work focused on airflow that surrounds aircraft. And finally, Christine Darden, an American mathematician, a Congressional Gold Medal recipient, data analyst, and aeronautical engineer devoted much of her 40 year career in aerodynamics at NASA to researching supersonic flights and sonic booms. So, I am proud to honor and recognize these four admirable women as we celebrate Black History Month, February 2020. Thank you."
