Amends Public Acts 98-679, 98-680, and 98-681. Adds supplemental appropriations to various agencies for personal services and State contributions to Social Security. Effective immediately.

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 Section 5. "An Act making appropriations", Public Act 98-  
5 679, approved June 30, 2014, is amended by adding Section 7 to  
6 Article 1, by adding Section 7 to Article 5, by adding Section  
7 7 to Article 16, by adding Section 7 to Article 19, by adding  
8 Section 7 to Article 20, by adding Section 7 to Article 25, by  
9 adding Section 7 to Article 31, and by adding Section 7 to  
10 Article 35 as follows:

11 (P.A. 98-679, Article 1, Section 7 new)

12 Sec. 7. The sum of \$5,190, or so much thereof as may be  
13 necessary, is appropriated from the General Revenue Fund to the  
14 Department of Agriculture for Personal Services and State  
15 Contributions to Social Security; including prior year costs,  
16 at the approximate costs below:

18	<u>For State Contributions to Social Security .....</u>	<u>\$350</u>

9 Section 10. "An Act making appropriations", Public Act 98-  
10 680, approved June 30, 2014, is amended by adding Section 7 to  
11 Article 2, by adding Section 7 to Article 6, by adding Section  
12 7 to Article 8, by adding Section 7 to Article 9, and by adding  
13 Section 7 to Article 10 as follows:

14 (P.A. 98-680, Article 2, Section 7 new)

15 Sec. 7. The sum of \$27,110, or so much thereof as may be  
16 necessary, is appropriated from the General Revenue Fund to the  
17 Department of Children and Family Services for Personal  
18 Services and State Contributions to Social Security; including  
19 prior year costs, at the approximate costs below:

20	<u>For Personal Services .....</u>	<u>\$24,500</u>
21	<u>For State Contributions to Social Security .....</u>	<u>\$2,610</u>

1 (P.A. 98-680, Article 6, Section 7 new)

2 Sec. 7. The sum of \$30,010, or so much thereof as may be  
3 necessary, is appropriated from the General Revenue Fund to the  
4 Department of Human Rights for Personal Services and State  
5 Contributions to Social Security; including prior year costs,  
6 at the approximate costs below:

7 For Personal Services .....\$27,870  
8 For State Contributions to Social Security .....\$2,140

9 (P.A. 98-680, Article 8, Section 7 new)

10 Sec. 7. The sum of \$37,160, or so much thereof as may be  
11 necessary, is appropriated from the General Revenue Fund to the  
12 Department of Healthcare and Family Services for Personal  
13 Services and State Contributions to Social Security; including  
14 prior year costs, at the approximate costs below:

15 For Personal Services .....\$34,510  
16 For State Contributions to Social Security .....\$2,650

17 (P.A. 98-680, Article 9, Section 7 new)

18 Sec. 7. The sum of \$17,050,280, or so much thereof as may  
19 be necessary, is appropriated from the General Revenue Fund to  
20 the Department of Human Services for Personal Services and  
21 State Contributions to Social Security; including prior year  
22 costs, at the approximate costs below:

18 the Department of Corrections for Personal Services and State  
19 Contributions to Social Security; including prior year costs,  
20 at the approximate costs below:

22       For State Contributions to Social Security .....\$2,890,310

2 Sec. 7. The sum of \$3,380, or so much thereof as may be  
3 necessary, is appropriated from the General Revenue Fund to the  
4 Illinois Emergency Management Agency for Personal Services and  
5 State Contributions to Social Security; including prior year  
6 costs, at the approximate costs below:

8	<u>For State Contributions to Social Security .....</u>	<u>\$230</u>

9 (P.A. 98-681, Article 9, Section 7 new)

10 Sec. 7. The sum of \$3,108,290, or so much thereof as may  
11 be necessary, is appropriated from the General Revenue Fund to  
12 the Department of Juvenile Justice for Personal Services and  
13 State Contributions to Social Security; including prior year  
14 costs, at the approximate costs below:

16	<u>For State Contributions to Social Security .....</u>	<u>\$182,350</u>

17 (P.A. 98-681, Article 18, Section 7 new)

18 Sec. 7. The sum of \$19,920, or so much thereof as may be  
19 necessary, is appropriated from the General Revenue Fund to the  
20 Department of State Police for Personal Services and State  
21 Contributions to Social Security; including prior year costs,  
22 at the approximate costs below:



1	<u>For Personal Services .....</u>	<u>\$18,500</u>
2	<u>For State Contributions to Social Security .....</u>	<u>\$1,420</u>

3       Section 99. Effective date. This Act takes effect upon  
4 becoming law.
