SYNOPSIS AS INTRODUCED:

65 ILCS 5/11-6-9 new
70 ILCS 705/10d new

Amends the Illinois Municipal Code. Provides that, if authorized by the fire chief of the fire department, any regularly enrolled volunteer fire fighter may purchase 4 vehicle tires every 3 years through his or her fire department's or municipality's joint purchasing contract relating to the purchase of vehicle tires. Further provides that the firefighter shall cover the cost of the tires and any related taxes. Limits applicability. Amends the Fire Protection District Act making similar changes. Effective immediately.

A BILL FOR

1 AN ACT concerning local government.

2 **Be it enacted by the People of the State of Illinois,**
3 **represented in the General Assembly:**

4 Section 5. The Illinois Municipal Code is amended by adding
5 Section 11-6-9 as follows:

6 (65 ILCS 5/11-6-9 new)

7 Sec. 11-6-9. Purchase of tires under joint purchasing
8 authority.

9 (a) If authorized by the fire chief of the fire department,
10 any regularly enrolled volunteer firefighter may purchase 4
11 vehicle tires every 3 years through his or her fire
12 department's or municipality's contract to purchase vehicle
13 tires under Section 2 of the Governmental Joint Purchasing Act.
14 The authorization must be in writing and on the fire
15 department's letterhead, and must include the volunteer
16 firefighter's name, the license plate number of the vehicle for
17 the authorized purchase, and must reference the fire
18 department's or municipality's joint purchasing agreement. For
19 purposes of this Section only, "vehicle" has the meaning
20 provided in Section 1-146 of the Illinois Vehicle Code.

21 (b) The fire department or municipality shall alone be
22 responsible for documenting how many tires each volunteer
23 firefighter purchases during the specified periods under this

1 Section.

2 (c) The firefighter shall pay for any tires, and any
3 related taxes, purchased under this Section.

4 (d) Purchase of tires under this Section are not considered
5 tax exempt.

6 (e) This Section applies to contracts first solicited under
7 Section 4 of the Governmental Joint Purchasing Act on or after
8 the effective date of this amendatory Act of the 100th General
9 Assembly.

10 Section 10. The Fire Protection District Act is amended by
11 adding Section 10d as follows:

12 (70 ILCS 705/10d new)

13 Sec. 10d. Purchase of tires under joint purchasing
14 authority.

15 (a) If authorized by the fire chief of the fire protection
16 district, any regularly enrolled volunteer firefighter may
17 purchase 4 vehicle tires every 3 years through his or her fire
18 protection district's contract to purchase vehicle tires under
19 Section 2 of the Governmental Joint Purchasing Act. The
20 authorization must be in writing and on the fire protection
21 district's letterhead, and must include the volunteer
22 firefighter's name, the license plate number of the vehicle for
23 the authorized purchase, and must reference the fire protection
24 district's joint purchasing agreement. For purposes of this

1 Section only, "vehicle" has the meaning provided in Section
2 1-146 of the Illinois Vehicle Code.

3 (b) The fire protection district shall alone be responsible
4 for documenting how many tires each volunteer firefighter
5 purchases during the specified period under this Section.

6 (c) The firefighter shall pay for any tires, and any
7 related taxes, purchased under this Section.

8 (d) Purchase of tires under this Section are not considered
9 tax exempt.

10 (e) This Section applies to contracts first solicited under
11 Section 4 of the Governmental Joint Purchasing Act on or after
12 the effective date of this amendatory Act of the 100th General
13 Assembly.

14 Section 99. Effective date. This Act takes effect upon
15 becoming law.
