AN ACT concerning transportation.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

- Section 5. The Illinois Vehicle Code is amended by changing
 Sections 11-1414.1 and 12-815.2 as follows:

Sec. 11-1414.1. School transportation of students.

(a) Every student enrolled in grade 12 or below in any 8 9 entity listed in subsection (a) of Section 1-182 of this Code must be transported in a school bus or a vehicle described in 10 subdivision (1) or (2) of subsection (b) of Section 1-182 of 11 12 this Code for any curriculum-related school activity, except a student in any of grades 9 through 12 or a student in any of 13 14 grades K through 12 with an Individualized Education Plan (IEP) with a staff to student ratio of 1 to 5, and attending Acacia 15 Academy, Alexander Leigh, Marklund, Helping Hands Center, 16 17 Connections Organization, Soaring Eagle Academy, or New Horizon Academy may be transported in a multi-function school 18 19 activity bus (MFSAB) as defined in Section 1-148.3a-5 of this 20 for curriculum-related activity except Code any for 21 transportation on regular bus routes from home to school or 22 from school to home, subject to the following conditions:

(i) A MFSAB may not be used to transport students under

1 2 this Section unless the driver holds a valid school bus driver permit.

3 (ii) The use of a MFSAB under this Section is subject
4 to the requirements of Sections 6-106.11, 6-106.12,
5 12-707.01, 13-101, and 13-109 of this Code.

"Curriculum-related school activity" as used in this 6 7 subsection (a) includes transportation from home to school or 8 from school to home, tripper or shuttle service between school 9 attendance centers, transportation to a vocational or career 10 center or other trade-skill development site or a regional safe 11 school or other school-sponsored alternative learning program, 12 or a trip that is directly related to the regular curriculum of a student for which he or she earns credit. 13

(b) Every student enrolled in grade 12 or below in any 14 15 entity listed in subsection (a) of Section 1-182 of this Code 16 who is transported in a vehicle that is being operated by or 17 for a public or private primary or secondary school, including any primary or secondary school operated by a religious 18 institution, for an interscholastic, interscholastic-athletic, 19 20 or school-sponsored, noncurriculum-related activity that (i) 21 does not require student participation as part of the 22 educational services of the entity and (ii) is not associated 23 with the students' regular class-for-credit schedule shall transport students only in a school bus or vehicle described in 24 25 subsection (b) of Section 1-182 of this Code. This subsection 26 (b) does not apply to any second division vehicle used by an
