- (c) School guidance counselors, nurses, teachers and other school personnel who work with pupils may be trained to have a basic knowledge of matters relating to immunodeficiency syndrome (AIDS), including the nature of the disease, its causes and effects, the means of detecting it and preventing its transmission, and the availability of appropriate sources of counseling and referral, and any other information that may be appropriate considering the age and grade level of such pupils. The School Board shall supervise such training. The State Board of Education and the Department of Public Health shall jointly develop standards for such training.
- 13 (d) In this subsection (d):
- "Domestic violence" means abuse by a family or household 14 15 member, as "abuse" and "family or household members" are 16 defined in Section 103 of the Illinois Domestic Violence Act of 17 1986.
- "Sexual violence" means sexual assault, abuse, or stalking 18 19 of an adult or minor child proscribed in the Criminal Code of 20 1961 or the Criminal Code of 2012 in Sections 11-1.20, 11-1.30, 11-1.40, 11-1.50, 11-1.60, 12-7.3, 12-7.4, 12-7.5, 12-12, 2.1 12-13, 12-14, 12-14.1, 12-15, and 12-16, including sexual 22 23 violence committed by perpetrators who are strangers to the 24 victim and sexual violence committed by perpetrators who are 25 known or related by blood or marriage to the victim.
- 26 At least once every 2 years, an in-service training program

for school personnel who work with pupils, including, but not limited to, school and school district administrators, teachers, school guidance counselors, school social workers, school counselors, school psychologists, and school nurses, must be conducted by persons with expertise in domestic and sexual violence and the needs of expectant and parenting youth and shall include training concerning (i) communicating with and listening to youth victims of domestic or sexual violence and expectant and parenting youth, (ii) connecting youth victims of domestic or sexual violence and expectant and parenting youth to appropriate in-school services and other agencies, programs, and services as needed, and implementing the school district's policies, procedures, and with protocols regard to such youth, including confidentiality. At a minimum, school personnel must be trained to understand, provide information and referrals, and address issues pertaining to youth who are parents, expectant parents, or victims of domestic or sexual violence.

- (e) At least every 2 years, an in-service training program for school personnel who work with pupils must be conducted by persons with expertise in anaphylactic reactions and management.
- (f) At least once every 2 years, a school board shall 23 in-service training on 24 conduct educator 25 teacher-student conduct, and school employee-student conduct 26 for all personnel.
