A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, , or so much thereof
6 as may be necessary, are appropriated from the General Revenue
7 Fund to the Department of Military Affairs:

8 FOR OPERATIONS - STATEWIDE

9 Payable from General Revenue Fund:

1 Section 10. The sum of \$16,000,000, or so much thereof as
2 may be necessary, is appropriated from the Federal Support
3 Agreement Revolving Fund to the Department of Military Affairs
4 Facilities Division for expenses related to Army National Guard
5 Facilities operations and maintenance as provided for in the
6 Cooperative Funding Agreements, including costs in prior years.

7 Section 15. The sum of \$10,000, or so much thereof as may
8 be necessary, is appropriated from the General Revenue Fund to
9 the Department of Military Affairs Office of the Adjutant
10 General Division for expenses related to the care and
11 preservation of historic artifacts.

12 Section 20. The sum of \$1,000,000, or so much thereof as
13 may be necessary, is appropriated from the Military Affairs
14 Trust Fund to the Department of Military Affairs Office of the
15 Adjutant General Division to support youth and other programs,
16 provided such amounts shall not exceed funds to be made
17 available from public or private sources.

18 Section 25. The sum of \$5,000,000, or so much thereof as
19 may be necessary, is appropriated from the Illinois Military
20 Family Relief Fund to the Department of Military Affairs Office
21 of the Adjutant General Division for the issuance of grants to

1 persons or families of persons who are members of the Illinois
2 National Guard or Illinois residents who are members of the
3 armed forces of the United States and who have been called to
4 active duty as a result of the September 11, 2001 terrorist
5 attacks, including costs in prior years.

6 Section 30. The sum of \$800,000, or so much thereof as may
7 be necessary, is appropriated from the General Revenue Fund to
8 the Department of Military Affairs for deposit into the Federal
9 Support Agreement Revolving Fund.

10 Section 35. The sum of \$100,000, or so much thereof as may
11 be necessary, is appropriated from the State Military Justice
12 Fund to the Department of Military Affairs for expenses of
13 military justice as provided in the Illinois Code of Military
14 Justice.

15 Section 40. The sum of \$1,800,000, or so much thereof as
16 may be necessary, is appropriated from the General Revenue Fund
17 to the Department of Military Affairs for deposit into the
18 Illinois Military Family Relief Fund.

19 Section 45. The sum of \$80,000, or so much thereof as may
20 be necessary, is appropriated from the General Revenue Fund to
21 the Department of Military Affairs for deposit into the State

1 Military Justice Fund.

2 Section 99. Effective Date. This Act takes effect July 1,
3 2018. Notwithstanding anything in this Act to the contrary,
4 appropriations authorized in this Act shall be used for all
5 costs incurred prior to July 1, 2019.
