SYNOPSIS AS INTRODUCED:

30 ILCS 105/5.891 new 625 ILCS 5/3-699.14

Amends the Illinois Vehicle Code to allow for the issuance of decals for Universal special license plates by the Illinois Department of Human Resources. Provides fees for the issuance of the decals. Creates the Theresa Tracy Trot - Illinois CancerCare Foundation Fund as a special fund in the State treasury. Makes a corresponding change in the State Finance Act. Effective immediately.

AN ACT concerning transportation.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The State Finance Act is amended by adding
Section 5.891 as follows:

Sec. 5.891. The Theresa Tracy Trot - Illinois CancerCare
 Foundation Fund.

9 Section 10. The Illinois Vehicle Code is amended by
10 changing Section 3-699.14 as follows:

12 Sec. 3-699.14. Universal special license plates.

(a) In addition to any other special license plate, the 13 14 Secretary, upon receipt of all applicable fees and applications made in the form prescribed by the Secretary, may issue 15 16 Universal special license plates to residents of Illinois on 17 behalf of organizations that have been authorized by the General Assembly to issue decals for Universal special license 18 19 plates. Appropriate documentation, as determined by the 20 Secretary, shall accompany each application. Authorized organizations shall be designated by amendment to this Section. 21

When applying for a Universal special license plate the 1 2 applicant shall inform the Secretary of the name of the 3 authorized organization from which the applicant will obtain a decal to place on the plate. The Secretary shall make a record 4 5 of that organization and that organization shall remain affiliated with that plate until the plate is surrendered, 6 7 revoked, or otherwise cancelled. The authorized organization may charge a fee to offset the cost of producing and 8 9 distributing the decal, but that fee shall be retained by the 10 authorized organization and shall be separate and distinct from 11 any registration fees charged by the Secretary. No decal, 12 sticker, or other material may be affixed to a Universal 13 special license plate other than a decal authorized by the 14 General Assembly in this Section or a registration renewal 15 sticker. The special plates issued under this Section shall be 16 affixed only to passenger vehicles of the first division, 17 including motorcycles and autocycles, or motor vehicles of the second division weighing not more than 8,000 pounds. Plates 18 issued under this Section shall expire according to the 19 20 multi-year procedure under Section 3-414.1 of this Code.

(b) The design, color, and format of the Universal special license plate shall be wholly within the discretion of the Secretary. Universal special license plates are not required to designate "Land of Lincoln", as prescribed in subsection (b) of Section 3-412 of this Code. The design shall allow for the application of a decal to the plate. Organizations authorized

by the General Assembly to issue decals for Universal special 1 2 license plates shall comply with rules adopted by the Secretary 3 governing the requirements for and approval of Universal special license plate decals. The Secretary may, in his or her 4 5 discretion, allow Universal special license plates to be issued as vanity or personalized plates in accordance with Section 6 7 3-405.1 of this Code. The Secretary of State must make a version of the special registration plates authorized under 8 9 this Section in a form appropriate for motorcycles and 10 autocycles.

11 (c) When authorizing a Universal special license plate, the 12 General Assembly shall set forth whether an additional fee is to be charged for the plate and, if a fee is to be charged, the 13 amount of the fee and how the fee is to be distributed. When 14 15 necessary, the authorizing language shall create a special fund 16 in the State treasury into which fees may be deposited for an 17 authorized Universal special license plate. Additional fees may only be charged if the fee is to be paid over to a State 18 19 agency or to a charitable entity that is in compliance with the 20 registration and reporting requirements of the Charitable Trust Act and the Solicitation for Charity Act. Any charitable 21 22 entity receiving fees for the sale of Universal special license 23 plates shall annually provide the Secretary of State a letter of compliance issued by the Attorney General verifying that the 24 25 entity is in compliance with the Charitable Trust Act and the 26 Solicitation for Charity Act.

Upon original issuance and for each registration 1 (d) 2 renewal period, in addition to the appropriate registration 3 fee, if applicable, the Secretary shall collect any additional fees, if required, for issuance of Universal special license 4 5 plates. The fees shall be collected on behalf of the 6 organization designated by the applicant when applying for the 7 plate. All fees collected shall be transferred to the State 8 agency on whose behalf the fees were collected, or paid into 9 the special fund designated in the law authorizing the 10 organization to issue decals for Universal special license 11 plates. All money in the designated fund shall be distributed 12 by the Secretary subject to appropriation by the General 13 Assembly.

Universal special license plates with the original and renewal
fees and fee distribution as follows:
