Amends various acts relating to the governance of public universities in Illinois. Provides that if a university offers a competency-based learning program, it must notify a student if he or she becomes eligible for the program.

2 **Be it enacted by the People of the State of Illinois,**
3 **represented in the General Assembly:**

4 Section 5. The University of Illinois Act is amended by
5 adding Section 105 as follows:

6 (110 ILCS 305/105 new)

7 Sec. 105. Competency-based learning program; notice. If
8 the University offers a competency-based learning program, it
9 must notify a student if he or she becomes eligible for the
10 program.

11 Section 10. The Southern Illinois University Management
12 Act is amended by adding Section 90 as follows:

13 (110 ILCS 520/90 new)

14 Sec. 90. Competency-based learning program; notice. If the
15 University offers a competency-based learning program, it must
16 notify a student if he or she becomes eligible for the program.

17 Section 15. The Chicago State University Law is amended by
18 adding Section 5-200 as follows:

19 (110 ILCS 660/5-200 new)

1 Sec. 5-200. Competency-based learning program; notice. If
2 the University offers a competency-based learning program, it
3 must notify a student if he or she becomes eligible for the
4 program.

5 Section 20. The Eastern Illinois University Law is amended
6 by adding Section 10-200 as follows:

7 (110 ILCS 665/10-200 new)

8 Sec. 10-200. Competency-based learning program; notice. If
9 the University offers a competency-based learning program, it
10 must notify a student if he or she becomes eligible for the
11 program.

12 Section 25. The Governors State University Law is amended
13 by adding Section 15-200 as follows:

14 (110 ILCS 670/15-200 new)

15 Sec. 15-200. Competency-based learning program; notice. If
16 the University offers a competency-based learning program, it
17 must notify a student if he or she becomes eligible for the
18 program.

19 Section 30. The Illinois State University Law is amended by
20 adding Section 20-205 as follows:

1 (110 ILCS 675/20-205 new)

2 Sec. 20-205. Competency-based learning program; notice. If
3 the University offers a competency-based learning program, it
4 must notify a student if he or she becomes eligible for the
5 program.

6 Section 35. The Northeastern Illinois University Law is
7 amended by adding Section 25-200 as follows:

8 (110 ILCS 680/25-200 new)

9 Sec. 25-200. Competency-based learning program; notice. If
10 the University offers a competency-based learning program, it
11 must notify a student if he or she becomes eligible for the
12 program.

13 Section 40. The Northern Illinois University Law is amended
14 by adding Section 30-210 as follows:

15 (110 ILCS 685/30-210 new)

16 Sec. 30-210. Competency-based learning program; notice. If
17 the University offers a competency-based learning program, it
18 must notify a student if he or she becomes eligible for the
19 program.

20 Section 45. The Western Illinois University Law is amended
21 by adding Section 35-205 as follows:

1 (110 ILCS 690/35-205 new)

2 Sec. 35-205. Competency-based learning program; notice. If
3 the University offers a competency-based learning program, it
4 must notify a student if he or she becomes eligible for the
5 program.
