6 Section 2-5. 5 (3) Right to purchase the land occupied by the Pana Lake 6 Project if the City of Pana shall at any time determine to sell 7 such land and the improvements thereon.

8 Section 2-15. The State of Illinois paid \$100,000 toward 9 the Pana Lake Project in consideration for obtaining the 10 foregoing contractual interests pursuant to appropriation of 11 State funds for the purpose made in Section 4 of Senate Bill 12 662 by the 65th General Assembly, approved July 21, 1947.

Section 2-20. The State of Illinois shall not receive consideration for the termination of its contractual rights of the June 28, 1949 Agreement.

16 Section 2-25. The Director of the Department of Natural 17 Resources may execute a mutual termination with the City of 18 Pana terminating both parties' interests in the June 28, 1949 19 Agreement.

Section 4-10. The conveyances of real property authorized by Section 4-5 are subject to: (1) existing public utilities, existing public roads, and any and all reservations, easements, encumbrances, covenants, and restrictions of record; and (2) the express condition that if said real property ceases to be HB3222 Enrolled - 41 - LRB101 10504 LNS 55610 b used for public purposes, it shall revert to the State of Illinois, Medical District Commission.

Section 4-15. The President of the Illinois Medical 3 4 District Commission shall obtain a certified copy of the 5 portions of this Act containing the title, the enacting clause, 6 the effective date, the appropriate Section or Sections containing the land descriptions of the property to be 7 conveyed, and this Section within 60 days after its effective 8 date and shall record the certified document in the Recorder's 9 10 office in the county in which the land is located.

ARTICLE 99.

Section 99-99. Effective date. This Act takes effect upon becoming law.
