Amends various Acts relating to the governance of public universities in Illinois. Provides that, as a prerequisite to receiving an undergraduate degree, the governing board of each public university shall require that a student meet with a career adviser of the university at least once during his or her undergraduate education. Effective January 1, 2021.

1 AN ACT concerning education.

2 **Be it enacted by the People of the State of Illinois,**
3 **represented in the General Assembly:**

4 Section 5. The University of Illinois Act is amended by
5 adding Section 120 as follows:

6 (110 ILCS 305/120 new)

7 Sec. 120. Career adviser. As a prerequisite to receiving an
8 undergraduate degree, the Board of Trustees shall require that
9 a student meet with a career adviser of the University at least
10 once during his or her undergraduate education.

11 Section 10. The Southern Illinois University Management
12 Act is amended by adding Section 100 as follows:

13 (110 ILCS 520/100 new)

14 Sec. 100. Career adviser. As a prerequisite to receiving an
15 undergraduate degree, the Board shall require that a student
16 meet with a career adviser of the University at least once
17 during his or her undergraduate education.

18 Section 15. The Chicago State University Law is amended by
19 adding Section 5-210 as follows:

1 (110 ILCS 660/5-210 new)

2 Sec. 5-210. Career adviser. As a prerequisite to receiving
3 an undergraduate degree, the Board shall require that a student
4 meet with a career adviser of the University at least once
5 during his or her undergraduate education.

6 Section 20. The Eastern Illinois University Law is amended
7 by adding Section 10-210 as follows:

8 (110 ILCS 665/10-210 new)

9 Sec. 10-210. Career adviser. As a prerequisite to receiving
10 an undergraduate degree, the Board shall require that a student
11 meet with a career adviser of the University at least once
12 during his or her undergraduate education.

13 Section 25. The Governors State University Law is amended
14 by adding Section 15-210 as follows:

15 (110 ILCS 670/15-210 new)

16 Sec. 15-210. Career adviser. As a prerequisite to receiving
17 an undergraduate degree, the Board shall require that a student
18 meet with a career adviser of the University at least once
19 during his or her undergraduate education.

20 Section 30. The Illinois State University Law is amended by
21 adding Section 20-215 as follows:

1 (110 ILCS 675/20-215 new)

2 Sec. 20-215. Career adviser. As a prerequisite to receiving
3 an undergraduate degree, the Board shall require that a student
4 meet with a career adviser of the University at least once
5 during his or her undergraduate education.

6 Section 35. The Northeastern Illinois University Law is
7 amended by adding Section 25-210 as follows:

8 (110 ILCS 680/25-210 new)

9 Sec. 25-210. Career adviser. As a prerequisite to receiving
10 an undergraduate degree, the Board shall require that a student
11 meet with a career adviser of the University at least once
12 during his or her undergraduate education.

13 Section 40. The Northern Illinois University Law is amended
14 by adding Section 30-220 as follows:

15 (110 ILCS 685/30-220 new)

16 Sec. 30-220. Career adviser. As a prerequisite to receiving
17 an undergraduate degree, the Board shall require that a student
18 meet with a career adviser of the University at least once
19 during his or her undergraduate education.

20 Section 45. The Western Illinois University Law is amended

1 by adding Section 35-215 as follows:

2 (110 ILCS 690/35-215 new)

3 Sec. 35-215. Career adviser. As a prerequisite to receiving
4 an undergraduate degree, the Board shall require that a student
5 meet with a career adviser of the University at least once
6 during his or her undergraduate education.

7 Section 99. Effective date. This Act takes effect January
8 1, 2021.
