A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much thereof  
6 as may be necessary, respectively, for the objects and purposes  
7 hereinafter named, are appropriated to meet the ordinary and  
8 contingent expenses of the Illinois Criminal Justice  
9 Information Authority:

10 OPERATIONS

11 Payable from General Revenue Fund:

1 Justice Information Authority from the General Revenue Fund for  
2 administrative costs, awards and grants for Adult Redeploy and  
3 Diversion Programs.

4 Section 35. The amount of \$1,200,000, or so much thereof  
5 as may be necessary, is appropriated from the General Revenue  
6 Fund to the Illinois Criminal Justice Information Authority for  
7 the purpose of awarding grants, contracts, administrative  
8 expenses and all related costs for the Safe From the Start  
9 Program.

10 Section 40. The amount of \$7,541,300, or so much thereof  
11 as may be necessary, is appropriated from the General Revenue  
12 Fund to the Illinois Criminal Justice Information Authority for  
13 administrative costs, awards and grants for Community-Based  
14 Violence Prevention Programs.

15 Section 45. The amount of \$6,094,300, or so much thereof  
16 as may be necessary, is appropriated from the General Revenue  
17 Fund to the Illinois Criminal Justice Information Authority for  
18 grants and administrative expenses related to Metropolitan  
19 Family Services' support of street intervention programming.

20 Section 50. The amount of \$5,000,000, or so much thereof  
21 as may be necessary, is appropriated from the General Revenue

1 Fund to the Illinois Criminal Justice Information Authority for  
2 administrative costs and grants related to the support of  
3 violence prevention and street intervention programming in  
4 municipalities with a population of 1,000,000 or greater.

5 Section 55. The amount of \$4,000,000, or so much thereof  
6 as may be necessary, is appropriated from the General Revenue  
7 Fund to the Illinois Criminal Justice Information Authority for  
8 grants and administrative expenses related to the support of  
9 violence prevention and street intervention programming in  
10 DuPage, Kane, Lake, McHenry, Will and Cook counties for  
11 municipalities with a population less than one million.

12 Section 60. The amount of \$3,000,000, or so much thereof  
13 as may be necessary, is appropriated from the General Revenue  
14 Fund to the Illinois Criminal Justice Information Authority for  
15 grants and administrative expenses related to the support of  
16 violence prevention and street intervention programming  
17 statewide excluding DuPage, Kane, Lake, McHenry, Will and Cook  
18 counties.

19 Section 65. The amount of \$3,361,700, or so much thereof  
20 as may be necessary, is appropriated from the General Revenue  
21 Fund to the Illinois Criminal Justice Information Authority for  
22 grants and administrative expenses related to trauma centers.

12 Section 10. The amount of \$1,000,000, or so much thereof  
 13 as may be necessary, is appropriated from the ICJIA Violence  
 14 Prevention Special Projects Fund to the Illinois Criminal  
 15 Justice Information Authority for administrative costs, awards  
 16 and grants for Adult Redeploy and Diversion Programs.

17 Section 15. The amount of \$500,000, or so much thereof as  
 18 may be necessary, is appropriated from the Criminal Justice  
 19 Information Projects Fund to the Illinois Criminal Justice  
 20 Information Authority for distribution to fund Department of  
 21 State Police drug task forces and Metropolitan Enforcement  
 22 Groups.

1 Section 20. The amount of \$2,500,000, or so much thereof  
 2 as may be necessary, is appropriated from the Criminal Justice  
 3 Information Projects Fund to the Illinois Criminal Justice  
 4 Information Authority for distribution of revenue pursuant to  
 5 Section 21.10 of the Illinois Lottery Law.

6 Section 25. The amount of \$35,000,000, or so much thereof  
 7 as may be necessary, is appropriated from the Criminal Justice  
 8 Information Projects Fund to the Illinois Criminal Justice  
 9 Information Authority for administrative costs, awards and  
 10 grants associated with the Restore, Reinvest, and Renew  
 11 Program.

12 Section 30. The following named amounts, or so much thereof  
 13 as may be necessary, are appropriated to the Illinois Criminal  
 14 Justice Information Authority for awards and grants and other  
 15 monies received from federal agencies, from other units of  
 16 government, and from private/not-for-profit organizations for  
 17 activities undertaken in support of investigating issues in  
 18 criminal justice and for undertaking other criminal justice  
 19 information projects:

22	Payable from the Criminal Justice	
23	Information Projects Fund .....	<u>1,000,000</u>

2 Section 35. The following named amounts, or so much thereof  
3 as may be necessary, are appropriated to the Illinois Criminal  
4 Justice Information Authority for activities undertaken in  
5 support of federal assistance programs administered by units  
6 of state and local government and non-profit organizations:

7 Payable from the Criminal Justice

8 Trust Fund .....7,000,000

9 Section 40. The amount of \$3,000,000, or so much thereof  
10 as may be necessary, is appropriated from the Criminal Justice  
11 Trust Fund to the Illinois Criminal Justice Information  
12 Authority for its ordinary and contingent expenses.

13 Section 45. The amount of \$140,000,000, or so much thereof  
14 as may be necessary, is appropriated from the Criminal Justice  
15 Trust Fund to the Illinois Criminal Justice Information  
16 Authority for awards and grants to local units of government,  
17 state agencies and non-profit organizations.

18 Section 50. The amount of \$7,800, or so much thereof as  
19 may be necessary, is appropriated from the Illinois State Crime  
20 Stoppers Association Fund to the Illinois Criminal Justice  
21 Information Authority for grants to enhance and develop Crime

1 Stoppers programs in Illinois.

2 Section 55. The following named amounts, or so much thereof  
3 as may be necessary, respectively, for the objects and purposes  
4 hereinafter named, are appropriated to the Illinois Criminal  
5 Justice Information Authority for the training of law  
6 enforcement personnel and services for families of victims of  
7 homicide or murder:

8 Payable from the Death Penalty Abolition Fund:

18 Section 60. The amount of \$150,000, or so much thereof as  
19 may be necessary, is appropriated from the Prescription Pill  
20 and Drug Disposal Fund to the Illinois Criminal Justice  
21 Information Authority for the purpose of collection,  
22 transportation, and incineration of pharmaceuticals by local  
23 law enforcement agencies.

1           Section 65. The amount of \$290,000, or so much thereof as  
2    may be necessary, is appropriated from the Cannabis Regulation  
3    Fund to the Illinois Criminal Justice Information Authority for  
4    operational expenses associated with the Cannabis Regulation  
5    and Tax Act.
