1 AN ACT concerning appropriations.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 ARTICLE 1

Section 5. The sum of \$3,500,000, or so much thereof as may be necessary, is appropriated to the Illinois Student Assistance Commission from the General Revenue Fund to meet its operational expenses for the fiscal year ending June 30, 2020.

9 Section 10. The sum of \$0, or so much thereof as may be 10 necessary, is appropriated to the Illinois Student Assistance 11 Commission from the General Revenue Fund for costs associated 12 with marketing for the College Illinois! Prepaid Tuition 13 Program.

1 Section 20. The sum of \$451,341,900, or so much thereof 2 as may be necessary, is appropriated to the Illinois Student Assistance Commission from the General Revenue Fund for grant 3 awards to students eligible for the Monetary Award Program, as 4 provided by law, and for agency administrative and operational 5 6 costs not to exceed 2 percent of the total appropriation in this Section. 7

Section 25. The sum of \$25,000,000, or so much thereof as may be necessary, is appropriated to the Illinois Student Assistance Commission from the General Revenue Fund for payments to eliqible public universities for grants associated with costs related to the first cohort of students pursuant to the AIM HIGH grant pilot program.

Section 30. The sum of \$10,000,000, or so much thereof as may be necessary, is appropriated to the Illinois Student Assistance Commission from the General Revenue Fund for payments to eligible public universities for grants associated with costs related to the second cohort of students pursuant to the AIM HIGH grant pilot program.

Section 35. The sum of \$26,400, or so much thereof as may be necessary, is appropriated from the Education Assistance Fund to the Illinois Student Assistance Commission for costs

- 2 Incentive Trust Fund to the Illinois Student Assistance
- 3 Commission for the John R. Justice Student Loan Repayment
- 4 Program.
- 5 ARTICLE 99
- 6 Section 99. Effective Date. This Act takes effect July 1,
- 7 2019.
