Makes appropriations for the ordinary and contingent expenses of the Court of Claims for the fiscal year beginning July 1, 2019. Effective July 1, 2019.

AN ACT concerning appropriations.

Be it enacted by the People of the State of Illinois, represented 2 in the General Assembly: 3

Section 5. The sum of \$1,541,100, or so much thereof as may 4 be necessary, is appropriated from the General Revenue Fund to 5 the Court of Claims for its ordinary and contingent expenses. 6

7 Section 10. The amount of \$450,000, or so much thereof as may be necessary, is appropriated from the Court of Claims 8 Administration and Grant Fund to the Court of Claims for 9 10 administrative expenses under the Crime Victims Compensation 11 Act.

12 Section 15. The following named amount, or so much thereof 13 as may be necessary, is appropriated to the Court of Claims for 14 payment of claims as follows:

For claims under the Crime Victims 15

19 Section 20. The amount of \$1,000,000, or so much thereof 20 as may be necessary, is appropriated from the General Revenue
