SENATE RESOLUTION

2 WHEREAS, The members of the Illinois Senate are saddened to 3 learn of the death of Maude Victoria Christie Moore, who passed 4 away on August 30, 2019; and

WHEREAS, Maude Moore was born in Salerno, Florida to Lucinda Thompson Christie and James A. Christie Sr. on February 24, 1922, shortly after they emigrated from the Bahamas; she was affectionately known as "Gracie" or "Sis"; at the age of nine, her maternal grandparents, with whom she had been living, returned to the Bahamas, and she stayed in Florida with her uncle; she was an excellent student, and by the time she graduated high school, she knew that she wanted to take care of people by becoming a nurse; and

WHEREAS, Maude Moore spent a year in New York with family, before heading to Chicago to attend the Michael Reese Hospital School of Nursing; she married Everett E. Moore; and

WHEREAS, Maude Moore converted from the Episcopalian faith of her childhood to the Catholic faith, and the family joined Holy Angels Catholic Church, where her children attended school; when her youngest child started second grade, she went to work for the City of Chicago, where she was employed for over 20 years at what was then the Department of Human
