SYNOPSIS AS INTRODUCED:

New Act

Creates the Low-Wage Employer Cost Recoupment Act. Directs the Department of Labor to impose a surcharge upon employers that pay employees wages that are less than the amount that would disqualify a single person from being eligible for federal Supplemental Nutrition Assistance Program benefits. Imposes a surcharge in an amount equal to the annual value of the amount of federal Supplemental Nutrition Assistance Program benefits for which a single person would be eligible multiplied by the number of employees whose wages do not disqualify a person from eligibility for federal Supplemental Nutrition Assistance Program benefits. Effective immediately.

FISCAL NOTE ACT MAY APPLY

1 AN ACT concerning employment.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- 4 Section 1. Short title. This Act may be cited as the
- 5 Low-Wage Employer Cost Recoupment Act.
- 6 Section 5. Definitions. In this Act:
- 7 "Department" means the Department of Labor.
- 8 "Director" means the Director of Labor.
- 9 "Employee" means any individual employed or permitted to
- work by an employer.
- "Employer" has the meaning ascribed to that term in the
- 12 Minimum Wage Law.
- "Wage" means compensation due to an employee by reason of
- 14 his or her employment.
- 15 Section 10. Low-wage employer surcharge.
- 16 (a) An employer that employs any employee (1) who was
- 17 listed on the employer's payroll for at least 90 calendar days
- 18 prior to the completion of the most recent calendar quarter,
- 19 beginning with the first calendar quarter of 2022 and (2)
- 20 whose wages paid by the employer during the quarter were less
- 21 than the amount that would disqualify a single person from
- 22 being eligible for federal Supplemental Nutrition Assistance

- 1 Program benefits shall pay a surcharge to the Department of
- 2 Labor.
- 3 (b) The Department shall determine the number of the
- 4 employer's employees whose wages are less than the amount that
- 5 would disqualify a single person from being eligible for
- 6 federal Supplemental Nutrition Assistance Program benefits.
- 7 The Director shall then impose a surcharge in the amount of the
- 8 annual value of the Supplemental Nutrition Assistance Program
- 9 benefits for which a single person would be eligible
- 10 multiplied by the number of those employees.
- 11 (c) The Department shall notify the employer of the amount
- of the surcharge no later than January 31, 2023 and each
- 13 January 31 thereafter.
- 14 Section 15. Payment of surcharge. An employer that has
- been notified of the imposition of a surcharge under Section
- 16 10 shall pay the surcharge to the Department in 10 equal
- 17 monthly installments due on the first day of each month
- beginning on March 1 of each year.
- 19 Section 20. Rulemaking authority. The Department may adopt
- 20 rules necessary to implement the provisions of this Act.
- 21 Section 99. Effective date. This Act takes effect upon
- 22 becoming law.
