SYNOPSIS AS INTRODUCED:

410 ILCS 705/5-17 new

Amends the Cannabis Regulation and Tax Act. Creates the Illinois Cannabis Control Commission, consisting of 7 members and an Executive Director to be appointed by the Governor. Provides that, notwithstanding any other provision of law, all authority granted to the Department of Financial and Professional Regulation and the Department of Agriculture under specified provisions of the Act is granted and shall be transferred to the Illinois Cannabis Control Commission. Requires the Commission to administer and enforce provisions of the Act relating to the oversight and registration of cultivation centers, craft growers, infuser organizations, transporting organizations, or dispensing organizations or their principal officers, agents-in-charge, or agents.

2 **Be it enacted by the People of the State of Illinois,**
3 **represented in the General Assembly:**

4 Section 5. The Cannabis Regulation and Tax Act is amended
5 by adding Section 5-17 as follows:

6 (410 ILCS 705/5-17 new)

7 Sec. 5-17. Cannabis Control Commission.

8 (a) There is hereby created the Illinois Cannabis Control
9 Commission, consisting of 7 members to be appointed by the
10 Governor with the advice and consent of the Senate, no more
11 than 4 of whom shall be members of the same political party.
12 The Executive Director of the Illinois Cannabis Control
13 Commission shall be appointed by the Governor with the advice
14 and consent of the Senate.

15 (b) Notwithstanding any other provision of law, all
16 authority granted to the Department of Financial and
17 Professional Regulation and the Department of Agriculture
18 provided under Sections 5-10 and 5-15 is granted and shall be
19 transferred to the Illinois Cannabis Control Commission.

20 (c) Notwithstanding any other provision of law, the
21 Illinois Cannabis Control Commission shall administer and
22 enforce the provisions of this Act relating to the oversight
23 and registration of cultivation centers, craft growers,

1 infuser organizations, transporting organizations, or their
2 agents, including the issuance of identification cards and
3 establishing limits on potency or serving size for cannabis or
4 cannabis products. The Illinois Cannabis Control Commission
5 may suspend or revoke the license of, impose other penalties
6 upon, or otherwise discipline, cultivation centers, craft
7 growers, infuser organizations, or transporting organizations
8 or their principal officers, agents-in-charge, or agents for
9 violations of this Act or any rules adopted under this Act.

10 (d) Notwithstanding any other provision of law, the
11 Illinois Cannabis Control Commission shall administer and
12 enforce the provisions of this Act relating to the oversight
13 and registration of dispensing organizations or dispensing
14 organization agents, including the issuance of identification
15 cards for dispensing organization agents. The Illinois
16 Cannabis Control Commission may suspend or revoke the license
17 of, impose other penalties upon, or otherwise discipline
18 dispensing organizations or a dispensing organization's
19 principal officers, agents-in-charge, or agents for violations
20 of this Act or any rules adopted under this Act.
