2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

4 Section 5. The Illinois Vehicle Code is amended by 5 changing Section 11-907 and by adding Section 11-907.2 as 6 follows:

7 (625 ILCS 5/11-907) (from Ch. 95 1/2, par. 11-907)

8 Sec. 11-907. Operation of vehicles and streetcars on 9 approach of authorized emergency vehicles.

10 (a) Upon the immediate approach of an authorized emergency 11 vehicle making use of audible and visual signals meeting the 12 requirements of this Code or a police vehicle properly and 13 lawfully making use of an audible or visual signal:

14 (1) the driver of every other vehicle shall yield the right-of-way and shall immediately drive to a position 15 16 parallel to, and as close as possible to, the right-hand edge or curb of the highway clear of any intersection and 17 shall, if necessary to permit the safe passage of the 18 19 emergency vehicle, stop and remain in such position until authorized emergency vehicle has passed, unless 20 the 21 otherwise directed by a police officer; and

(2) the operator of every streetcar shall immediatelystop such car clear of any intersection and keep it in such

1 2 position until the authorized emergency vehicle has passed, unless otherwise directed by a police officer.

(b) This Section shall not operate to relieve the driver of an authorized emergency vehicle from the duty to drive with due regard for the safety of all persons using the highway.

6 (c) Upon approaching a stationary authorized emergency 7 vehicle, when the authorized emergency vehicle is giving a 8 signal by displaying alternately flashing red, red and white, 9 blue, or red and blue lights or amber or yellow warning lights, 10 a person who drives an approaching vehicle shall:

11 (1)proceeding with due caution, yield the 12 right-of-way by making a lane change into a lane not 13 adjacent to that of the authorized emergency vehicle, if possible with due regard to safety and traffic conditions, 14 15 if on a highway having at least 4 lanes with not less than 16 2 lanes proceeding in the same direction as the 17 approaching vehicle; or

18 (2) if changing lanes would be impossible or unsafe, 19 proceeding with due caution, reduce the speed of the 20 vehicle, maintaining a safe speed for road conditions and 21 leaving a safe distance until safely past the stationary 22 <u>emergency</u> vehicles.

23 <u>The visual signal specified under this subsection (c)</u> 24 given by an authorized emergency vehicle is an indication to 25 <u>drivers of approaching vehicles that a hazardous condition is</u> 26 <u>present when circumstances are not immediately clear. of vehicles approaching a stationary emergency vehicle in any 1 2 lane shall heed the warning of the signal, reduce the speed of 3 the vehicle, proceed with due caution, maintain a safe speed for road conditions, be prepared to stop, and leave a safe 4 5 distance until safely passed the stationary emergency vehicle. As used in this subsection (c), "authorized emergency 6 7 vehicle" includes any vehicle authorized by law to be equipped 8 with oscillating, rotating, or flashing lights under Section 9 12-215 of this Code, while the owner or operator of the vehicle

10 is engaged in his or her official duties.

(d) A person who violates subsection (c) of this Section 11 12 commits a business offense punishable by a fine of not less than \$250 or more than \$10,000 for a first violation, and a 13 fine of not less than \$750 or more than \$10,000 for a second or 14 15 subsequent violation. It is a factor in aggravation if the 16 person committed the offense while in violation of Section 11-501, 12-610.1, or 12<u>-610.2</u> of this Code. Imposition of the 17 penalties authorized by this subsection (d) for a violation of 18 subsection (c) of this Section that results in the death of 19 another person does not preclude imposition of appropriate 20 additional civil or criminal penalties. A person who violates 21 22 subsection (c) and the violation results in damage to another 23 vehicle commits a Class A misdemeanor. A person who violates subsection (c) and the violation results in the injury or 24 25 death of another person commits a Class 4 felony.

(e) If a violation of subsection (c) of this Section

1 results in damage to the property of another person, in 2 addition to any other penalty imposed, the person's driving 3 privileges shall be suspended for a fixed period of not less 4 than 90 days and not more than one year.

5 (f) If a violation of subsection (c) of this Section 6 results in injury to another person, in addition to any other 7 penalty imposed, the person's driving privileges shall be 8 suspended for a fixed period of not less than 180 days and not 9 more than 2 years.

10 (g) If a violation of subsection (c) of this Section 11 results in the death of another person, in addition to any 12 other penalty imposed, the person's driving privileges shall 13 be suspended for 2 years.

(h) The Secretary of State shall, upon receiving a record
of a judgment entered against a person under subsection (c) of
this Section:

17 (1) suspend the person's driving privileges for the18 mandatory period; or

19 (2) extend the period of an existing suspension by the20 appropriate mandatory period.

(i) The Scott's Law Fund shall be a special fund in the State treasury. Subject to appropriation by the General Assembly and approval by the Director, the Director of the State Police shall use all moneys in the Scott's Law Fund in the Department's discretion to fund the production of materials to educate drivers on approaching stationary HB3656 Engrossed - 5 - LRB102 13852 RJF 19203 b

authorized emergency vehicles, to hire off-duty Department of State Police for enforcement of this Section, and for other law enforcement purposes the Director deems necessary in these efforts.

5 (j) For violations of this Section issued by a county or 6 municipal police officer, the assessment shall be deposited 7 into the county's or municipality's Transportation Safety 8 Highway Hire-back Fund. The county shall use the moneys in its 9 Transportation Safety Highway Hire-back Fund to hire off-duty 10 county police officers to monitor construction or maintenance 11 zones in that county on highways other than interstate 12 highways. The county, in its discretion, may also use a 13 portion of the moneys in its Transportation Safety Highway 14 Hire-back Fund to purchase equipment for county law 15 enforcement and fund the production of materials to educate 16 drivers on construction zone safe driving habits and 17 approaching stationary authorized emergency vehicles.
