

102ND GENERAL ASSEMBLY State of Illinois 2021 and 2022 HB4251

SYNOPSIS AS INTRODUCED:

60 ILCS 1/85-30 60 ILCS 1/205-105

Amends the Township Code. Provides that any purchase by a township for services, materials, equipment, or supplies in excess of \$30,000 (rather than \$20,000) shall be contracted in specified ways. Provides that contracts for construction work whose estimated cost will exceed \$30,000 (rather than \$20,000) for township waterworks and sewerage systems shall be let to the lowest responsible bidder. Effective immediately.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Township Code is amended by changing Sections 85-30 and 205-105 as follows:

- Sec. 85-30. Purchases; bids. Any purchase by a township for services, materials, equipment, or supplies in excess of \$30,000 \$20,000 (other than professional services) shall be contracted for in one of the following ways:
 - (1) By a contract let to the lowest responsible bidder after advertising for bids at least once (i) in a newspaper published within the township, or (ii) if no newspaper is published within the township, then in one published within the county, or (iii) if no newspaper is published within the county, then in a newspaper having general circulation within the township.
- 18 (2) By a contract let without advertising for bids in 19 the case of an emergency if authorized by the township 20 board.
- 21 This Section does not apply to contracts by a township 22 with the federal government.

- 3 (a) All contracts for construction work whose estimated 4 cost will exceed \$30,000 $\frac{$20,000}{}$ shall be let to the lowest 5 responsible bidder after publication of notice for bids. Notice for bids shall be published once in a newspaper 6 7 published and having general circulation in the township, if there is one. If there is no such newspaper, notice for bids 8 9 shall be published in a newspaper published and having general 10 circulation in the county. Notice for bids shall be published 11 at least 10 days before the date set for receiving bids. Bids

shall be opened and publicly read, and an award shall be made

- 15 (b) This Section shall not apply to engineering, legal, or 16 other professional services, but it shall apply to the 17 purchase of equipment unless the township board, by a resolution adopted by a three-fourths vote, determines that it 18 19 is for the best interests of the township that advertising for 20 bids for the equipment be dispensed with.
