#### SYNOPSIS AS INTRODUCED:

Amends the Illinois Act on the Aging. In provisions concerning the Council on Aging, provides that at least 7 citizen members shall represent underrepresented communities, including, but no limited to: one member who is a lesbian, gay, bisexual, or queer individual; one member who is a transgender or gender-expansive individual; one member who is an African-American or Black individual; and one member who is an Asian-American or Pacific Islander individual. Creates the Illinois Commission on LGBTQ Aging to investigate, analyze, and study the health, housing, financial, psychosocial, home-and-community-based services, assisted living, and long-term care needs of LGBTQ older adults and their caregivers. Requires the Commission to make recommendations to improve access to benefits, services, and supports for LGBTQ older adults and their caregivers. Requires the Commission to: examine the impact of State and local laws, policies, and regulations on LGBTQ older adults and make recommendations to ensure equitable access, treatment, care and benefits, and overall quality of life; and examine strategies to increase provider awareness of the needs of LGBTQ older adults and their caregivers and to improve the competence of and access to treatment, services, and ongoing care, including preventive care; and carry out other duties. Contains provisions concerning: members appointed to the Commission; Commission meetings and reports; an LGBTQ Older Adult Advocate to advocate for LGBTQ older adults and older adults living with HIV who experience barriers to accessing and utilizing services; an LGBTQ Older Adult Curriculum and Training Program; and other matters. ## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 Section 5. The Illinois Act on the Aging is amended by 5 changing Sections 3, 7.01, and 7.09 and by adding Sections 6 3.12, 3.13, 8.10, 8.11, and 8.12 as follows:

4	investigate, analyze, and study the health, housing,
5	financial, psychosocial, home-and-community-based services,

7	adults and their caregivers. The Commission shall make
8	recommendations to improve access to benefits, services, and
9	supports for LGBTQ older adults and their caregivers. The
10	Commission, in formulating its recommendations, shall take
11	into account the best policies and practices in other states
12	and jurisdictions. Specifically, the Commission shall:
13	(1) Examine the impact of State and local laws,
14	policies, and regulations on LGBTQ older adults and make
15	recommendations to ensure equitable access, treatment,
16	care and benefits, and overall quality of life.
17	(2) Examine best practices for increasing access,
18	reducing isolation, preventing abuse and exploitation,
19	promoting independence and self-determination,
20	strengthening caregiving, eliminating disparities, and
21	improving overall quality of life for LGBTQ older adults.

23	assigned at birth, socioeconomic status, disability,
24	sexual orientation, gender identity, and other

7	one representative to serve as an ex officio member of the
8	Commission: the Department, the Department of Public
9	Health, the Department of Human Services, the Department

11	Veterans' Affairs.
12	(3) Appointing authorities shall ensure, to the
13	maximum extent practicable, that the Commission is diverse
14	with respect to race, ethnicity, age, sexual orientation,
15	gender identity, gender expression, and geography.
16	(4) Members of the Commission shall serve until this
17	Section is repealed. Members shall continue to serve until
18	their successors are appointed. Any vacancy shall be
19	filled by the appointing authority. Any vacancy occurring
20	other than by the dissolution of the Commission shall be
21	filled for the balance of the unexpired term. Members of
22	the Commission shall serve without compensation but shall
23	be reimbursed for expenses necessarily incurred in the
24	performance of their duties.
25	(c) Commission organization. The Commission shall provide
26	for its organization and procedure, including selection of the

1 chairperson and vice-chairperson. A majority of the Commission 2 shall constitute a quorum for the transaction of business. 3 Administrative and other support for the Commission shall be provided by the Department. Any State agency under the 4 5 jurisdiction of the Governor shall provide testimony and 6 information as directed by the Commission. 7 (d) Meetings and reports. The Commission shall: 8 (1) Hold at least one public meeting per quarter. 9 Public meetings may be virtually conducted. 10 (2) No later than March 30, 2023, submit a First 11 Report to the Illinois General Assembly that contains

12 <u>findings and recommendations, including any recommended</u> 13 <u>legislation. The First Report shall be made available to</u> 14 <u>the public on the Department's publicly accessible</u> 15 <u>website.</u>

16 <u>(3) No later than March 30, 2025, submit a Second</u>
17 <u>Report in the same manner as the First Report, containing</u>
18 <u>updates to the findings and recommendations contained in</u>
19 <u>the First Report. The Second Report shall be made</u>

18	(a) All providers of services who contract with or receive
19	funding from the Department shall complete a curriculum and
20	training program on the prevention and elimination of
21	discrimination based on sexual orientation, gender identity,
22	and gender expression and on providing affirming care and
23	improving access to services for LGBTQ older adults, older
24	adults living with HIV, and their caregivers. The curriculum
25	and training program must be completed by all employees of

1 <u>each provider as well as the employees of the provider's</u> 2 <u>subgrantees and vendors. Providers shall complete training in</u> 3 <u>accordance with the Department's established training</u> 4 <u>requirements. Providers must maintain records of when each</u> 5 <u>employee completes the curriculum and training program. Such</u> 6 <u>proof of completion shall be made available to the Department</u> 7 upon its request.

8 (b) The Department may develop the curriculum and training 9 program or may contract with organizations or individuals to 10 provide their curriculum and training program. Such 11 organizations or individuals must affirm LGBTQ older adults 12 and older adults living with HIV and have recognized expertise in identifying and addressing the legal and social challenges 13 14 faced by LGBTQ older adults and older adults living with HIV. If the Department develops its own curriculum and training 15 program, the Department shall collaborate on developing the 16 17 program with individuals and organizations that affirm LGBTQ older adults and older adults living with HIV and have 18 19 recognized expertise in identifying and addressing the legal 20 and social challenges faced by LGBTQ older adults and older adults living with HIV. At a minimum, the curriculum and 21 22 training program required by this Section must address the 23 following:
