Amend House Bill 4715, AS AMENDED, with reference to page and line numbers of House Amendment No. 3 1, on page 3, by replacing lines 2 through 4 with the 4 5 following: "(1) The practice of structural engineering as defined 6 7 in the Structural Engineering Practice Act of 1989, the 8 practice of professional engineering as defined in the Professional Engineering Practice Act of 1989, or the 9 practice of land surveying as defined in the Professional 10 11 Land Surveyor Act of 1989. 12 (2) Services that constitute the practice of architecture as defined in the Illinois Architecture 13 Practice Act of 1989, except as provided in this Act."; 14 15 and 16 on page 3, line 5, by replacing "(2)" with "(3)"; and

"(h) Nothing in this Act shall <u>authorize registered</u>

- services that they are prohibited from performing, or any
- 13 practice: (i) that is restricted in the Professional
- 14 Engineering Practice Act of 1989, the Professional Land
- 15 Surveyor Act of 1989, of the Structural Engineering Practice
- 16 Act of 1989; (ii) that is restricted in the Illinois
- 17 Architecture Practice Act of 1989, except as provided in this
- 18 Act; or (iii) that they are not authorized to perform under the
- 19 Environmental Barriers Act, except as provided in this Act.

- 1 Nothing in this Act shall authorize registered interior
- 2 designers to perform services, including life safety services
- 3 that they are prohibited from performing, or any practice (i)
- 4 that is restricted in the Illinois Architecture Practice Act
- 5 of 1989, the Professional Engineering Practice Act of 1989, or
- 6 the Structural Engineering Practice Act of 1989, or (ii) that
- 7 they are not authorized to perform under the Environmental
- 8 Barriers Act."; and

- on page 9, lines 17 through 18, by deleting ", or professional
