A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much thereof
6 as may be necessary, respectively, for the objects and purposes
7 hereinafter named, are appropriated to meet the ordinary and
8 contingent expenses of the Illinois Criminal Justice
9 Information Authority:

1 as may be necessary, is appropriated from the General Revenue
2 Fund to the Illinois Criminal Justice Information Authority for
3 the purpose of awarding grants, contracts, administrative
4 expenses and all related costs for the Safe From the Start
5 Program.

6 Section 35. The amount of \$11,885,600, or so much thereof
7 as may be necessary, is appropriated from the General Revenue
8 Fund to the Illinois Criminal Justice Information Authority for
9 administrative costs, awards and grants for Community-Based
10 Violence Prevention Programs.

11 Section 40. The amount of \$6,094,300, or so much thereof
12 as may be necessary, is appropriated from the General Revenue
13 Fund to the Illinois Criminal Justice Information Authority for
14 grants and administrative expenses related to Metropolitan
15 Family Services' support of street intervention programming.

16 Section 45. The amount of \$1,000,000, or so much thereof
17 as may be necessary, is appropriated from the General Revenue
18 Fund to the Illinois Criminal Justice Information Authority for
19 a grant to the Safer Foundation for violence prevention
20 services and any associated administrative expenses.

21 Section 50. The amount of \$1,000,000, or so much thereof

1 as may be necessary, is appropriated from the General Revenue
2 Fund to the Illinois Criminal Justice Information Authority for
3 grants to local law enforcement agencies, other first
4 responders, and co-responders for training and other allowable
5 costs pursuant to the Community-Law Enforcement and Other First
6 Responder Partnership for Deflection and Addiction Treatment
7 Act and any associated administrative expenses.

8 Section 55. The amount of \$600,000, or so much thereof as
9 may be necessary, is appropriated from the General Revenue Fund
10 to the Illinois Criminal Justice Information Authority for
11 costs associated with implementation of the SAFE-T Act.

12 Section 60. The sum of \$1,000,000, or so much thereof as
13 may be necessary, is appropriated to the Illinois Criminal
14 Justice Information Authority from the General Revenue Fund for
15 a grant to the University of Illinois at Springfield for the
16 Illinois Innocence Project, and any associated administrative
17 expenses.

18 Section 65. The amount of \$1,500,000, or so much thereof
19 as may be necessary, is appropriated from the General Revenue
20 Fund to the Illinois Criminal Justice Information Authority for
21 grants and administrative expenses associated with statewide
22 deferred prosecution funding programs.

1 Section 70. The amount of \$300,000, or so much thereof as
2 may be necessary, is appropriated from the General Revenue Fund
3 to the Illinois Criminal Justice Information Authority for
4 grants and administrative expenses associated with the Domestic
5 Violence Fatality Review Committee.

6 Section 75. The amount of \$545,100, or so much thereof as
7 may be necessary, is appropriated from the General Revenue Fund
8 to the Illinois Criminal Justice Information Authority for
9 grants and administrative expenses associated with the
10 Innovations Institute.

11 Section 80. The amount of \$75,000, or so much thereof as
12 may be necessary, is appropriated from the General Revenue Fund
13 to the Illinois Criminal Justice Information Authority for
14 grants and administrative expenses associated with the Higher
15 Education in Prison Task Force.

16 Section 85. The amount of \$20,000,000, or so much thereof
17 as may be necessary, is appropriated from the General Revenue
18 Fund to the Illinois Criminal Justice Information Authority for
19 deposit into the Gang Crime Witness Protection Program Fund.

20 Section 90. The amount of \$18,786,300, or so much thereof

1 as may be necessary, is appropriated from the General Revenue
 2 Fund to the Illinois Criminal Justice Information Authority for
 3 administrative costs and grants to the following named
 4 entities. The combined cost of grants and administrative
 5 expenses associated with each grant shall equal the approximate
 6 amounts below.

 15 and grants for Adult Redeploy and Diversion Programs.

16 Section 15. The amount of \$500,000, or so much thereof as
 17 may be necessary, is appropriated from the Criminal Justice
 18 Information Projects Fund to the Illinois Criminal Justice
 19 Information Authority for distribution to fund Department of
 20 State Police drug task forces and Metropolitan Enforcement
 21 Groups.

22 Section 20. The amount of \$2,500,000, or so much thereof

1 as may be necessary, is appropriated from the Criminal Justice
2 Information Projects Fund to the Illinois Criminal Justice
3 Information Authority for distribution of revenue pursuant to
4 Section 21.10 of the Illinois Lottery Law.

5 Section 25. The amount of \$125,000,000, or so much thereof
6 as may be necessary, is appropriated from the Criminal Justice
7 Information Projects Fund to the Illinois Criminal Justice
8 Information Authority for administrative costs, awards and
9 grants associated with the Restore, Reinvest, and Renew
10 Program, including prior year costs.

11 Section 30. The amount of \$2,000,000, or so much thereof as
12 may be necessary, is appropriated from the Criminal Justice
13 Information Projects Fund to the Illinois Criminal Justice
14 Information Authority for all costs associated with research,
15 analysis and evaluation of Restore, Reinvest, and Renew
16 programs.

17 Section 35. The following named amounts, or so much thereof
18 as may be necessary, are appropriated to the Illinois Criminal
19 Justice Information Authority for awards and grants and other
20 monies received from federal agencies, from other units of
21 government, and from private/not-for-profit organizations for
22 activities undertaken in support of investigating issues in

1 criminal justice and for undertaking other criminal justice

20 as may be necessary, is appropriated from the Criminal Justice
21 Trust Fund to the Illinois Criminal Justice Information
22 Authority for awards and grants to local units of government,

1 state agencies and non-profit organizations.

2 Section 55. The amount of \$7,800, or so much thereof as
3 may be necessary, is appropriated from the Illinois State Crime
4 Stoppers Association Fund to the Illinois Criminal Justice
5 Information Authority for grants to enhance and develop Crime
6 Stoppers programs in Illinois.

7 Section 60. The following named amounts, or so much thereof
8 as may be necessary, respectively, for the objects and purposes
9 hereinafter named, are appropriated to the Illinois Criminal
10 Justice Information Authority for the training of law
11 enforcement personnel and services for families of victims of

1 Section 65. The amount of \$150,000, or so much thereof as
2 may be necessary, is appropriated from the Prescription Pill
3 and Drug Disposal Fund to the Illinois Criminal Justice
4 Information Authority for the purpose of collection,
5 transportation, and incineration of pharmaceuticals by local
6 law enforcement agencies.

7 Section 70. The amount of \$20,000,000, or so much thereof
8 as may be necessary, is appropriated from the Criminal Justice
9 Trust Fund to the Illinois Criminal Justice Information
10 Authority for administrative costs, awards and grants
11 associated with the Coronavirus Emergency Supplemental Funding
12 (CESF) Program.

13 Section 75. The amount of \$20,000,000, or so much thereof
14 as may be necessary, is appropriated from the Gang Crime Witness
15 Protection Program Fund to the Illinois Criminal Justice
16 Information Authority for grants and administrative expenses
17 associated with the Gang Crime Witness Protection Program Per
18 Public Act 98-0058.

ARTICLE 3

20 Section 5. The sum of \$50,000,000, or so much thereof as
21 may be necessary and remains unexpended at the close of

1 business on June 30, 2022, from an appropriation heretofore
2 made for such purpose in Article 127, Section 135 of Public
3 Act 102-0017, as amended, is reappropriated from the State
4 Coronavirus Urgent Remediation Emergency Fund to the Illinois
5 Criminal Justice Information Authority for grants and
6 administrative expenses associated with implementing violence
7 prevention programs for purposes permitted by Section 9901 of
8 the American Rescue Plan Act of 2021 and any associated
9 federal guidance.

10 Section 10. The sum of \$800,000, or so much thereof as
11 may be necessary and remains unexpended at the close of
12 business on June 30, 2022, from an appropriation heretofore
13 made for such purpose in Article 127, Section 345 of Public
14 Act 102-0017, as amended, is reappropriated from the State
15 Coronavirus Urgent Remediation Emergency Fund to the Illinois
16 Criminal Justice Information Authority for a grant to Carmen-
17 Buckner Elementary School, including administrative costs,
18 for purposes allowed by Section 9901 of the American Rescue
19 Plan Act of 2021 and any associated federal guidance.

20 Section 15. The sum of \$800,000, or so much thereof as
21 may be necessary and remains unexpended at the close of
22 business on June 30, 2022, from an appropriation heretofore
23 made for such purpose in Article 127, Section 350 of Public

1 Act 102-0017, as amended, is reappropriated from the State
2 Coronavirus Urgent Remediation Emergency Fund to the Illinois
3 Criminal Justice Information Authority for a grant to Earhart
4 Elementary School, including administrative costs, for
5 purposes allowed by Section 9901 of the American Rescue Plan
6 Act of 2021 and any associated federal guidance.

7 Section 20. The sum of \$800,000, or so much thereof as may be
8 necessary and remains unexpended at the close of business on
9 June 30, 2022, from an appropriation heretofore made for such
10 purpose in Article 127, Section 355 of Public Act 102-0017,
11 as amended, is reappropriated from the State Coronavirus
12 Urgent Remediation Emergency Fund to the Illinois Criminal
13 Justice Information Authority for a grant to Dulles
14 Elementary School, including administrative costs, for
15 purposes allowed by Section 9901 of the American Rescue Plan
16 Act of 2021 and any associated federal guidance.

17 Section 25. The sum of \$800,000, or so much thereof as
18 may be necessary and remains unexpended at the close of
19 business on June 30, 2022, from an appropriation heretofore
20 made for such purpose in Article 127, Section 360 of Public
21 Act 102-0017, as amended, is reappropriated from the State
22 Coronavirus Urgent Remediation Emergency Fund to the Illinois
23 Criminal Justice Information Authority for a grant to St.

1 Bernard Hospital, including administrative costs, for
2 purposes allowed by Section 9901 of the American Rescue Plan
3 Act of 2021 and any associated federal guidance.

4 Section 30. The sum of \$150,000, or so much thereof as
5 may be necessary and remains unexpended at the close of
6 business on June 30, 2022, from an appropriation heretofore
7 made for such purpose in Article 127, Section 470 of Public
8 Act 102-0017, as amended, is reappropriated from the State
9 Coronavirus Urgent Remediation Emergency Fund to the Illinois
10 Criminal Justice Information Authority for a grant to First
11 Followers Re-Entry Program for violence prevention and
12 reduction, including administrative costs, for purposes
13 allowed by Section 9901 of the American Rescue Plan Act of
14 2021 and any associated federal guidance.

15 Section 35. The sum of \$500,000, or so much thereof as
16 may be necessary and remains unexpended at the close of
17 business on June 30, 2022, from an appropriation heretofore
18 made for such purpose in Article 127, Section 475 of Public
19 Act 102-0017, as amended, is reappropriated from the State
20 Coronavirus Urgent Remediation Emergency Fund to the Illinois
21 Criminal Justice Information Authority for a grant to Ex-Cons
22 for Community and Social Change for violence prevention and
23 reduction, including administrative costs, for purposes

1 allowed by Section 9901 of the American Rescue Plan Act of
2 2021 and any associated federal guidance.

3 Section 40. The sum of \$300,000, or so much thereof as
4 may be necessary and remains unexpended at the close of
5 business on June 30, 2022, from an appropriation heretofore
6 made for such purpose in Article 127, Section 480 of Public
7 Act 102-0017, as amended, is reappropriated from the State
8 Coronavirus Urgent Remediation Emergency Fund to the Illinois
9 Criminal Justice Information Authority for a grant to Urban
10 League of Metropolitan St. Louis at Fairview Heights for
11 violence prevention and reduction, including administrative
12 costs, for purposes allowed by Section 9901 of the American
13 Rescue Plan Act of 2021 and any associated federal guidance.

14 Section 45. The sum of \$250,000, or so much thereof as
15 may be necessary and remains unexpended at the close of
16 business on June 30, 2022, from an appropriation heretofore
17 made for such purpose in Article 127, Section 485 of Public
18 Act 102-0017, as amended, is reappropriated from the State
19 Coronavirus Urgent Remediation Emergency Fund to the Illinois
20 Criminal Justice Information Authority for a grant to Black
21 Lives Matter of Lake County for violence prevention and youth
22 mentorship, including administrative costs, for purposes
23 allowed by Section 9901 of the American Rescue Plan Act of

1 2021 and any associated federal guidance.

2 Section 50. The sum of \$300,000, or so much thereof as
3 may be necessary and remains unexpended at the close of
4 business on June 30, 2022, from an appropriation heretofore
5 made for such purpose in Article 127, Section 490 of Public
6 Act 102-0017, as amended, is reappropriated from the State
7 Coronavirus Urgent Remediation Emergency Fund to the Illinois
8 Criminal Justice Information Authority for a grant to Elite
9 Striders Drill Team for violence prevention and reduction,
10 including administrative costs, for purposes allowed by
11 Section 9901 of the American Rescue Plan Act of 2021 and any
12 associated federal guidance.

13 Section 55. The sum of \$1,000,000, or so much thereof as
14 may be necessary and remains unexpended at the close of
15 business on June 30, 2022, from an appropriation heretofore
16 made for such purpose in Article 127, Section 495 of Public
17 Act 102-0017, as amended, is reappropriated from the State
18 Coronavirus Urgent Remediation Emergency Fund to the Illinois
19 Criminal Justice Information Authority for a grant to
20 Violence Interrupters for violence prevention and reduction,
21 including administrative costs, for purposes allowed by
22 Section 9901 of the American Rescue Plan Act of 2021 and any
23 associated federal guidance.

Section 99. Effective Date. This Act takes effect July 1,
