## SYNOPSIS AS INTRODUCED:

105 ILCS 5/21B-20

Amends the School Code. Provides that a foreign language endorsement on an Educator License with Stipulations may be issued to an applicant who provides satisfactory evidence that he or she meets specified requirements. Provides that the foreign language endorsement on an Educator License with Stipulations is valid until June 30 immediately following 5 years of the endorsement being issued and may be renewed. Provides that an individual who holds a valid foreign language endorsement on an Educator License with Stipulations may teach a course on the foreign language for which the foreign language endorsement is issued. Provides that an individual who holds a valid foreign language endorsement on an Educator License with Stipulations but does not hold a bachelor's degree may substitute teach in foreign language classrooms. Effective July 1, 2023.

# Be it enacted by the People of the State of Illinois, represented in the General Assembly:

Section 5. The School Code is amended by changing Section
21B-20 as follows:

6 (105 ILCS 5/21B-20)

7 Sec. 21B-20. Types of licenses. The State Board of 8 Education shall implement a system of educator licensure, 9 whereby individuals employed in school districts who are required to be licensed must have one of the following 10 licenses: (i) a professional educator license; 11 (ii) an 12 license with stipulations; (iii) a substitute educator teaching license; or (iv) until June 30, 2023, a short-term 13 14 substitute teaching license. References in law regarding individuals certified or certificated or required to be 15 16 certified or certificated under Article 21 of this Code shall 17 also include individuals licensed or required to be licensed under this Article. The first year of all licenses ends on June 18 19 30 following one full year of the license being issued.

The State Board of Education, in consultation with the State Educator Preparation and Licensure Board, may adopt such rules as may be necessary to govern the requirements for licenses and endorsements under this Section.

(1) Professional Educator License. Persons who (i) 1 2 have successfully completed an approved educator 3 preparation program and are recommended for licensure by the Illinois institution offering the educator preparation 4 5 program, (ii) have successfully completed the required testing under Section 21B-30 of this Code, (iii) have 6 7 successfully completed coursework on the psychology of, the identification of, and the methods of instruction for 8 9 exceptional child, including without limitation the 10 children with learning disabilities, (iv) have 11 successfully completed coursework in methods of reading 12 and reading in the content area, and (v) have met all other criteria established by rule of the State Board of 13 14 Education shall be issued a Professional Educator License. 15 All Professional Educator Licenses are valid until June 30 16 immediately following 5 years of the license being issued. 17 The Professional Educator License shall be endorsed with specific areas and grade levels in which the individual is 18 19 eligible to practice. For an early childhood education 20 endorsement, an individual may satisfy the student 21 teaching requirement of his or her early childhood teacher 22 preparation program through placement in a setting with 23 children from birth through grade 2, and the individual may be paid and receive credit while student teaching. The 24 25 student teaching experience must meet the requirements of 26 be approved by the individual's early childhood and

1 teacher preparation program.

Individuals can receive subsequent endorsements on the Professional Educator License. Subsequent endorsements shall require a minimum of 24 semester hours of coursework in the endorsement area and passage of the applicable content area test, unless otherwise specified by rule.

7 (2) Educator License with Stipulations. An Educator
8 License with Stipulations shall be issued an endorsement
9 that limits the license holder to one particular position
10 or does not require completion of an approved educator
11 program or both.

12 An individual with an Educator License with 13 Stipulations must not be employed by a school district or 14 any other entity to replace any presently employed teacher 15 who otherwise would not be replaced for any reason.

16 An Educator License with Stipulations may be issued 17 with the following endorsements:

(A) (Blank).

(B) Alternative provisional educator. An
alternative provisional educator endorsement on an
Educator License with Stipulations may be issued to an
applicant who, at the time of applying for the
endorsement, has done all of the following:

(i) Graduated from a regionally accredited
 college or university with a minimum of a
 bachelor's degree.

1(ii) Successfully completed the first phase of2the Alternative Educator Licensure Program for3Teachers, as described in Section 21B-50 of this4Code.

(iii) Passed a content area test, as required under Section 21B-30 of this Code.

7 The alternative provisional educator endorsement is 8 valid for 2 years of teaching and may be renewed for a 9 third year by an individual meeting the requirements set 10 forth in Section 21B-50 of this Code.

11 (C) Alternative provisional superintendent. An 12 alternative provisional superintendent endorsement on 13 an Educator License with Stipulations entitles the 14 holder to serve only as a superintendent or assistant 15 superintendent in a school district's central office. 16 This endorsement may only be issued to an applicant 17 who, at the time of applying for the endorsement, has done all of the following: 18

19(i) Graduated from a regionally accredited20college or university with a minimum of a master's21degree in a management field other than education.

(ii) Been employed for a period of at least 5
years in a management level position in a field
other than education.

endorsement program, as provided in Section 21B-55 of this Code.

3 (iv) Passed a content area test required under Section 21B-30 of this Code.

The endorsement is valid for 2 fiscal years in order to complete one full year of serving as a superintendent or assistant superintendent.

(D) (Blank).

9 (E) Career and technical educator. A career and technical educator endorsement on an Educator License 10 11 with Stipulations may be issued to an applicant who 12 has a minimum of 60 semester hours of coursework from a 13 regionally accredited institution of higher education or an accredited trade and technical institution and 14 has a minimum of 2,000 hours of experience outside of 15 16 education in each area to be taught.

17 The career and technical educator endorsement on an Educator License with Stipulations is valid until 18 19 June 30 immediately following 5 years of the 20 endorsement being issued and may be renewed.

individual who holds a valid career 21 An and 22 technical educator endorsement on an Educator License 23 with Stipulations but does not hold a bachelor's 24 degree may substitute teach in career and technical 25 education classrooms.

(F) Part-time provisional career and technical

1 educator or provisional career and technical educator. A part-time provisional career and technical educator 2 3 endorsement or a provisional career and technical educator endorsement on an Educator License with 4 5 Stipulations may be issued to an applicant who has a 6 minimum of 8,000 hours of work experience in the skill 7 for which the applicant is seeking the endorsement. It is the responsibility of each employing school board 8 regional office of education 9 and to provide 10 verification, in writing, to the State Superintendent 11 of Education at the time the application is submitted 12 that no qualified teacher holding a Professional 13 Educator License Educator License or an with 14 Stipulations with a career and technical educator 15 endorsement is available and that actual circumstances 16 require such issuance.

The provisional career and technical educator endorsement on an Educator License with Stipulations is valid until June 30 immediately following 5 years of the endorsement being issued and may be renewed for 5 years.

A part-time provisional career and technical educator endorsement on an Educator License with Stipulations may be issued for teaching no more than 2 courses of study for grades 6 through 12. The part-time provisional career and technical educator endorsement on an Educator License with Stipulations is valid until June 30 immediately following 5 years of the endorsement being issued and may be renewed for years if the individual makes application for renewal.

6 An individual who holds a provisional or part-time 7 provisional career and technical educator endorsement 8 on an Educator License with Stipulations but does not 9 hold a bachelor's degree may substitute teach in 10 career and technical education classrooms.

11 (G) Transitional bilingual educator. Α 12 transitional bilingual educator endorsement on an 13 Educator License with Stipulations may be issued for 14 the purpose of providing instruction in accordance 15 with Article 14C of this Code to an applicant who 16 provides satisfactory evidence that he or she meets 17 all of the following requirements:

18 (i) Possesses adequate speaking, reading, and
19 writing ability in the language other than English
20 in which transitional bilingual education is
21 offered.

(ii) Has the ability to successfullycommunicate in English.

24 (iii) Either possessed, within 5 years
25 previous to his or her applying for a transitional
26 bilingual educator endorsement, a valid and

comparable teaching certificate or comparable 1 2 authorization issued by a foreign country or holds a degree from an institution of higher learning in 3 country that the State Educator 4 а foreign 5 Preparation and Licensure Board determines to be the equivalent of a bachelor's degree from a 6 7 regionally accredited institution of higher 8 learning in the United States.

9 A transitional bilingual educator endorsement 10 shall be valid for prekindergarten through grade 12, 11 is valid until June 30 immediately following 5 years 12 of the endorsement being issued, and shall not be 13 renewed.

Persons holding a transitional bilingual educator endorsement shall not be employed to replace any presently employed teacher who otherwise would not be replaced for any reason.

In an to 19 alleviate the shortage of teachers speaking a language 20 other than English in the public schools, an individual who holds an Educator License with 21 22 Stipulations apply for may also а language 23 endorsement, provided that the applicant provides satisfactory evidence that he or she meets all of the 24 25 following requirements:

(ii) Has demonstrated proficiency in the language for which the endorsement is to be issued by passing the applicable language content test required by the State Board of Education.

6 (iii) Holds a bachelor's degree or higher from 7 a regionally accredited institution of higher 8 education or, for individuals educated in а 9 country other than the United States, holds a 10 degree from an institution of higher learning in a 11 foreign country that the State Educator 12 Preparation and Licensure Board determines to be 13 the equivalent of a bachelor's degree from a 14 regionally accredited institution of higher 15 learning in the United States.

(iv) (Blank).

17 A language endorsement on an Educator License with Stipulations is valid for prekindergarten through 18 grade 12 for the same validity period as 19 the 20 individual's transitional bilingual educator 21 endorsement on the Educator License with Stipulations 22 and shall not be renewed.

(I) Visiting international educator. A visiting
 international educator endorsement on an Educator
 License with Stipulations may be issued to an
 individual who is being recruited by a particular

1 school district that conducts formal recruitment 2 programs outside of the United States to secure the 3 services of qualified teachers and who meets all of 4 the following requirements:

(i) Holds the equivalent of a minimum of a bachelor's degree issued in the United States.

(ii) Has been prepared as a teacher at the grade level for which he or she will be employed.

9 (iii) Has adequate content knowledge in the 10 subject to be taught.

11(iv) Has an adequate command of the English12language.

13 A holder of a visiting international educator 14 endorsement on an Educator License with Stipulations 15 shall be permitted to teach in bilingual education 16 programs in the language that was the medium of 17 instruction in his or her teacher preparation program, provided that he or she passes the English Language 18 19 Proficiency Examination or another test of writing 20 skills in English identified by the State Board of 21 Education, in consultation with the State Educator 22 Preparation and Licensure Board.

A visiting international educator endorsement on an Educator License with Stipulations is valid for 5 years and shall not be renewed.

(J) Paraprofessional educator. A paraprofessional

а

1 educator endorsement on an Educator License with 2 Stipulations may be issued to an applicant who holds a 3 high school diploma or its recognized equivalent and either holds an associate's degree or a minimum of 60 4 5 semester hours of credit from a regionally accredited 6 institution of higher education or has passed a 7 paraprofessional competency test under subsection (c-5) of Section 21B-30. The paraprofessional educator 8 9 endorsement is valid until June 30 immediately 10 following 5 years of the endorsement being issued and 11 may be renewed through application and payment of the 12 appropriate fee, as required under Section 21B-40 of holds 13 Code. An individual this who only 14 paraprofessional educator endorsement is not subject 15 to additional requirements in order to renew the 16 endorsement.

17 (K) Chief school business official. A chief school business official endorsement on an Educator License 18 19 with Stipulations may be issued to an applicant who 20 qualifies by having a master's degree or higher, 2 21 years of full-time administrative experience in school 22 business management or 2 years of university-approved 23 practical experience, and a minimum of 24 semester 24 hours of graduate credit in a program approved by the 25 State Board of Education for the preparation of school 26 business administrators and by passage of the

applicable State tests, including an applicable
 content area test.

The chief school business official endorsement may 3 also be affixed to the Educator License 4 with 5 Stipulations of any holder who qualifies by having a master's degree in business administration, finance, 6 accounting, or public administration and who completes 7 an additional 6 semester hours of internship in school 8 9 business management from a regionally accredited 10 institution of higher education and passes the 11 applicable State tests, including an applicable 12 content area test. This endorsement shall be required 13 for any individual employed as a chief school business official. 14

The chief school business official endorsement on 15 16 an Educator License with Stipulations is valid until 17 immediately following 5 June 30 years of the endorsement being issued and may be renewed if the 18 19 license holder completes renewal requirements as 20 required for individuals who hold a Professional 21 Educator License endorsed for chief school business 22 official under Section 21B-45 of this Code and such 23 rules as may be adopted by the State Board of Education. 24

25The State Board of Education shall adopt any rules26necessary to implement Public Act 100-288.

(L) Provisional in-state educator. A provisional 1 in-state educator endorsement on an Educator License 2 3 with Stipulations may be issued to a candidate who has completed an Illinois-approved educator preparation 4 5 program at an Illinois institution of higher education 6 and who has not successfully completed an 7 evidence-based assessment of teacher effectiveness but who meets all of the following requirements: 8 9 (i) Holds at least a bachelor's degree.

10(ii) Has completed an approved educator11preparation program at an Illinois institution.

(iii) Has passed an applicable content area
 test, as required by Section 21B-30 of this Code.

14 (iv) Has attempted an evidence-based 15 assessment of teacher effectiveness and received a 16 minimum score on that assessment, as established 17 by the State Board of Education in consultation with the State Educator Preparation and Licensure 18 19 Board.

A provisional in-state educator endorsement on an Educator License with Stipulations is valid for one full fiscal year after the date of issuance and may not be renewed.

(M) (Blank).

(N) Specialized services. A specialized services
 endorsement on an Educator License with Stipulations

may be issued as defined and specified by rule. 1 (O) Foreign language endorsement. A foreign 2 3 language endorsement on an Educator License with Stipulations may be issued to an applicant who 4 5 provides satisfactory evidence that he or she meets 6 all of the following requirements: 7 (i) Possesses adequate speaking, reading, and 8 writing ability in a language other than English. 9 (ii) Has the ability to successfully 10 communicate in English. 11 (iii) Has demonstrated proficiency in the 12 language for which the endorsement is to be issued by passing the applicable language content test 13 14 required by the State Board of Education; however, 15 if the language for which the endorsement is to be 16 issued is the applicant's first language, the 17 applicant shall not be required to pass the 18 applicable language content test in order to 19 receive the foreign language endorsement under 20 this subsection. 21 The foreign language endorsement on an 22 Educator License with Stipulations is valid until June 23 30 immediately following 5 years of the endorsement 24 being issued and may be renewed. 25 An individual who holds a valid foreign 26 language endorsement on an Educator License with

1Stipulations may teach a course on the foreign2language for which the foreign language endorsement is3issued.

4An individual who holds a valid foreign5language endorsement on an Educator License with6Stipulations but does not hold a bachelor's degree may7substitute teach in foreign language classrooms.

(3) Substitute Teaching License. A Substitute Teaching 8 9 License may be issued to qualified applicants for 10 substitute teaching in all grades of the public schools, 11 prekindergarten through grade 12. Substitute Teaching 12 Licenses are not eligible for endorsements. Applicants for 13 a Substitute Teaching License must hold a bachelor's 14 degree or higher from a regionally accredited institution 15 of higher education.

16

Substitute Teaching Licenses are valid for 5 years.

17 Substitute Teaching Licenses are valid for substitute 18 teaching in every county of this State. If an individual 19 has had his or her Professional Educator License or 20 Educator License with Stipulations suspended or revoked, 21 then that individual is not eligible to obtain a 22 Substitute Teaching License.

A substitute teacher may only teach in the place of a licensed teacher who is under contract with the employing board. If, however, there is no licensed teacher under contract because of an emergency situation, then a - 16 - LRB102 28143 RJT 39950 b

district may employ a substitute teacher for no longer 1 than 30 calendar days per each vacant position in the 2 3 district if the district notifies the appropriate regional office of education within 5 business days after the 4 5 employment of the substitute teacher in the emergency situation. An emergency situation is one in which an 6 7 unforeseen vacancy has occurred and (i) a teacher is unable to fulfill his or her contractual duties or (ii) 8 9 teacher capacity needs of the district exceed previous 10 indications, and the district is actively engaged in 11 advertising to hire a fully licensed teacher for the 12 vacant position.

13 There is no limit on the number of days that a 14 substitute teacher may teach in a single school district, 15 provided that no substitute teacher may teach for longer 16 than 90 school days for any one licensed teacher under 17 contract in the same school year. A substitute teacher who holds a Professional Educator License or Educator License 18 19 with Stipulations shall not teach for more than 120 school 20 days for any one licensed teacher under contract in the 21 same school year. The limitations in this paragraph (3) on 22 the number of days a substitute teacher may be employed do 23 not apply to any school district operating under Article 34 of this Code. 24

A school district may not require an individual who
 holds a valid Professional Educator License or Educator

1 2 License with Stipulations to seek or hold a Substitute Teaching License to teach as a substitute teacher.

3 (4) Short-Term Substitute Teaching License. Beginning on July 1, 2018 and until June 30, 2023, the State Board of 4 5 Education may issue a Short-Term Substitute Teaching 6 License. A Short-Term Substitute Teaching License may be 7 issued to a qualified applicant for substitute teaching in 8 all grades of the public schools, prekindergarten through 9 grade 12. Short-Term Substitute Teaching Licenses are not 10 eligible for endorsements. Applicants for a Short-Term 11 Substitute Teaching License must hold an associate's 12 degree or have completed at least 60 credit hours from a 13 regionally accredited institution of higher education.

14 Short-Term Substitute Teaching Licenses are valid for 15 substitute teaching in every county of this State. If an 16 individual has had his or her Professional Educator 17 License or Educator License with Stipulations suspended or 18 revoked, then that individual is not eligible to obtain a 19 Short-Term Substitute Teaching License.

20The provisions of Sections 10-21.9 and 34-18.5 of this21Code apply to short-term substitute teachers.

22 An individual holding a Short-Term Substitute Teaching 23 License may teach no more than 5 consecutive days per 24 licensed teacher who is under contract. individual holding a Short-Term Substitute Teaching
License. An individual holding a Short-Term Substitute
Teaching License must complete the training program under
Section 10-20.67 or 34-18.60 of this Code to be eligible
to teach at a public school. This paragraph (4) is
inoperative on and after July 1, 2023.
