1	Section 10. The sum of \$2,500,000, or so much thereof as
2	may be necessary, is appropriated from the Fire Prevention Fund
3	to the Office of the State Fire Marshal for grants for the
4	Small Equipment Grant Program.
5	Section 15. The sum of \$1,000,000, or so much thereof as
6	may be necessary, is appropriated from the Fire Prevention Fund
7	to the Office of the State Fire Marshal for all costs associated
8	with the Minimum Basic Firefighter Training Program.
9	Section 20. The sum of \$60,000, or so much thereof as may
10	be necessary, is appropriated from the Fire Prevention Fund to
11	the Office of the State Fire Marshal for all costs associated
12	with the Illinois Firefighter Peer Support Program.
13	Section 25. The sum of \$50,000, or so much thereof as may
14	be necessary, is appropriated from the Fire Prevention Fund to
15	the Office of the State Fire Marshal for all costs associated
16	with the Community Risk Reduction Program.

Section 30. The sum of \$380,000, or so much thereof as may he necessary, is appropriated from the Fire Prevention Fund to the Office of the State Fire Marshal for all costs associated with the Firefighter Online Training Management System. -4- OMB102 00120 CLF 10120 b

Section 35. The sum of \$2,000,000, or so much thereof as may be necessary, is appropriated from the Fire Prevention Fund to the Office of the State Fire Marshal for all costs associated with the renovation and rehabilitation of the Fire Museum Building located on the State Fairground in Springfield.

6 Section 40. The sum of \$75,000, or so much thereof as may 7 be necessary, is appropriated from the Illinois Fire Fighters' 8 Memorial Fund to the Office of the State Fire Marshal for 9 expenses related to the Maintenance and Rehabilitation of the 10 Fire Museum Building and Museum Artifacts.

Section 45. The sum of \$200,000, or so much thereof as may be necessary, is appropriated from the Illinois Fire Fighters' Memorial Fund to the Office of the State Fire Marshal for all costs associated with the Medal of Honor Ceremony, Scholarships and Firefighter Memorial Maintenance.

1 Section 65. The sum of \$240,000, or so much thereof as may 2 be necessary, is appropriated from the Fire Prevention Fund to 3 the Office of the State Fire Marshal for grants available for 4 costs and services related to ILEAS/MABAS administration.

5 Section 70. The sum of \$10,000, or so much thereof as may 6 be necessary, is appropriated from the Fire Prevention Fund to 7 the Office of the State Fire Marshal for a grant to the 8 Hazardous Materials Emergency Response Reimbursement.

9 Section 75. The sum of \$550,000, or so much thereof as may 10 be necessary, is appropriated from the Underground Storage Tank 11 Fund to the Office of the State Fire Marshal for a grant to the 12 City of Chicago for administrative costs incurred as a result 13 of the State's Underground Storage Program.

Section 99. Effective Date. This Act takes effect July 15 1, 2021.
