Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 Section 5. The Clinical Social Work and Social Work 5 Practice Act is amended by changing Sections 5, 8, 9A, and 11 6 as follows:

8 (Section scheduled to be repealed on January 1, 2028) 9 Sec. 5. Powers and duties of the Department. Subject to 10 the provisions of this Act, the Department shall exercise the 11 following functions, powers, and duties:

12 (1) Conduct or authorize examinations to ascertain the 13 qualifications and fitness of candidates for a license to 14 engage in the independent practice of clinical social work 15 and in the practice of social work, pass upon the 16 qualifications of applicants for licenses, and issue 17 licenses to those who are found to be fit and qualified.

18 (2) Adopt rules required for the administration and19 enforcement of this Act.

20 (3) Adopt rules for determining approved undergraduate
 21 and graduate social work degree programs and prepare and
 22 maintain a list of colleges and universities offering such
 23 approved programs whose graduates, if they otherwise meet

the requirements of this Act, are eligible to apply for a license.

3 (4) Prescribe forms to be issued for the 4 administration and enforcement of this Act consistent with 5 and reflecting the requirements of this Act and rules 6 adopted pursuant to this Act.

7 (5) Conduct investigations related to possible
8 violations of this Act.

9 (6) Maintain rosters of the names and addresses of all 10 persons who hold valid licenses under this Act. These 11 rosters shall be available upon written request and 12 payment of the required fee.

(2) Applicants for examination shall pay, either to the
 Department or to the designated testing service, a fee
 covering the cost of determining the applicant's eligibility

and of providing the examination. Failure to appear for the examination on the scheduled date at the time and place specified after the applicant's application for examination has been received and acknowledged by the Department or the designated testing service shall result in forfeiture of the examination fee.

8 (4) The Department may employ consultants for the purpose9 of preparing and conducting examinations.

10 (5)An applicant has one year from the date of notification of successful completion of the examination to 11 12 apply to the Department for a license. If an applicant fails to 13 apply within one year, the examination scores shall be void and the applicant shall be required to take and pass the 14 15 examination again unless licensed in another jurisdiction of 16 the United States within one year of passing the examination.

Applicants for a license as a licensed social worker enrolled in an approved program for a master's degree 18 19 in social work may sit for the authorized examination for 20 licensed social workers in the final semester of the program 21 for a master's degree in social work without prior approval of 22 the Department. The Department may adopt rules to administer 23 this paragraph (6). Applicants for a license as a licensed social worker must still meet all requirements set forth in 24 25 Section 9A.

A person shall be qualified to be licensed as a licensed social worker if that person: 5 6 (1) has applied in writing on the prescribed form; 7 is of good moral character, as defined in (2) subsection (2) of Section 9; 8 9 (3) (a) has a degree from a graduate program of social 10 work approved by the Department; or 11 (b) has a degree in social work from an undergraduate program approved by the Department and has successfully 12 13 completed at least 3 years of supervised professional 14 experience subsequent to obtaining the degree as 15 established by rule. If no supervision by a licensed 16 social worker or a licensed clinical social worker is available, then supervised professional experience may 17 18 include supervision by other appropriate disciplines as 19 defined by rule;

3 Sec. 11. Licenses; renewal; restoration; person in
4 military service; inactive status.

5 (a) The expiration date and renewal period for each license issued under this Act shall be set by rule. The 6 licensee may renew a license during the 60-day period 7 8 preceding its expiration date by paying the required fee and 9 by demonstrating compliance with any continuing education 10 requirements. The Department shall adopt rules establishing 11 minimum requirements of continuing education and means for 12 verification of the completion of the continuing education 13 The Department requirements. may, by rule, specify 14 circumstances under which the continuing education 15 requirements may be waived.

16 (b) Any person who has permitted a license to expire or who 17 has a license on inactive status may have it restored by submitting an application to the Department and filing proof 18 of fitness, as defined by rule, to have the license restored, 19 20 including, if appropriate, evidence which is satisfactory to the Department certifying the active practice of clinical 21 22 social work or social work in another jurisdiction and by 23 paying the required fee.

fitness to resume active status. The Department may also require the person to complete a specific period of evaluated clinical social work or social work experience and may require successful completion of an examination <u>for clinical social</u> <u>workers</u>.

6 (b-7) Notwithstanding any other provision of this Act, any 7 person whose license expired while on active duty with the armed forces of the United States, while called into service 8 9 or training with the State Militia or in training or education 10 under the supervision of the United States government prior to 11 induction into the military service may have his or her 12 license restored without paying any renewal fees if, within 2 13 years after the honorable termination of that service, training or education, except under conditions other than 14 15 honorable, the Department is furnished with satisfactory 16 evidence that the person has been so engaged and that the 17 service, training or education has been so terminated.

(c) A license to practice shall not be denied any
applicant because of the applicant's race, religion, creed,
national origin, political beliefs or activities, age, sex,
sexual orientation, or physical impairment.
