Amends various Acts relating to the governance of public universities in Illinois. Requires the governing board of each public university to provide to each enrolled student, at the time the student declares or changes his or her academic major or program of study, a report that contains relevant, independent, and accurate data related to the student's major or program of study and to the current occupational outlook associated with that major or program of study. Sets forth specific information the report must provide.

1 AN ACT concerning education.

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

Section 5. The University of Illinois Act is amended by adding Section 120 as follows:

(110 ILCS 305/120 new)

- Sec. 120. Academic major report. The Board of Trustees shall provide to each enrolled student, at the time the student declares or changes his or her academic major or program of study, a report that contains relevant, independent, and accurate data related to the student's major or program of study and to the current occupational outlook associated with that major or program of study. The report shall provide the student with all of the following information:
  - (1) The estimated cost of his or her education associated with pursuing a degree in that major or program of study.
    - (2) The average monthly student loan payment over a period of 20 years based on the estimated cost of his or her education under paragraph (1).
- (3) The average job placement rate within 12 months after graduation for a graduate who holds a degree in that

2	(4) The average entry-level wage or salary for an
3	occupation related to that major or program of study.
4	(5) The average wage or salary 5 years after entry
5	into an occupation under paragraph (4).
6	Section 10. The Southern Illinois University Management
