SYNOPSIS AS INTRODUCED:

225 ILCS 447/40-5

Amends the Private Detective, Private Alarm, Private Security, Fingerprint Vendor, and Locksmith Act of 2004. Provides that reasonable attorney's fees and costs may be awarded to a licensee, interested party, or person injured if he or she successfully obtains injunctive relief, whether by consent or otherwise. Effective immediately.

AN ACT concerning regulation.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

Section 5. The Private Detective, Private Alarm, Private
Security, Fingerprint Vendor, and Locksmith Act of 2004 is
amended by changing Section 40-5 as follows:

9 Sec. 40-5. Injunctive relief.

(a) The practice of a private detective, private security 10 contractor, private alarm contractor, fingerprint vendor, 11 12 locksmith, private detective agency, private security 13 contractor agency, private alarm contractor agency, 14 fingerprint vendor agency, or locksmith agency by any person, firm, corporation, or other legal entity that has not been 15 16 issued a license by the Department or whose license has been 17 suspended, revoked, or not renewed is hereby declared to be inimical to the public safety and welfare and to constitute a 18 19 public nuisance. The Secretary may, in the name of the People 20 of the State of Illinois through the Attorney General of the 21 State of Illinois or the State's Attorney of any county in 22 which the violation is alleged to have occurred in the State of Illinois, petition for an order enjoining the violation or for 23

an order enforcing compliance with this Act. Upon the filing 1 2 of a verified petition in court, if satisfied by affidavit or 3 otherwise that the person, firm, corporation, or other legal entity is or has been conducting activities in violation of 4 5 this Act, the court may enter a temporary restraining order or preliminary injunction, without bond, enjoining the defendant 6 7 from further activity. A copy of the verified complaint shall be served upon the defendant and the proceedings shall be 8 9 conducted as in civil cases. If it is established the 10 defendant has been or is conducting activities in violation of 11 this Act, the court may enter a judgment enjoining the 12 defendant from that activity. In case of violation of any injunctive order or judgment entered under this Section, the 13 court may punish the offender for contempt of court. 14 15 Injunctive proceedings shall be in addition to all other 16 penalties under this Act.

17 If any person practices as a private detective, (b) private security contractor, private 18 alarm contractor, fingerprint vendor, locksmith, private detective agency, 19 20 private security contractor agency, private alarm contractor agency, fingerprint vendor agency, or locksmith agency or 21 22 holds himself or herself out as such without having a valid 23 license under this Act, then any licensee, any interested 24 party, or any person injured thereby may, in addition to the 25 Secretary, petition for relief as provided in subsection (a) of this Section. Reasonable attorney's fees and costs may be 26
