SYNOPSIS AS INTRODUCED:

10 ILCS 5/1A-70 new

10 ILCS 5/19-3

from Ch. 46, par. 19-3

Amends the Election Code. Provides that the State Board of Elections shall develop and maintain a statewide or locally-based system to track and confirm when there is a change in the status of a trackable ballot. Provides that the term "trackable ballot" means a ballot that is: (1) mailed to a voter; and (2) deposited in the mail by a voter; or (3) deposited in a ballot box by a voter. Effective immediately.

A BILL FOR

1 AN ACT concerning elections.

2 **Be it enacted by the People of the State of Illinois,**
3 **represented in the General Assembly:**

4 Section 5. The Election Code is amended by changing
5 Section 19-3 and by adding Section 1A-70 as follows:

6 (10 ILCS 5/1A-70 new)

7 Sec. 1A-70. Ballot tracking system.

8 (a) As used in this Section:

9 "Change in the status" means:

10 (1) when a trackable ballot is mailed to a voter;

11 (2) when an election official receives a voted
12 trackable ballot; and

13 (3) when a voted trackable ballot is counted.

14 "Trackable ballot" means a ballot that is:

15 (1) mailed to a voter in accordance with Article 19;

16 and

17 (2) deposited in the mail by a voter in accordance
18 with Article 19; or

19 (3) deposited in a ballot box by a voter in accordance
20 with Article 15.

21 "Voter registration list" means the statewide list
22 established under Section 1A-25, or any successor statewide
23 voter registration list established by the State Board of

1 Elections.

2 (b) The State Board of Elections shall develop and
3 maintain a statewide or locally-based system to track and
4 confirm when there is a change in the status of a trackable
5 ballot.

6 (c) The ballot tracking system shall be operational on or
7 before July 1, 2022.

8 (d) Beginning on July 1, 2022, if a voter elects to receive
9 electronic notifications regarding the status of the voter's
10 trackable ballot, the ballot tracking system shall, when there
11 is a change in the status of the voter's trackable ballot:

12 (1) send a text message notification to the voter if
13 the voter's information in the voter registration list
14 includes a mobile telephone number;

15 (2) send an e-mail notification to the voter if the
16 voter's information in the voter registration list
17 includes an e-mail address; and

18 (3) send a notification by another electronic means
19 directed by the State Board of Elections.

22 (a) The application for a vote by mail ballot for a single
23 election shall be substantially in the following form:

24 APPLICATION FOR VOTE BY MAIL BALLOT

25 To be voted at the election in the County of and

1 State of Illinois, in the precinct of the (1) *township of
2 (2) *City of or (3) *.... ward in the City of

3 I state that I am a resident of the precinct of the
4 (1) *township of (2) *City of or (3) *.... ward in
5 the city of residing at in such city or town in the
6 county of and State of Illinois; that I have lived at such
7 address for month(s) last past; that I am lawfully
8 entitled to vote in such precinct at the election to be
9 held therein on; and that I wish to vote by vote by mail
10 ballot.

11 I hereby make application for an official ballot or
12 ballots to be voted by me at such election, and I agree that I
13 shall return such ballot or ballots to the official issuing
14 the same prior to the closing of the polls on the date of the
15 election or, if returned by mail, postmarked no later than
16 election day, for counting no later than during the period for
17 counting provisional ballots, the last day of which is the
18 14th day following election day.

19 I understand that this application is made for an official
20 vote by mail ballot or ballots to be voted by me at the
21 election specified in this application and that I must submit
22 a separate application for an official vote by mail ballot or
23 ballots to be voted by me at any subsequent election.

24 Under penalties as provided by law pursuant to Section
25 29-10 of the Election Code, the undersigned certifies that the
26 statements set forth in this application are true and correct.

5 (b) The application for permanent vote by mail status
6 shall be substantially in the following form:

7 APPLICATION FOR PERMANENT VOTE BY MAIL STATUS

8 I am currently a registered voter and wish to apply for
9 permanent vote by mail status.

10 I state that I am a resident of the City of residing
11 at in such city in the county of and State of
12 Illinois; that I have lived at such address for month(s)
13 last past; that I am lawfully entitled to vote in such precinct
14 at the election to be held therein on; and that I
15 wish to vote by vote by mail ballot in:

16 all subsequent elections that do not require a party
17 designation.

18 all subsequent elections, and I wish to receive a
19 Party vote by mail ballot in
20 elections that require a party designation.

21 I hereby make application for an official ballot or
22 ballots to be voted by me at such election, and I agree that I
23 shall return such ballot or ballots to the official issuing
24 the same prior to the closing of the polls on the date of the
25 election or, if returned by mail, postmarked no later than
26 election day, for counting no later than during the period for

1 counting provisional ballots, the last day of which is the
2 14th day following election day.

3 Under penalties as provided by law under Section 29-10 of
4 the Election Code, the undersigned certifies that the
5 statements set forth in this application are true and correct.

9 (c) However, if application is made for a primary election
10 ballot, such application shall require the applicant to
11 designate the name of the political party with which the
12 applicant is affiliated. The election authority shall allow
13 any voter on permanent vote by mail status to change his or her
14 party affiliation for a primary election ballot by a method
15 and deadline published and selected by the election authority.

16 (d) If application is made electronically, the applicant
17 shall mark the box associated with the above described
18 statement included as part of the online application
19 certifying that the statements set forth in the application
20 under subsection (a) or (b) are true and correct, and a
21 signature is not required.

22 (e) Any person may produce, reproduce, distribute, or
23 return to an election authority an application under this
24 Section. If applications are sent to a post office box
25 controlled by any individual or organization that is not an
26 election authority, those applications shall (i) include a

1 valid and current phone number for the individual or
2 organization controlling the post office box and (ii) be
3 turned over to the appropriate election authority within 7
4 days of receipt or, if received within 2 weeks of the election
5 in which an applicant intends to vote, within 2 days of
6 receipt. Failure to turn over the applications in compliance
7 with this paragraph shall constitute a violation of this Code
8 and shall be punishable as a petty offense with a fine of \$100
9 per application. Removing, tampering with, or otherwise
10 knowingly making the postmark on the application unreadable by
11 the election authority shall establish a rebuttable
12 presumption of a violation of this paragraph. Upon receipt,
13 the appropriate election authority shall accept and promptly
14 process any application under this Section submitted in a form
15 substantially similar to that required by this Section,
16 including any substantially similar production or reproduction
17 generated by the applicant.

18 (f) An election authority may combine the applications in
19 subsections (a) and (b) onto one form, but the distinction
20 between the applications must be clear and the form must
21 provide check boxes for an applicant to indicate whether he or
22 she is applying for a single election vote by mail ballot or
23 for permanent vote by mail status.

24 (g) Beginning on July 1, 2022, the application shall also
25 include substantially the following provision, along with a
26 provision to allow the voter to specifically consent to

1 receive notifications by text message or e-mail:

2 "If you have provided a phone number or email address, you
3 can receive notifications by text message or e-mail regarding
4 the status of a ballot that is mailed to you and that you
5 deposit in the mail or in a ballot drop box by indicating the
6 phone number or email address here."

7 If the applicant provides a phone number or email address
8 on his or her application, the election authority shall
9 transmit that information to the State Board of Elections for
10 inclusion in the statewide voter registration list.
