The University of Illinois Hospital shall provide information on these programs, no less than at the 13

time of employment and during any benefit open enrollment

period, by an information form about the respective programs

that a nurse must sign during onboarding at the University of

- 10 professionals employed by the establishment are aware of
- 11 employee assistance programs or other like programs available
- for the physical and mental well-being of the employee. The
- establishment shall provide information on these programs, no
- less than at the time of employment and during any benefit open
- 15 enrollment period, by an information form about the respective
- 16 programs that a licensed health care professional must sign
- during onboarding at the establishment. The signed information

The Community Living Facility 7 shall provide information on these programs, no less than at 8 9 the time of employment and during any benefit open enrollment 10 period, by an information form about the respective programs 11 that a licensed health care professional must sign during onboarding at the Community Living Facility. The signed 12 13 information form shall be added to the licensed health care 14 professional's personnel file. The Community Living Facility 15 may provide this information to licensed health care 16 professionals electronically.
- Section 20. The Life Care Facilities Act is amended by adding Section 10.2 as follows:

- Sec. 10.2. Facility employee assistance programs. A

- Sec. 3-613. Facility employee assistance programs. A 16 17 facility shall ensure that nurses employed by the facility are 18 aware of employee assistance programs or other like programs available for the physical and mental well-being of the 19 employee. The facility shall provide information on these 20 programs, no less than at the time of employment and during any 21 22 benefit open enrollment period, by an information form about 23 the respective programs that a nurse must sign during onboarding at the facility. The signed information form shall 24

- be added to the nurse's personnel file. The facility may 1
- 2 provide this information to nurses electronically.
- Section 40. The Hospital Licensing Act is amended by 3
- 4 adding Section 6.33 as follows:
- (210 ILCS 85/6.33 new) 5
- Sec. 6.33. Hospital employee assistance programs. A 6
- 7 hospital licensed under this Act shall ensure that employees
- 8 of the hospital are made aware of employee assistance programs
- 9 or other like programs available for the physical and mental
- well-being of the employees. Hospitals shall provide 10
- information on these programs, no less than at the time of 11
- employment and during any benefit open enrollment period, by 12
- 13 an information form about the respective programs that an
- employee must sign during onboarding at the hospital. A 14
- hospital may provide this information to employees 15
- 16 electronically.".
