

## 103RD GENERAL ASSEMBLY State of Illinois 2023 and 2024 HB2266

Introduced 2/14/2023, by Rep. Mark L. Walker

## SYNOPSIS AS INTRODUCED:

15 ILCS 510/7a from Ch. 130, par. 107a 15 ILCS 510/7b from Ch. 130, par. 107b

Amends the State Treasurer Employment Code. Provides that members of the Personnel Review Board shall each be paid \$100 for each day they are engaged in the business of the Board and shall be reimbursed for their expenses when engaged in such business. Provides that members shall meet periodically in accordance with a schedule established by the chairperson and at such other times as necessary, with written notice given by the chairperson at least three days before the meeting. Effective immediately.

1 AN ACT concerning State government.

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- 4 Section 5. The State Treasurer Employment Code is amended
- 5 by changing Sections 7a, and 7b as follows:
- 6 (15 ILCS 510/7a) (from Ch. 130, par. 107a)
- 7 Sec. 7a. Terms compensation. Members of the Personnel
- 8 Review Board shall initially be appointed as follows:
- 9 (a) One member to serve for 2 years and until a successor
- 10 is appointed;
- 11 (b) One member to serve for 4 years and until a successor
- is appointed; and
- (c) One member to serve for 6 years and until a successor
- is appointed.
- Thereafter, members of the Board shall be appointed by the
- 16 Treasurer for 6 year terms with the advice and consent of the
- 17 Senate. One member of the Board shall be appointed a
- chairperson for a 2 year term. Members of the Board shall each
- be paid \$100 for each day they are engaged in the business of
- 20 the Board and shall be reimbursed for their expenses when
- 21 <u>engaged in such business</u> receive no compensation for their
- 22 services, but shall be reimbursed for necessary traveling and
- 23 other official expenses.

- 3 Sec. 7b. Meetings. Members Meetings of the Personnel
- 4 Review Board shall meet periodically in accordance with a
- 5 schedule established by the chairperson and at such other
- 6 times as necessary, with written notice given by the
- 7 chairperson at least three days before the meeting be held at
- 8 least 4 times a year on call of the chairman, or upon call
- 9 signed by any 2 members, or upon call of the Treasurer. Two
- 10 members of the Board constitute a quorum.
