| 9 | (a) The operator of a motorcycle, motor driven cycle, or |
| 10 | moped and every passenger thereon shall be protected by |
| 11 | glasses, goggles <u>,</u> or a transparent shield. |
| 12 | (a-5) In addition to the requirements of subsection (a) , |
| 13 | an operator or passenger of a motorcycle, motor driven cycle, |
| 14 | or moped who is less than 18 years of age shall be protected by |
| 15 | <u>a motorcycle helmet.</u> |
| 16 | (b) For the purposes of this Section, glasses, goggles, |

1 <u>motorcycle helmet</u>, and transparent shields are defined as 2 follows:

3 "Glasses" means ordinary eye pieces such as spectacles or 4 sunglasses worn before the eye, made of shatter-resistant 5 material. <u>"Shatter-resistant material"</u>, as used in this 6 Section, means material so manufactured, fabricated, or 7 created that it substantially prevents shattering or flying 8 when struck or broken.

9 "Goggles" means a device worn before the eyes, the 10 predominant function of which is protecting the eyes without 11 obstructing peripheral vision. Goggles shall provide 12 protection from the front and sides, and may or may not form a 13 complete seal with the face.

14 <u>"Motorcycle helmet" means a protective covering for the</u> 15 <u>head consisting of a hard outer shell, padding adjacent to and</u> 16 <u>inside the outer shell and a chin-strap type retention system</u> 17 <u>with a sticker indicating that the motorcycle helmet meets</u> 18 <u>standards established by the United States Department of</u> 19 <u>Transportation.</u>

"Transparent shield" means a windshield attached to the front of a motorcycle that extends above the eyes when an operator is seated in the normal, upright riding position, made of shatter-resistant material, or a shatter-resistant protective face shield that covers the wearer's eyes and face at least to a point approximately to the tip of the nose.
