A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. In addition to any other sums appropriated, the sum
6 of \$399,657,500 or so much thereof as may be necessary, is
7 appropriated from the Title III Social Security and Employment
8 Fund to the Department of Employment Security for operational
9 expenses, awards, grants, and permanent improvements for the
10 fiscal year ending June 30, 2025, including prior years' costs.

11 Section 15. The following named sums, or so much thereof
12 as may be necessary, are appropriated to the Department of
13 Employment Security:

14 WORKFORCE DEVELOPMENT

15 Payable from Title III Social Security and
16 Employment Fund:

17 For expenses related to the
18 Development of Training Programs200,000
19 For the expenses related to Employment
20 Security Automation3,700,000
21 For expenses related to a Benefit

15 Section 20. The following named amounts, or so much thereof
 16 as may be necessary, respectively, are appropriated to the
 17 Department of Employment Security:

23 Section 25. The following named amounts, or so much thereof

1 as may be necessary, are appropriated to the Department of
2 Employment Security for unemployment compensation benefits to
3 former state employees as follows:

4 TRUST FUND UNIT

5 Grants-In-Aid

6 Payable from the Road Fund:

7 For benefits paid on the basis of wages
8 paid for insured work for the Department
9 of Transportation5,000,000

10 Payable from Title III Social Security

11 and Employment Fund:1,734,300

12 Payable from the General Revenue Fund:21,000,000

13 Total \$27,734,300

14 Section 30. The sum of \$200,000, or so much thereof as may
15 be necessary, is appropriated from the General Revenue Fund to
16 the Department of Employment Security for all ordinary and
17 contingent expenses related to the implementation of Automatic
18 Voter Registration.

19 Section 45. The sum of \$75,000,000, or so much thereof as
20 may be necessary and remains unexpended at the close of business
21 on June 30, 2024, from an appropriation therefore made for such
22 purpose in Article 53, Section 45 of Public Act 103-0006, as
23 amended, is reappropriated from the Title III Social Security

1 and Employment Fund to the Department of Employment Security
2 for the return of federal funds to the Federal Emergency
3 Management Agency in accordance with 44 C.F.R. § 206.120 (f).

4 Section 50. The amount of \$700,000, or so much thereof as
5 may be necessary, is appropriated from the General Revenue Fund
6 to the Department of Employment Security for data analysis and
7 administrative expenses associated with the Homelessness
8 Prevention administrative data pilot addressing homelessness
9 prevention strategies.

10 Section 55. The amount of \$155,000, or so much thereof as
11 may be necessary, is appropriated from the General Revenue Fund
12 to the Department of Employment Security to implement
13 diversity, equity, inclusion, and accessibility initiatives.

14 Section 99. Effective date. This Act takes effect July 1,
15 2024.
