### SYNOPSIS AS INTRODUCED:

Makes specified appropriations to the Commission on Government Forecasting and Accountability, Legislative Information System, Legislative Printing Unit, Legislative Audit Commission, Legislative Reference Bureau, Joint Committee on Administrative Rules, Architect of the Capitol, Legislative Ethics Commission, and Legislative Inspector General for their ordinary and contingent expenses in the fiscal year beginning on July 1, 2024. Effective July 1, 2024.

A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 Article 1

5 Section 5. The sum of \$4,514,600, or so much thereof as may  
6 be necessary, is appropriated from the General Revenue Fund to  
7 the Commission on Government Forecasting and Accountability to  
8 meet its operational expenses for the fiscal year beginning  
9 July 1, 2024.

10 Section 10. The sum of \$1,500,000, or so much thereof as  
11 may be necessary, is appropriated from the General Revenue Fund  
12 to the Commission on Government Forecasting and Accountability  
13 for the purpose of making pension pick up contributions to the  
14 State Employees' Retirement System of Illinois for affected  
15 legislative staff employees for the fiscal year beginning July  
16 1, 2024.

17 Section 15. The sum of \$2,114,600, or so much thereof as  
18 may be necessary, is appropriated from the General Revenue Fund  
19 to the Architect of the Capitol to meet its ordinary and  
20 contingent expenses for the fiscal year beginning July 1, 2024.

1           Section 20. The sum of \$1,390,700, or so much thereof as  
2           may be necessary, is appropriated from the General Revenue Fund  
3           to the Joint Committee on Administrative Rules to meet its  
4           operational expenses for the fiscal year beginning July 1,  
5           2024.

6           Section 25. The sum of \$475,000, or so much thereof as may  
7           be necessary, is appropriated from the General Revenue Fund to  
8           the Legislative Audit Commission to meet its operational  
9           expenses for the fiscal year beginning July 1, 2024.

10          Section 30. The sum of \$200,000, or so much thereof as may  
11          be necessary, is appropriated to the Legislative Ethics  
12          Commission to meet the ordinary and contingent expenses of the  
13          Commission for the fiscal year beginning July 1, 2024.

15          Section 35. The sum of \$920,000, or so much thereof as may  
16          be necessary, is appropriated from the General Revenue Fund for  
17          Legislative Inspector General its ordinary and contingent  
18          expenses for the fiscal year beginning July 1, 2024.

19          Section 40. The sum of \$6,642,000, or so much thereof as  
20          may be necessary, is appropriated from the General Revenue Fund  
21          to the Legislative Information System to meet its operational

1 expenses for the fiscal year beginning July 1, 2024.

2 Section 45. The following sum, or so much of that amount  
3 as may be necessary, is appropriated from the General Revenue  
4 Assembly Computer Equipment Revolving Fund to the Legislative  
5 Information System:

6 For Purchase, Maintenance, and Rental of  
7 General Assembly Electronic Data Processing  
8 Equipment and for other operational purposes  
9 of the General Assembly .....\$1,600,000

10 Section 50. The sum of \$3,738,000, or so much thereof as  
11 may be necessary, is appropriated from the General Revenue Fund  
12 to the Legislative Printing Unit to meet its operational  
13 expenses for the fiscal year beginning July 1, 2024.

14 Section 55. The sum of \$4,365,360, or so much thereof as  
15 may be necessary, is appropriated from the General Revenue Fund  
16 to the Legislative Reference Bureau to meet its operational  
17 expenses for the fiscal year beginning July 1, 2024.

18 Section 99. Effective date. This Act takes effect July 1,  
19 2024.
