

103RD GENERAL ASSEMBLY State of Illinois 2023 and 2024 SB0106

Introduced 1/24/2023, by Sen. Doris Turner

SYNOPSIS AS INTRODUCED:

30 ILCS 500/45-110 new

Amends the Illinois Procurement Code. Provides that in awarding contracts for Abandoned Mined Land Reclamation Projects with a total value of more than \$100,000, preference shall be given to an otherwise qualified bidder who provides proof that at least 2 current employees of the bidder are former coal mine employees and that all such declared former coal mine employees in the bid shall be used in the fulfillment of an awarded Abandoned Mined Land Reclamation Project. Provides that when the Illinois Department of Natural Resources is to award a contract to the lowest responsible bidder, an otherwise qualified bidder who will fulfill the contract through the use of former coal mine employees may be given preference over other bidders unable to do so, if the bid is not more than 2% greater than the low bid.

1 AN ACT concerning finance.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Illinois Procurement Code is amended by adding Section 45-110 as follows:
- 6 (30 ILCS 500/45-110 new)
- 7 Sec. 45-110. Former coal mining employees.
- 8 (a) In this Section:
- 9 <u>"Abandoned Mined Land Reclamation Project" means</u>
 10 <u>construction or construction-related professional services</u>
 11 <u>that are used for reclamation projects awarded by the</u>
 12 <u>Department of Natural Resources under the Abandoned Mined</u>
- 13 Lands and Water Reclamation Act.
- "Former coal mine employee" means an individual who was

 previously employed in any capacity by a coal mining company

 in which the company engaged in the extraction of coal

 deposits or was previously employed in any capacity by a

 coal-fired power plant.
- 19 <u>(b) In awarding contracts for Abandoned Mined Land</u>
 20 <u>Reclamation Projects with a total value of more than \$100,000,</u>
 21 <u>preference shall be given to an otherwise qualified bidder who</u>
 22 <u>provides proof that at least 2 current employees of the bidder</u>
 23 are former coal mine employees and that all such declared

- 1 former coal mine employees in the bid shall be used in the 2 fulfillment of an awarded Abandoned Mined Land Reclamation 3 Project. If the Illinois Department of Natural Resources is to 4 award a contract to the lowest responsible bidder, an 5 otherwise qualified bidder who will fulfill the contract 6 through the use of former coal mine employees may be given 7 preference over other bidders unable to do so, if the bid is 8 not more than 2% greater than the low bid.
- 9 (c) This Section does not apply to any contract for any
 10 project for which federal funds are available for expenditure
 11 when its provisions may be in conflict with federal law or
 12 federal regulation.
