2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 1. Short title. This Act may be cited as the Wild
Animal Public Safety Act.

6 Section 5. Definitions. In this Act:

7 "Covered animal" means any live member of the following,8 or any hybrid of the following:

9 (1) Bear.

(2) Nonhuman primate.

"Direct contact" means physical contact or proximity where physical contact is possible, including, but not limited to, any proximity without a permanent physical barrier or sufficient vertical height designed to prevent physical contact between the public and a covered animal.

16 "Professional production crew" means a cast or crew member 17 of a television or motion picture production team that has 18 obtained permits as required by law, and includes a 19 professional photographer, videographer, or cinematographer.

1 with a covered animal.

2 Section 15. Nonapplication of Act. This Act does not 3 apply to direct contact between a covered animal and any of the 4 following:

5

(1) The owner of the covered animal.

6 (2) The owner of the facility in which the specified 7 animal is kept.

8 (3) A trained professional employee or contractor of 9 the owner of the covered animal or facility (or an 10 accompanying employee receiving professional training), 11 while acting in the course and scope of official duty.

(4) A licensed veterinarian, a veterinary student
accompanying such a veterinarian, or a registered
veterinary technician under the direct or indirect
supervision of a licensed veterinarian.

16 (5) A law enforcement officer or animal control
 17 authority acting in the course and scope of official duty.

(6) An employee of a federal, State, or local agency,
while acting in the course and scope of the person's
official duty.

(7) A board member of the facility where the animal is
 kept, a trainee, service provider, or professional
 production crew which:

(B) is performing work with the specified animal
 away from public view; and

3 (C) is under a contract or other engagement with4 the facility's owner.

5 Section 20. Penalty. Any person who violates the 6 provisions of this Act is guilty of a Class B misdemeanor.

7 Section 25. Enforcement. Any law enforcement officer or 8 peace officer employed by this State or by any county or 9 municipality within this State may enforce the provisions of 10 this Act. The Attorney General, or a State's Attorney of the 11 county in which a violation of this Act occurred, may bring an action in the name of the People of the State of Illinois to 12 enforce the provisions of this Act, and may bring an action for 13 14 an injunction to restrain any actual or threatened violation.

Section 97. Severability. The provisions of this Act are severable under Section 1.31 of the Statute on Statutes.
