1 AMENDMENT TO SENATE BILL 2100

2 AMENDMENT NO. _____. Amend Senate Bill 2100, AS AMENDED,
3 by replacing everything after the enacting clause with the
4 following:

5 "Section 5. The Illinois Pension Code is amended by
6 changing Sections 22B-115 and 22B-116 as follows:

7 (40 ILCS 5/22B-115)

8 Sec. 22B-115. Board of Trustees of the Fund.

9 (a) No later than one month after the effective date of
10 this amendatory Act of the 101st General Assembly or as soon
11 thereafter as may be practicable, the Governor shall appoint,
12 by and with the advice and consent of the Senate, a transition
13 board of trustees consisting of 9 members as follows:

14 (1) three members representing municipalities who are
15 mayors, presidents, chief executive officers, chief
16 financial officers, or other officers, executives, or

1 department heads of municipalities and appointed from
2 among candidates recommended by the Illinois Municipal
3 League;

4 (2) three members representing participants and who
5 are participants, 2 of whom shall be appointed from among
6 candidates recommended by a statewide fraternal
7 organization representing more than 20,000 active and
8 retired police officers in the State of Illinois, and one
9 of whom shall be appointed from among candidates
10 recommended by a benevolent association representing sworn
11 police officers in the State of Illinois;

12 (3) two members representing beneficiaries and who are
13 beneficiaries, one of whom shall be appointed from among
14 candidates recommended by a statewide fraternal
15 organization representing more than 20,000 active and
16 retired police officers in the State of Illinois, and one
17 of whom shall be appointed from among candidates
18 recommended by a benevolent association representing sworn
19 police officers in the State of Illinois; and

20 (4) one member who is a representative of the Illinois
21 Municipal League.

22 The transition board members shall serve until the initial
23 permanent board members are elected and qualified.

24 The transition board of trustees shall select the
25 chairperson of the transition board of trustees from among the
26 trustees for the duration of the transition board's tenure.

1 (b) The permanent board of trustees shall consist of 9
2 members as follows:

3 (1) Three members who are mayors, presidents, chief
4 executive officers, chief financial officers, or other
5 officers, executives, or department heads of
6 municipalities that have participating pension funds and
7 are elected by the mayors and presidents of municipalities
8 that have participating pension funds.

9 (2) Three members who are participants of
10 participating pension funds and are elected by the
11 participants of participating pension funds.

12 (3) Two members who are beneficiaries of participating
13 pension funds and are elected by the beneficiaries of
14 participating pension funds.

15 (4) One member recommended by the Illinois Municipal
16 League who shall be appointed by the Governor with the
17 advice and consent of the Senate.

18 The permanent board of trustees shall select the
19 chairperson of the permanent board of trustees from among the
20 trustees for a term of 2 years. The holder of the office of
21 chairperson shall alternate between a person elected or
22 appointed under item (1) or (4) of this subsection (b) and a
23 person elected under item (2) or (3) of this subsection (b).

24 (c) Each trustee shall qualify by taking an oath of office
25 before the Secretary of State or the legal counsel of the fund
26 stating that he or she will diligently and honestly administer

1 the affairs of the board and will not violate or knowingly
2 permit the violation of any provision of this Article.

3 (d) Trustees shall receive no salary for service on the
4 board but shall be reimbursed for travel expenses incurred
5 while on business for the board according to Article 1 of this
6 Code and rules adopted by the board ~~the standards in effect for~~
7 ~~members of the Commission on Government Forecasting and~~
8 ~~Accountability.~~

9 A municipality employing a police officer who is an
10 elected or appointed trustee of the board must allow
11 reasonable time off with compensation for the police officer
12 to conduct official business related to his or her position on
13 the board, including time for travel. The board shall notify
14 the municipality in advance of the dates, times, and locations
15 of this official business. The Fund shall timely reimburse the
16 municipality for the reasonable costs incurred that are due to
17 the police officer's absence.

18 (e) No trustee shall have any interest in any brokerage
19 fee, commission, or other profit or gain arising out of any
20 investment directed by the board. This subsection does not
21 preclude ownership by any member of any minority interest in
22 any common stock or any corporate obligation in which an
23 investment is directed by the board.

24 (f) Notwithstanding any provision or interpretation of law
25 to the contrary, any member of the transition board may also be
26 elected or appointed as a member of the permanent board.

1 Notwithstanding any provision or interpretation of law to
2 the contrary, any trustee of a fund established under Article
3 3 of this Code may also be appointed as a member of the
4 transition board or elected or appointed as a member of the
5 permanent board.

6 The restriction in Section 3.1 of the Lobbyist
7 Registration Act shall not apply to a member of the transition
8 board appointed pursuant to item (4) of subsection (a) or to a
9 member of the permanent board appointed pursuant to item (4)
10 of subsection (b).

13 Sec. 22B-116. Conduct and administration of elections;
14 terms of office.

15 (a) For the election of the permanent trustees, the
16 transition board shall administer the initial elections and
17 the permanent board shall administer all subsequent elections.
18 Each board shall develop and implement such procedures as it
19 determines to be appropriate for the conduct of such
20 elections. For the purposes of obtaining information necessary
21 to conduct elections under this Section, participating pension
22 funds shall cooperate with the Fund.

23 (b) All nominations for election shall be by petition.
24 Each petition for a trustee shall be executed as follows:

25 (1) for trustees to be elected by the mayors and

1 presidents of municipalities that have participating
2 pension funds, by at least 20 such mayors and presidents;

3 (2) for trustees to be elected by participants, by at
4 least 400 participants; and

5 (3) for trustees to be elected by beneficiaries, by at
6 least 100 beneficiaries.

7 (c) A separate ballot shall be used for each class of
8 trustee. The board shall prepare and send ballots and ballot
9 envelopes to the participants and beneficiaries eligible to
10 vote in accordance with rules adopted by the board. The
11 ballots shall contain the names of all candidates in
12 alphabetical order. The ballot envelope shall have on the
13 outside a form of certificate stating that the person voting
14 the ballot is a participant or beneficiary entitled to vote.

15 Participants and beneficiaries, upon receipt of the
16 ballot, shall vote the ballot and place it in the ballot
17 envelope, seal the envelope, execute the certificate thereon,
18 and return the ballot to the Fund.

19 The board shall set a final date for ballot return, and
20 ballots received prior to that date in a ballot envelope with a
21 properly executed certificate and properly voted shall be
22 valid ballots.

23 The board shall set a day for counting the ballots and name
24 judges and clerks of election to conduct the count of ballots
25 and shall make any rules necessary for the conduct of the
26 count.

1 The candidate or candidates receiving the highest number
2 of votes for each class of trustee shall be elected. In the
3 case of a tie vote, the winner shall be determined in
4 accordance with procedures developed by the Department of
5 Insurance.

6 In lieu of conducting elections via mail balloting as
7 described in this Section, the board may instead adopt rules
8 to provide for elections to be carried out solely via Internet
9 balloting or phone balloting. Nothing in this Section
10 prohibits the Fund from contracting with a third party to
11 administer the election in accordance with this Section.

12 (d) At any election, voting shall be as follows:

13 (1) Each person authorized to vote for an elected
14 trustee may cast one vote for each related position for
15 which such person is entitled to vote and may cast such
16 vote for any candidate or candidates on the ballot for
17 such trustee position.

18 (2) If only one candidate for each position is
19 properly nominated in petitions received, that candidate
20 shall be deemed the winner and no election under this
21 Section shall be required.

22 (3) The results shall be entered in the minutes of the
23 first meeting of the board following the tally of votes.

24 (e) The initial election for permanent trustees shall be
25 held and the permanent board shall be seated no later than 12
26 months after the effective date of this amendatory Act of the

1 101st General Assembly. Each subsequent election shall be held
2 no later than 30 days prior to the end of the term of the
3 incumbent trustees.

4 (f) The elected trustees shall each serve for terms of 4
5 years commencing on the first business day of the first month
6 after election; except that the terms of office of the
7 initially elected trustees shall be as follows:

8 (1) one trustee elected pursuant to item (1) of
9 subsection (b) of Section 22B-115 shall serve for a term
10 of 2 years and 2 trustees elected pursuant to item (1) of
11 subsection (b) of Section 22B-115 shall serve for a term
12 of 4 years;

13 (2) two trustees elected pursuant to item (2) of
14 subsection (b) of Section 22B-115 shall serve for a term
15 of 2 years and one trustee elected pursuant to item (2) of
16 subsection (b) of Section 22B-115 shall serve for a term
17 of 4 years; and

18 (3) one trustee elected pursuant to item (3) of
19 subsection (b) of Section 22B-115 shall serve for a term
20 of 2 years and one trustee elected pursuant to item (3) of
21 subsection (b) of Section 22B-115 shall serve for a term
22 of 4 years.

23 (g) The trustee appointed pursuant to item (4) of
24 subsection (b) of Section 22B-115 shall serve for a term of 2
25 years commencing on the first business day of the first month
26 after the election of the elected trustees.

1 (h) A member of the board who was elected pursuant to item
2 (1) of subsection (b) of Section 22B-115 who ceases to serve as
3 a mayor, president, chief executive officer, chief financial
4 officer, or other officer, executive, or department head of a
5 municipality that has a participating pension fund shall not
6 be eligible to serve as a member of the board and his or her
7 position shall be deemed vacant. A member of the board who was
8 elected by the participants of participating pension funds who
9 ceases to be a participant may serve the remainder of his or
10 her elected term.

11 For a vacancy of a trustee under item (1) of subsection (b)
12 of Section 22B-115, the vacancy shall be filled by appointment
13 by the board for the unexpired term from a list of candidates
14 recommended by the trustees under item (1) of subsection (b)
15 of Section 22B-115. The list of candidates shall be compiled
16 and presented to the board by the executive director of the
17 Fund.

18 For a vacancy of a trustee under item (2) of subsection (b)
19 of Section 22B-115, the vacancy shall be filled by appointment
20 by the board for the unexpired term from a list of candidates
21 recommended by the trustees under item (2) of subsection (b)
22 of Section 22B-115. The list of candidates shall be compiled
23 and presented to the board by the executive director of the
24 Fund.

25 For a vacancy of a trustee under item (3) of subsection (b)
26 of Section 22B-115, the vacancy shall be filled by appointment

1 by the board for the unexpired term from a list of candidates
2 recommended by the trustees under item (3) of subsection (b)
3 of Section 22B-115. The list of candidates shall be compiled
4 and presented to the board by the executive director of the
5 Fund.

6 A trustee appointed to fill the vacancy of an elected
7 trustee shall serve until a successor is elected. Special
8 elections to fill the remainder of an unexpired term vacated
9 by an elected trustee shall be held concurrently with and in
10 the same manner as the next regular election for an elected
11 trustee position.

12 ~~For a vacancy of an elected trustee occurring with an~~
13 ~~unexpired term of 6 months or more, an election shall be~~
14 ~~conducted for the vacancy in accordance with Section 22B 115~~
15 ~~and this Section.~~

16 ~~For a vacancy of an elected trustee occurring with an~~
17 ~~unexpired term of less than 6 months, the vacancy shall be~~
18 ~~filled by appointment by the board for the unexpired term as~~
19 ~~follows: a vacancy of a member elected pursuant to item (1) of~~
20 ~~subsection (b) of Section 22B-115 shall be filled by a mayor,~~
21 ~~president, chief executive officer, chief financial officer,~~
22 ~~or other officer, executive, or department head of a~~
23 ~~municipality that has a participating pension fund; a vacancy~~
24 ~~of a member elected pursuant to item (2) of subsection (b) of~~
25 ~~Section 22B 115 shall be filled by a participant of a~~

3 Vacancies among the appointed trustees shall be filled for
4 unexpired terms by appointment in like manner as for the
5 original appointments.
