Makes appropriations for the ordinary and contingent expenses of the Board of Trustees of the University of Illinois for the fiscal year beginning July 1, 2023, as follows:

General Funds	\$697,055,100
Other State Funds	\$ 11,936,202
Federal Funds	\$ 595,835
Total	<u>\$709,587,137</u>

A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The amount of \$632,000,400, or so much thereof  
6 as may be necessary, is appropriated from the Education  
7 Assistance Fund to the Board of Trustees of the University of  
8 Illinois to meet its operational expenses for the fiscal year  
9 ending June 30, 2024.

10 Section 10. The following named amounts, or so much thereof  
11 as may be necessary, are appropriated from the Education  
12 Assistance Fund to the Board of Trustees of the University of  
13 Illinois for Labor and Employment Relations:

14	For degree programs .....	704,300
15	For certificate programs .....	<u>915,600</u>
16	Total	\$1,619,900

17 Section 15. The sum of \$15,173,200, or so much thereof as  
18 may be necessary, is appropriated from the General Revenue Fund  
19 to the Board of Trustees of the University of Illinois for  
20 costs and expenses related to or in support of the Prairie

1 Research Institute, in accordance with Public Act 95-0728.

2 Section 20. The sum of \$40,380,600, or so much thereof as  
3 may be necessary, is appropriated from the General Revenue Fund  
4 to the Board of Trustees of the University of Illinois for  
5 operating costs and expenses related to or in support of the  
6 University of Illinois Hospital.

7 Section 25. The sum of \$716,300, or so much thereof as may  
8 be necessary, is appropriated from the Education Assistance  
9 Fund to the Board of Trustees of the University of Illinois for  
10 costs associated with the Hispanic Center for Excellence at the  
11 Chicago campus.

12 Section 30. The sum of \$283,500, or so much thereof as may  
13 be necessary, is appropriated from the Education Assistance  
14 Fund to the Board of Trustees of the University of Illinois for  
15 Dixon Springs Agricultural Center.

16 Section 35. The sum of \$1,079,000, or so much thereof as  
17 may be necessary, is appropriated from the Education Assistance  
18 Fund to the Board of Trustees of the University of Illinois for  
19 costs associated with the Public Policy Institute at the  
20 Chicago campus.

1           Section 40. The sum of \$302,200, or so much thereof as may  
2 be necessary, is appropriated from the Education Assistance  
3 Fund to the Board of Trustees of the University of Illinois for  
4 a grant to the College of Dentistry.

5           Section 45. The amount of \$500,000, or so much thereof as  
6 may be necessary, is appropriated from the General Revenue Fund  
7 to the Board of Trustees of the University of Illinois for  
8 costs associated with the Illinois Heart Rescue.

9           Section 46. The sum of \$3,000,000, or so much thereof as  
10 may be necessary, is appropriated to the University of Illinois  
11 from the General Revenue Fund for a grant to the University of  
12 Illinois at Springfield for the Illinois Innocence Project, and  
13 any associated administrative expenses.

14          Section 50. The sum of \$5,671,200, or so much thereof as may  
15 be necessary, is appropriated from the Fire Prevention Fund to  
16 the Board of Trustees of the University of Illinois for the  
17 purpose of maintaining the Illinois Fire Service Institute,  
18 paying the Institute's expenses, and providing the facilities  
19 and structures incident thereto, including payment to the  
20 University for personal services and related costs incurred.

21          Section 55. The sum of \$250,000, or so much thereof as may

1 be necessary, is appropriated from the State College and  
2 University Trust Fund to the Board of Trustees of the University  
3 of Illinois for scholarship grant awards.

4 Section 60. The sum of \$250,000 or so much thereof as may  
5 be necessary, is appropriated from the Pet Population Control  
6 Fund to the University of Illinois for costs associated with  
7 pet population control at the College of Veterinary Medicine.

8 Section 65. The sum of \$300,000, or so much thereof as may  
9 be necessary, is appropriated from the Emergency Public Health  
10 Fund to the University of Illinois for costs and expenses  
11 related to or in support of Emergency Mosquito Abatement.

12 Section 70. The sum of \$400,000, or so much thereof as may  
13 be necessary, is appropriated from the Used Tire Management  
14 Fund to the University of Illinois for costs and expenses  
15 related to or in support of mosquito research and abatement.

16 Section 75. The sum of \$500,000, or so much thereof as may  
17 be necessary, is appropriated from the Hazardous Waste Research  
18 Fund to the University of Illinois for its ordinary and  
19 contingent expenses.

20 Section 80. The sum of \$500,000, or so much thereof as may

1 be necessary, is appropriated from the General Professions  
2 Dedicated Fund to the Board of Trustees of the University of  
3 Illinois for costs associated with the development, support or  
4 administration of pharmacy practice education or training  
5 programs for the College of Medicine at Rockford.

6 Section 85. The sum of \$65,002, or so much thereof as may  
7 be necessary and remains unexpended at the close of business  
8 on June 30, 2023, from an appropriation heretofore made for  
9 such purpose in Article 133, Section 90 of Public Act 102-0698,  
10 as amended, is reappropriated, from the Coal Technology  
11 Development Assistance Fund to the University of Illinois for  
12 the Prairie Research Institute for costs associated with  
13 conducting the carbon capture, utilization, and storage study.

14 Section 90. The sum of \$4,000,000, or so much thereof as  
15 may be necessary, is appropriated from the Coal Technology  
16 Development Assistance Fund to the University of Illinois for  
17 the Prairie Research Institute for costs associated with carbon  
18 dioxide capture technology at a coal-fired power plant, and  
19 other projects in consultation with the United States  
20 Department of Energy.

21 Section 95. The sum of \$2,000,000 or so much thereof as may  
22 be necessary, is appropriated from the General Revenue Fund to

1 the Board of trustees of the University of Illinois for the  
2 University's Climate Jobs Institute.

3 ARTICLE 2

4 Section 5. The sum of \$595,835, or so much thereof as may  
5 be necessary and remains unexpended at the close of business  
6 on June 30, 2023, from an appropriation heretofore made for  
7 such purpose in Article 138, Section 390 of Public Act 102-  
8 0698, as amended, is reappropriated from the State Coronavirus  
9 Urgent Remediation Emergency Fund to the Board of Trustees of  
10 the University of Illinois for costs associated with the water  
11 rates report under Section 115 of the University of Illinois  
12 Act for purposes permitted by Section 9901 of the American  
13 Rescue Plan Act of 2021 and related federal guidance. No  
14 contract shall be entered into or obligation incurred for water  
15 rates report from appropriations made in this section until  
16 after the purpose and amounts have been approved in writing by  
17 the Governor.

18 Section 99. Effective date. This Act takes effect July 1,  
19 2023.
