Section 30. The sum of \$6,000,000, or so much thereof as may be necessary, is appropriated from the Insurance Financial Regulation Fund to the Department of Insurance for costs associated with the establishment, administration operations of the Workers' Compensation Fraud Unit Information Technology System.

Section 35. The sum of \$100,000, or so much thereof as may be necessary, is appropriated from the George Bailey Memorial Fund to the Department of Insurance for grants and expenses

- Section 60. The sum of \$10,000,000, or so much thereof as
- may be necessary, is appropriated from the Illinois Health
- Benefits Exchange Fund to the Department of Insurance for costs
- 17 associated with implementation of a healthcare feasibility
- 18 study recommendation.
- 19 Section 99. Effective date. This Act takes effect July 1,
- 20 2023.
