1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much thereof
6 as may be necessary, respectively, for the objects and purposes
7 hereinafter named, are appropriated from the Insurance Producer
8 Administration Fund to the Department of Insurance:

3 Section 10. The sum of \$4,335,000, or so much thereof as
 4 may be necessary, is appropriated from the Insurance Producer
 5 Administration Fund to the Department of Insurance for costs
 6 and expenses related to or in support of Get Covered Illinois.

7 Section 15. The sum of \$5,000,000, or so much thereof as
 8 may be necessary, is appropriated from the Insurance Producer
 9 Administration Fund to the Department of Insurance for costs
 10 and expenses related to or in support of the agency's
 11 operations.

12 Section 20. The following named amounts, or so much thereof
 13 as may be necessary, respectively, for the objects and purposes
 14 hereinafter named, are appropriated from the Insurance
 15 Financial Regulation Fund to the Department of Insurance:

10 Section 25. The sum of \$2,350,000, or so much thereof as
 11 may be necessary, is appropriated from the Insurance Financial
 12 Regulation Fund to the Department of Insurance for costs and
 13 expenses related to or in support of the agency's operations.

14 Section 30. The sum of \$6,000,000, or so much thereof as
 15 may be necessary, is appropriated from the Insurance Financial
 16 Regulation Fund to the Department of Insurance for costs
 17 associated with the establishment, administration and
 18 operations of the Workers' Compensation Fraud Unit Information
 19 Technology System.

20 Section 35. The sum of \$100,000, or so much thereof as may
 21 be necessary, is appropriated from the George Bailey Memorial
 22 Fund to the Department of Insurance for grants and expenses

1 related to or in support of the George Bailey Memorial Program.

2 Section 40. The following named amounts, or so much thereof
3 as may be necessary, respectively, for the objects and purposes
4 hereinafter named, are appropriated from the Public Pension
5 Regulation Fund to the Department of Insurance:

19 Section 45. The sum of \$2,600,000, or so much thereof as
20 may be necessary, is appropriated from the Public Pension
21 Regulation Fund to the Department of Insurance for costs and
22 expenses related to or in support of the agency's operations.

1 Section 50. The sum of \$3,200,000, or so much thereof as
2 may be necessary, is appropriated from the Illinois Workers'
3 Compensation Commission Operations Fund to the Department of
4 Insurance for costs associated with the administration and
5 operations of the Insurance Fraud Division of the Illinois
6 Workers' Compensation Commission's Anti-Fraud Program.

7 Section 55. The sum of \$2,000,000, or so much thereof as
8 may be necessary, is appropriated from the Parity Advancement
9 Fund to the Illinois Department of Insurance for costs and
10 expenses related to or in support of parity compliance
11 advocacy, consumer education, and any other initiatives that
12 support parity implementation and enforcement on behalf of
13 consumers.

14 Section 60. The sum of \$10,000,000, or so much thereof as
15 may be necessary, is appropriated from the Illinois Health
16 Benefits Exchange Fund to the Department of Insurance for costs
17 associated with implementation of a healthcare feasibility
18 study recommendation.

19 Section 99. Effective date. This Act takes effect July 1,
20 2023.
