A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much thereof
6 as may be necessary, respectively, are appropriated to the
7 Illinois State Police for the following purposes:

8 DIVISION OF JUSTICE SERVICES

9 Payable from General Revenue Fund:

10	For New Forensic Lab Expenses	0

14 Payable from the State Police Wireless

5 Section 10. The sum of \$4,000,000, or so much thereof as
 6 may be necessary, is appropriated from the State Asset
 7 Forfeiture Fund to the Illinois State Police for payment of
 8 their expenditures as outlined in the Illinois Drug Asset
 9 Forfeiture Procedure Act, the Cannabis Control Act, the
 10 Controlled Substances Act and the Environmental Safety Act.

11 Section 15. The sum of \$2,500,000, or so much thereof as
 12 may be necessary, is appropriated from the Federal Asset
 13 Forfeiture Fund to the Illinois State Police for payment of
 14 their expenditures in accordance with the Federal Equitable
 15 Sharing Guidelines.

16 Section 20. The sum of \$2,000,000, or so much thereof as
 17 may be necessary, is appropriated to the Illinois State Police,
 18 Division of Justice Services, from the Money Laundering Asset
 19 Recovery Fund for the ordinary and contingent expenses incurred
 20 by the Illinois State Police.

21 Section 25. The sum of \$1,000,000, or so much thereof as

1 may be necessary, is appropriated from the LEADS Maintenance
 2 Fund to the Illinois State Police, Division of Justice
 3 Services, for expenses related to the LEADS System.

4 Section 30. The following named amounts, or so much thereof
 5 as may be necessary, respectively, are appropriated to the
 6 Illinois State Police for the following purposes:

4 Section 35. The following amount, or so much thereof as
 5 may be necessary for objects and purposes hereinafter named,
 6 is appropriated from the Drug Traffic Prevention Fund to the
 7 Illinois State Police, Division of Operations, pursuant to the
 8 provisions of the "Intergovernmental Drug Laws Enforcement Act"
 9 for Grants to Metropolitan Enforcement Groups.

10 For Grants to Metropolitan Enforcement Groups:

11 Payable from the Drug Traffic
 12 Prevention Fund500,000

13 Section 40. The sum of \$18,000,000, or so much thereof as
 14 may be necessary, is appropriated from the State Police
 15 Whistleblower Reward and Protection Fund to the Illinois State
 16 Police for payment of their expenditures for state law
 17 enforcement purposes in accordance with the State Whistleblower
 18 Protection Act.

19 Section 45. The sum of \$43,000,000, or so much thereof as
 20 may be necessary, is appropriated from the State Police
 21 Operations Assistance Fund to the Illinois State Police for the
 22 ordinary and contingent expenses incurred by the Illinois State

1 Police.

2 Section 47. The sum of \$2,000,000, or so much thereof as
3 may be necessary, is appropriated from the State Police
4 Operations Assistance Fund to the Illinois State Police for the
5 ordinary and contingent expenses of the Safe2Help Program.

6 Section 50. The sum of \$100,000, or so much thereof as may
7 be necessary, is appropriated from the Medicaid Fraud and Abuse
8 Prevention Fund to the Illinois State Police, Division of
9 Operations, for the detection, investigation or prosecution of
10 recipient or vendor fraud.

11 Section 55. The sum of \$13,000,000, or so much thereof as
12 may be necessary, is appropriated from the State Police Law
13 Enforcement Administration Fund to the Illinois State Police,
14 Division of Operations, for all costs associated with a cadet
15 program for the Illinois State Police.

16 Section 60. The sum of \$2,000,000, or so much thereof as
17 may be necessary, is appropriated from the Scott's Law Fund to
18 the Illinois State Police for the ordinary and contingent
19 expenses incurred by the Illinois State Police.

20 Section 65. The sum of \$40,000,000, or so much thereof as

1 may be necessary, is appropriated from the Illinois State
 2 Police Federal Projects Fund to the Illinois State Police for
 3 current and prior year expenses relating to federal awards and
 4 grants.

5 Section 70. The sum of \$6,000,000, or so much thereof as
 6 may be necessary, is appropriated from the State Police
 7 Training and Academy Fund to the Illinois State Police for
 8 expenses related to State Police Training.

9 Section 75. The following named amounts, or so much thereof
 10 as may be necessary, respectively, are appropriated to the
 11 Illinois State Police for the following purposes:

10 Section 80. The sum of \$2,250,000, or so much thereof as
 11 may be necessary, is appropriated to the Illinois State Police,
 12 Division of Forensic Services and Identification, from the
 13 Mental Health Reporting Fund for expenses as outlined in the
 14 Firearm Concealed Carry Act and the Firearm Owners
 15 Identification Card Act.

16 Section 85. The sum of \$29,000,000, or so much thereof as
 17 may be necessary, is appropriated to the Illinois State Police
 18 from the State Police Firearm Services Fund for expenses as
 19 outlined in the Firearm Concealed Carry Act and the Firearm
 20 Owners Identification Card Act.

21 Section 90. The sum of \$500,000, or so much thereof as may
 22 be necessary, is appropriated to the Illinois State Police from

1 the Illinois State Police Firearm Services Fund to provide
2 logistical and administrative assistance to the Firearm Owner's
3 Identification Card Review Board.

4 Section 95. The sum of \$230,000,000, or so much thereof
5 as may be necessary, is appropriated from the Statewide 9-1-1
6 Fund to the Illinois State Police, Division of Justice
7 Services, for costs pursuant to the Emergency Telephone System
8 Act.

9 Section 100. The sum of \$2,000,000, or so much thereof as
10 may be necessary, is appropriated from the State Police
11 Revocation Enforcement Fund to the Illinois State Police, for
12 grants to law enforcement agency task forces for participating
13 in programs to help reduce crime

14 Section 105. The sum of \$1,300,000, or so much thereof as
15 may be necessary, is appropriated from the General Revenue Fund
16 to the Illinois State Police, for the ordinary and contingent
17 expenses of the Safe2Help Program.

18 Section 99. Effective date. This Act takes effect July 1,
19 2023.
