## 1 AMENDMENT TO SENATE BILL 3115 2 AMENDMENT NO. . Amend Senate Bill 3115 by replacing everything after the enacting clause with the following: 3 "Section 5. The Nursing Home Care Act is amended by 4 changing Sections 3-112, 3-113, and 3-114 as follows: 5 (210 ILCS 45/3-112) (from Ch. 111 1/2, par. 4153-112) 6 Sec. 3-112. (a) Whenever ownership of a facility is 7 8 transferred from the person named in the license to any other person, the transferee must obtain a new probationary license. 9 10 The transferee shall notify the Department of the transfer and apply for a new license at least 30 days prior to final 11 12 transfer. (b) The transferor shall notify the Department at least 30 13

days prior to final transfer. The transferor shall remain

responsible for the operation of the facility until such time

as a license is issued to the transferee.

1 (c) The transferee shall submit to the Department, at the 2 same time as notice to the Department of the transfer, a 3 transition plan signed by both the transferee and the 4 transferor that includes, at a minimum, a detailed explanation 5 of how resident care and appropriate staffing levels shall be maintained until the license has been obtained and the 6 transfer of the facility operations occurs and an explanation 7 8 of how resident care and appropriate staffing levels shall be 9 maintained after the license has been obtained and the 10 transfer of the facility operations occurs. The transition plan shall cover the time period of 10 days before the transfer 11 12 is to take place and 10 days after the transfer is complete. The transition plan shall be signed by the transferee and the 13 14 transferor. The transferee and the transferor shall coordinate 15 as necessary to ensure that there are no gaps in care, staffing, and safety during the transition period. 16 17 The Department shall approve or deny the transition plan within 15 days after submission. If the Department denies the 18 19 transition plan, the Department shall work with the transferee 20 and the transferor to bring the transition plan into compliance with this subsection. A denial of the transition 21 22 plan is not grounds for the Department to deny a change of 23 ownership application. (Source: P.A. 98-756, eff. 7-16-14.) 24

Sec. 3-113. (a) The license granted to the transferee shall be subject to the plan of correction submitted by the previous owner and approved by the Department and conditions contained in a conditional license issued to the previous owner. If there are outstanding violations and no approved plan of correction has been implemented, Department may issue a conditional license and plan of correction as provided in Sections 3-311 through 3-317. The license granted to a transferee for a facility that is in receivership shall be subject to any contractual obligations assumed by a grantee under the Equity in Long-term Care Quality Act and to the plan submitted by the receiver for continuing and increasing adherence to best practices in providing high-quality nursing home care, unless the grant is repaid, under conditions to be determined by rule by the Department in its administration of the Equity in Long-term Care Quality Act.

(b) Failure to follow the transition plan and ensure residents are provided adequate care after a change in ownership shall be considered a high-risk designation under subsection (9) of Section 3-305 by the Department if harm to a resident is found. The transferee is liable for all high-risk designation penalties assessed against the facility regarding the transition plan from the transfer of ownership to 10 days after the transfer is complete.

The transferor shall remain liable for all 2 3 penalties assessed against the facility which are imposed for 4 violations occurring prior to transfer of ownership. Failure to follow the transition plan and ensure residents are 5 provided adequate care before a change in ownership shall be 6 7 considered a high-risk designation under subsection (9) of 8 Section 3-305 by the Department if harm to a resident is found. 9 (Source: P.A. 81-223.)".
