 2 as may be necessary, is appropriated to the Office of the
 3 Secretary of State for any operations, alterations,
 4 rehabilitation, and nonrecurring repairs and maintenance of the
 5 interior and exterior of the various buildings and facilities
 6 under the jurisdiction of the Office of the Secretary of State,
 7 including sidewalks, terraces, and grounds and all labor,
 8 materials, and other costs incidental to the above work:

10 Section 15. The sum of \$3,000,000, or so much thereof as
 11 may be necessary, is appropriated from the Capital Development
 12 Fund to the Office of the Secretary of State for new
 13 construction and alterations, and maintenance of the interiors

 15 jurisdiction of the Office of the Secretary of State.

 10 such purposes, the sum of \$1,288,800, or so much thereof as may
 11 be necessary, is appropriated from the General Revenue Fund to
 12 the Office of the Secretary of State for a grant to the Chicago
 13 Public Library.

14 Section 85. The sum of \$0, or so much thereof as may be
 15 necessary, is appropriated from the General Revenue Fund to the
 16 Office of the Secretary of State for all expenditures and grants
 17 to libraries for the Project Next Generation Program.

18 Section 90. The following named sum, or so much thereof as
 19 may be necessary, is appropriated to the Office of the Secretary
 20 of State from the General Revenue Fund for the purpose of
 21 promotion of organ and tissue donations:

2 Section 95. The sum of \$50,000, or so much thereof as may
3 be necessary, is appropriated from the Secretary of State

7 be necessary, is appropriated to the Office of the Secretary

9 Illinois Masonic Charities Fund, a not-for-profit corporation,
10 for charitable purposes.

11 Section 105. The sum of \$135,000, or so much thereof as may
12 be necessary, is appropriated to the Secretary of State from
13 the Illinois Pan Hellenic Trust Fund to provide grants for
14 charitable purposes sponsored by African-American fraternities
15 and sororities.

16 Section 110. The sum of \$28,000, or so much thereof as may
17 be necessary, is appropriated to the Secretary of State from
18 the Park District Youth Program Fund to provide grants for the
19 Illinois Association of Park Districts: After School
20 Programming.

1 Section 115. The sum of \$215,000, or so much thereof as may
 2 be necessary, is appropriated to the Secretary of State from
 3 the Illinois Route 66 Heritage Project Fund to provide grants
 4 for the development of tourism, education, preservation and
 5 promotion of Route 66.

6 Section 120. The sum of \$600,000, or so much thereof as may
 7 be necessary, is appropriated from the Police Memorial
 8 Committee Fund to the Office of the Secretary of State for
 9 grants to the Police Memorial Committee for maintaining a
 10 memorial statue, holding an annual memorial commemoration, and
 11 giving scholarships or grants to children and spouses of police
 12 officers killed in the line of duty.

13 Section 125. The following named sum, or so much thereof
 14 as may be necessary, respectively, are appropriated to the
 15 Office of the Secretary of State for such purposes in Section
 16 3-646 of the Illinois Vehicle Code, for grants to the Regional
 17 Organ Bank of Illinois and to Mid-America Transplant Services
 18 for the purpose of promotion of organ and tissue donation
 19 awareness. These amounts are in addition to any amounts
 20 otherwise appropriated to the Office of the Secretary of State:

22 Section 130. The sum of \$450,000, or so much thereof as may

1 be necessary, is appropriated to the Secretary of State from
2 the Chicago Police Memorial Foundation Fund for grants to the
3 Chicago Police Memorial Foundation for maintenance of a
4 memorial and park, holding an annual memorial commemoration,
5 giving scholarships to children of police officers killed or
6 catastrophically injured in the line of duty, providing
7 financial assistance to police officers and their families when
8 a police officer is killed or injured in the line of duty, and
9 paying the insurance premiums for police officers who are
10 terminally ill.

11 Section 135. The sum of \$155,000, or so much thereof as may
12 be necessary, is appropriated to the Secretary of State from
13 the U.S. Marine Corps Scholarship Fund to provide grants per
14 Section 3-651 of the Illinois Vehicle Code.

15 Section 140. The sum of \$1,000,000, or so much thereof as
16 may be necessary, is appropriated from the SOS Federal Projects
17 Fund to the Office of the Secretary of State for the payment
18 of any operational expenses relating to the cost incident to
19 augmenting the Illinois Commercial Motor Vehicle safety program
20 by assuring and verifying the identity of drivers prior to
21 licensure, including CDL operators; for improved security for
22 Drivers Licenses and Personal Identification Cards; and any
23 other related program deemed appropriate by the Office of the

1 Secretary of State.

2 Section 145. The sum of \$1,500,000, or so much thereof as
3 may be necessary, is appropriated to the Office of the Secretary
4 of State from the Securities Investors Education Fund for any
5 expenses used to promote public awareness of the dangers of
6 securities fraud.

7 Section 150. The sum of \$200,000, or so much thereof as may
8 be necessary, is appropriated to the Office of the Secretary
9 of State from the Secretary of State Evidence Fund for the
10 purchase of evidence, for the employment of persons to obtain
11 evidence, and for the payment for any goods or services related
12 to obtaining evidence.

13 Section 155. The sum of \$225,000, or so much thereof as may
14 be necessary, is appropriated from the Electric Vehicle Rebate
15 Fund to the Office of Secretary of State for the cost of
16 administering the Electric Vehicle Rebate Act.

17 Section 160. The sum of \$200,000,000, or so much thereof
18 as may be necessary, is appropriated from the Secretary of
19 State Special Services Fund to the Office of the Secretary of
20 State for electronic data processing, for office automation and
21 technology, and for operating program expenses related to the

1 enforcement of administering laws related to vehicles and
2 transportation.

3 Section 165. The sum of \$20,000,000, or so much thereof as
4 may be necessary, is appropriated from the Motor Vehicle
5 License Plate Fund to the Office of the Secretary of State for
6 the cost incident to providing new or replacement plates for
7 motor vehicles.

8 Section 170. The sum of \$4,600,000, or so much thereof as
9 may be necessary, is appropriated from the Secretary of State
10 DUI Administration Fund to the Office of Secretary of State for
11 operation of the Department of Administrative Hearings of the
12 Office of Secretary of State and for no other purpose.

13 Section 175. The sum of \$0, or so much thereof as may be
14 necessary, is appropriated from the Secretary of State Police
15 DUI Fund to the Secretary of State for the payments of goods
16 and services that will assist in the prevention of alcohol-
17 related criminal violence throughout the State.

18 Section 180. The sum of \$1,000,000, or so much thereof as
19 may be necessary, is appropriated from the Secretary of State
20 Police Services Fund to the Secretary of State for purposes as
21 indicated by the grantor or contractor or, in the case of money

1 bequeathed or granted for no specific purpose, for any purpose
2 as deemed appropriate by the Director of the Secretary of State
3 Department of Police in administering the responsibilities of
4 the Secretary of State Department of Police.

5 Section 185. The sum of \$300,000, or so much thereof as may
6 be necessary, is appropriated from the Office of the Secretary
7 of State Grant Fund to the Office of the Secretary of State to
8 be expended in accordance with the terms and conditions upon
9 which such funds were received.

10 Section 190. The sum of \$24,300, or so much thereof as may
11 be necessary, is appropriated to the Office of the Secretary
12 of State from the State Library Fund to increase the collection
13 of books, records, and holdings; to hold public forums; to
14 purchase equipment and resource materials for the State
15 Library; and for the upkeep, repair, and maintenance of the
16 State Library building and grounds.

17 Section 195. The following sum, or so much thereof as may
18 be necessary, is appropriated to the Office of the Secretary
19 of State for any operations, alterations, rehabilitations, new
20 construction, and maintenance of the interior and exterior of
21 the various buildings and facilities under the jurisdiction of
22 the Secretary of State to enhance security measures in the

1 Capitol Complex:

2 From General Revenue Fund5,000,000

3 Section 200. The sum of \$50,000,000, or so much thereof
4 as may be necessary, is appropriated from the Secretary of
5 State Identification Security and Theft Prevention Fund to the
6 Office of Secretary of State for all costs related to
7 implementing identification security and theft prevention
8 measures.

9 Section 205. The sum of \$2,500,000, or so much thereof as
10 may be necessary, is appropriated to the Office of the Secretary
11 of State from the Driver Services Administration Fund for the
12 payment of costs related to the issuance of temporary visitor's
13 driver's licenses, and other operational costs, including
14 personnel, facilities, computer programming, and data
15 transmission.

16 Section 210. The sum of \$2,100,000, or so much thereof as
17 may be necessary, is appropriated from the Monitoring Device
18 Driving Permit Administration Fee Fund to the Office of the
19 Secretary of State for all Secretary of State costs associated
20 with administering Monitoring Device Driving Permits per Public
21 Act 95-0400.

1 Section 215. The sum of \$300,000, or so much thereof as
2 may be necessary, is appropriated from the Indigent BAIID Fund
3 to the Office of the Secretary of State to reimburse ignition
4 interlock device providers per Public Act 95-0400, including
5 reimbursements submitted in prior years.

6 Section 220. The sum of \$45,000,000, or so much thereof as
7 may be necessary, is appropriated to the Office of the Secretary
8 of State from the Vehicle Hijacking and Motor Vehicle Theft
9 Prevention and Insurance Verification Trust Fund for awards,
10 grants, and operational support to implement the Illinois
11 Vehicle Hijacking and Motor Vehicle Theft Prevention and
12 Insurance Verification Act, and for operational expenses of the
13 Office to implement the Act.

14 Section 225. The sum of \$50,000, or so much thereof as may
15 be necessary, is appropriated to the Secretary of State from
16 the Illinois Professional Golfers Association Junior Golf Fund
17 for grants to the Illinois Professional Golfers Association
18 Foundation to help Association members expose Illinois
19 youngsters to the game of golf.

20 Section 230. The sum of \$160,000, or so much thereof as
21 may be necessary, is appropriated to the Secretary of State
22 from the Agriculture in the Classroom Fund for grants to support

1 Agriculture in the Classroom programming for public and private
2 schools within Illinois.

3 Section 235. The sum of \$25,000, or so much thereof as may
4 be necessary, is appropriated to the Secretary of State from
5 the Boy Scout and Girl Scout Fund for grants to the Illinois
6 divisions of the Boy Scouts of America and the Girl Scouts of
7 the U.S.A.

8 Section 240. The sum of \$45,000, or so much thereof as may
9 be necessary, is appropriated to the Secretary of State from
10 the Support Our Troops Fund for grants to Illinois Support Our
11 Troops, Inc. for charitable assistance to the troops and their
12 families in accordance with its Articles of Incorporation.

13 Section 245. The sum of \$4,000, or so much thereof as may
14 be necessary, is appropriated to the Office of the Secretary
15 of State from the Rotary Club Fund for grants for charitable
16 purposes sponsored by the Rotary Club.

17 Section 250. The sum of \$13,000, or so much thereof as may
18 be necessary, is appropriated to the Office of the Secretary
19 of State from the Ovarian Cancer Awareness Fund for grants to
20 the National Ovarian Cancer Coalition, Inc. for ovarian cancer
21 research, education, screening, and treatment.

1 Section 255. The sum of \$6,000, or so much thereof as may
2 be necessary, is appropriated to the Office of the Secretary
3 of State from the Sheet Metal Workers International Association
4 of Illinois Fund for grants for charitable purposes sponsored
5 by Illinois chapters of the Sheet Metal Workers International
6 Association.

7 Section 260. The sum of \$120,000, or so much thereof as
8 may be necessary, is appropriated to the Office of the Secretary
9 of State from the Illinois Police Association Fund for
10 providing death benefits for the families of police officers
11 killed in the line of duty, and for providing scholarships, for
12 graduate study, undergraduate study, or both, to children and
13 spouses of police officers killed in the line of duty.

14 Section 265. The sum of \$8,000, or so much thereof as may
15 be necessary, is appropriated to the Secretary of State from
16 the International Brotherhood of Teamsters Fund for grants to
17 the Teamsters Joint Council 25 Charitable Trust for religious,
18 charitable, scientific, literary, and educational purposes.

19 Section 270. The sum of \$16,000, or so much thereof as may
20 be necessary, is appropriated to the Office of the Secretary
21 of State from the Fraternal Order of Police Fund for grants to

1 the Illinois Fraternal Order of Police to increase the
2 efficiency and professionalism of law enforcement officers in
3 Illinois, to educate the public about law enforcement issues,
4 to more firmly establish the public confidence in law
5 enforcement, to create partnerships with the public, and to
6 honor the service of law enforcement officers.

7 Section 275. The sum of \$35,000, or so much thereof as may
8 be necessary, is appropriated to the Secretary of State from
9 the Share the Road Fund for grants to the League of Illinois
10 Bicyclists, a not for profit corporation, for educational
11 programs instructing bicyclists and motorists how to legally
12 and more safely share the roadways.

13 Section 280. The sum of \$0, or so much thereof as may be
14 necessary, is appropriated to the Office of the Secretary of
15 State from the St. Jude Children's Research Fund for grants to
16 St. Jude Children's Research Hospital for pediatric treatment
17 and research.

18 Section 285. The sum of \$25,000, or so much thereof as may
19 be necessary, is appropriated to the Office of the Secretary
20 of State from the Ducks Unlimited Fund for grants to Ducks
21 Unlimited, Inc. to fund wetland protection, enhancement, and
22 restoration projects in the State of Illinois, to fund

1 education and outreach for media, volunteers, members, and the
2 general public regarding waterfowl and wetlands conservation
3 in the State of Illinois, and to cover reasonable cost for
4 Ducks Unlimited plate advertising and administration of the
5 wetland conservation projects and education program.

6 Section 290. The sum of \$200,000, or so much thereof as may
7 be necessary, is appropriated to the Secretary of State from
8 the Family Responsibility Fund for all costs associated with
9 enforcement of the Family Financial Responsibility Law.

10 Section 295. The sum of \$500,000, or so much thereof as may
11 be necessary, is appropriated to the Office of the Secretary
12 of State from the Illinois State Police Memorial Park Fund for
13 grants to the Illinois State Police Heritage Foundation, Inc.
14 for building and maintaining a memorial and park, holding an
15 annual memorial commemoration, giving scholarships to children
16 of State police officers killed or catastrophically injured in
17 the line of duty, and providing financial assistance to police
18 officers and their families when a police officer is killed
19 or injured in the line of duty.

20 Section 300. The sum of \$6,000, or so much thereof as may
21 be necessary, is appropriated to the Office of the Secretary
22 of State from the Illinois Sheriffs' Association Scholarship

1 and Training Fund for grants to the Illinois Sheriffs'
2 Association for scholarships obtained in a competitive process
3 to attend the Illinois Teen Institute or an accredited college
4 or university, for programs designed to benefit the elderly and
5 teens, and for law enforcement training.

6 Section 305. The sum of \$1,300,000, or so much thereof as
7 may be necessary, is appropriated to the Office of the Secretary
8 of State from the Alzheimer's Awareness Fund for grants to the
9 Alzheimer's Disease and Related Disorders Association, Greater
10 Illinois Chapter, for Alzheimer's care, support, education, and
11 awareness programs.

12 Section 310. The sum of \$40,000, or so much thereof as may
13 be necessary, is appropriated to the Office of the Secretary
14 of State from the Illinois Nurses Foundation Fund for grants
15 to the Illinois Nurses Foundation, to promote the health of the
16 public by advancing the nursing profession in this State.

17 Section 315. The sum of \$3,000, or so much thereof as may
18 be necessary, is appropriated to the Office of the Secretary
19 of State from the Hospice Fund for grants to a statewide
20 organization whose primary membership consists of hospice
21 programs.

1 Section 320. The sum of \$35,000, or so much thereof as may
2 be necessary, is appropriated to the Office of the Secretary
3 of State from the Octave Chanute Aerospace Heritage Fund for
4 grants to the Rantoul Historical Society and Museum, or any
5 other charitable foundation responsible for the former exhibits
6 and collections of the Chanute Air Museum, for operational and
7 program expenses of the Chanute Air Museum and any other
8 structure housing exhibits and collections of the Chanute Air
9 Museum.

10

11 Section 325. The sum of \$0, or so much thereof as may be
12 necessary, is appropriated from the Secretary of State Special
13 Services Fund to the Office of the Secretary of State for
14 operating program expenses related to the enforcement of
15 administering laws related to vehicles and transportation.

16 Section 330. The sum of \$2,500,000, or so much thereof as
17 may be necessary, is appropriated from the General Revenue Fund
18 to the Office of the Secretary of State for all Secretary of
19 State costs associated with the implementation of the
20 provisions of Article XIV of the Illinois Constitution,
21 including, without limitation, the duties under the
22 Constitutional Convention Act and the Illinois Constitutional
23 Amendment Act.

1 Section 335. The amount of \$150,000, or so much of this
2 amount as may be necessary, is appropriated from the General
3 Revenue Fund to the Office of the Secretary of State for
4 ordinary and contingent expenses of the Executive Inspector
5 General.

6 Section 340. The sum of \$0 or so much thereof as may be
7 necessary, is appropriated from the Guide Dogs of America Fund
8 to the Office of the Secretary of State for such purposes in
9 Section 3-699.14 of the Illinois Vehicle Code (625 ILCS 5).

10 Section 345. The sum of \$0, or so much thereof as may be
11 necessary, is appropriated from the Illinois EMS Memorial
12 Scholarship and Training Fund to the Office of the Secretary
13 of State for such purposes in Section 3-684 of the Illinois
14 Vehicle Code (625 ILCS 5).

15 Section 350. The amount of \$35,000,000, or so much thereof
16 as may be necessary, is appropriated to the Office of the
17 Secretary of State from the General Revenue Fund for deposit
18 into the Secretary of State Special Services Fund for
19 technology modernization and maintenance of information
20 technology systems and infrastructure and other costs.

21 Section 355. The amount of \$400,000, or so much thereof

1 as may be necessary, is appropriated from the Electronic
2 Notarization Fund to the Office of the Secretary of State to
3 fund the Department of Index's implementation and maintenance
4 of the electronic notarization commissions.

5 Section 99. Effective date. This Act takes effect July 1,
6 2024.
