Makes appropriations for the ordinary and contingent expenses of the Illinois Student Assistance Commission for the fiscal year beginning July 1, 2024, as follows:

A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The sum of \$7,840,000, or so much thereof as
6 may be necessary, is appropriated to the Illinois Student
7 Assistance Commission from the General Revenue Fund to meet its
8 operational expenses for the fiscal year ending June 30, 2025.

9 Section 10. The following named amount, or so much thereof
10 as may be necessary, is appropriated from the General Revenue
11 Fund to the Illinois Student Assistance Commission for the
12 following purpose:

13 To support outreach, research, and
14 training activities7,840,000

15 Section 15. The sum of \$446,566,200, or so much thereof
16 as may be necessary, is appropriated to the Illinois Student
17 Assistance Commission from the General Revenue Fund for grant
18 awards to students eligible for the Monetary Award Program, as
19 provided by law, and for agency administrative and operational
20 costs not to exceed 2 percent of the total appropriation for

1 the Monetary Award Program.

2 Section 20. The sum of \$265,000,000, or so much thereof
3 as may be necessary, is appropriated to the Illinois Student
4 Assistance Commission from the Education Assistance Fund for
5 grant awards to students eligible for the Monetary Award
6 Program, as provided by law.

7 Section 25. The sum of \$50,000,000, or so much thereof as
8 may be necessary, is appropriated to the Illinois Student
9 Assistance Commission from the General Revenue Fund for
10 payments to eligible public universities for grants to students
11 pursuant to the AIM HIGH program.

12 Section 30. The sum of \$150,000, or so much thereof as may
13 be necessary, is appropriated from the General Revenue Fund to
14 the Illinois Student Assistance Commission for costs associated
15 with providing grants to exonerated persons, as provided by
16 law.

17 Section 35. The sum of \$26,400, or so much thereof as may
18 be necessary, is appropriated from the Education Assistance
19 Fund to the Illinois Student Assistance Commission for costs
20 associated with the Veterans' Home Medical Providers' Loan
21 Repayment Program pursuant to Public Act 99-0813.

1 Section 40. The sum of \$500,000, or so much thereof as may
 2 be necessary, is appropriated from the Education Assistance
 3 Fund to the Illinois Student Assistance Commission for grants
 4 to eligible nurse educators to use for payment of their
 5 educational loan pursuant to Public Act 94-1020.

6 Section 45. The following named sums, or so much thereof
 7 as may be necessary, respectively, are appropriated from the
 8 Education Assistance Fund to the Illinois Student Assistance
 9 Commission for the following purposes:

10 Grants and Scholarships

11	For the payment of scholarships to students	
12	who are children of police officers or firefighters	
13	killed in the line of duty, or who are	
14	dependents of correctional officers killed	
15	or permanently disabled in the line of	
16	duty, as provided by law	1,300,000
17	For payment of Minority Teacher Scholarships	<u>8,000,000</u>
18	Total	\$9,300,000

19 Section 50. The sum of \$10,750,000, or so much thereof as
 20 may be necessary, is appropriated from the Education Assistance
 21 Fund to the Illinois Student Assistance Commission to the
 22 Golden Apple Scholars of Illinois program, as provided by law.

1 Section 55. The sum of \$5,000,000, or so much thereof as
2 may be necessary, is appropriated from the Education Assistance
3 Fund to the Illinois Student Assistance Commission to the
4 Golden Apple Scholars of Illinois program for the Golden Apple
5 Accelerators Program.

6 Section 60. The sum of \$975,000, or so much thereof as may
7 be necessary, is appropriated from the Education Assistance
8 Fund to the Illinois Student Assistance Commission for the Loan
9 Repayment for Teachers Program.

10

11 Section 65. The sum of \$300,000, or so much thereof as may
12 be necessary, is appropriated from the ISAC Accounts Receivable
13 Fund to the Illinois Student Assistance Commission for costs
14 associated with the collection of delinquent scholarship awards
15 pursuant to the Illinois State Collection Act of 1986.

16 Section 70. The sum of \$110,000, or so much thereof as may
17 be necessary, is appropriated to the Illinois Student
18 Assistance Commission from the University Grant Fund for
19 payment of grants for the Higher Education License Plate
20 Program, as provided by law.

21 Section 75. The following named sum, or so much thereof

1 as may be necessary, is appropriated from the Illinois Student
2 Assistance Commission Contracts and Grants Fund to the Illinois
3 Student Assistance Commission for the following purpose:

- 4 To support outreach, research, and
- 5 training activities5,000,000
- 6 Community Behavioral Health Care
- 7 Provider Loan Repayment Program5,000,000

8 Section 80. The following named sum, or so much thereof
9 as may be necessary, is appropriated from the Optometric
10 Licensing and Disciplinary Board Fund to the Illinois Student
11 Assistance Commission for the following purpose:

- 12 Grants and Scholarships
- 13 For payment of scholarships for the
- 14 Optometric Education Scholarship
- 15 Program, as provided by law50,000

16 Section 85. The following named sum, or so much thereof
17 as may be necessary, is appropriated from the National Guard
18 and Naval Militia Grant Fund to the Illinois Student Assistance
19 Commission for the following purpose:

- 20 Grants and Scholarships
- 21 For payment of Illinois National Guard and
- 22 Naval Militia Scholarships
- 23 at State-controlled universities

1 and public community colleges in
 2 Illinois to students eligible to
 3 receive such awards, as provided by law20,000

4 Section 90. The sum of \$100,000, or so much thereof as may
 5 be necessary, is appropriated from the Golden Apple Scholars
 6 of Illinois Fund to the Illinois Student Assistance Commission
 7 for the Golden Apple Scholars of Illinois Program, as provided
 8 by law.

9 Section 95. The following named sums, or so much thereof
 10 as may be necessary, respectively, are appropriated to the
 11 Illinois Student Assistance Commission from the Student Loan
 12 Operating Fund for its ordinary and contingent expenses:

- 13 For Administration
- 14 For Personal Services13,538,600
- 15 For State Contributions to State
- 16 Employees Retirement System7,312,600
- 17 For State Contributions to
- 18 Social Security1,029,000
- 19 For State Contributions for
- 20 Employees Group Insurance5,436,800
- 21 For Contractual Services8,374,300
- 22 For Travel311,000
- 23 For Commodities282,200

6 Section 100. The sum of \$1,000,000 or so much thereof as
7 may be necessary, is appropriated to the Illinois Student
8 Assistance Commission from the Student Loan Operating Fund for
9 costs associated with the Illinois Designated Account Purchase
10 Program.

12 Section 105. The following named sum, or so much thereof
13 as may be necessary, is appropriated from the Federal
14 Congressional Teacher Scholarship Program Fund to the Illinois
15 Student Assistance Commission for the following purpose:

16	For transferring repayment funds collected	
17	under the Paul Douglas Teacher Scholarship	
18	Program to the U.S. Treasury	100,000

19 Section 110. The sum of \$11,320,000, or so much thereof
20 as may be necessary, is appropriated from the Federal Student
21 Incentive Trust Fund to the Illinois Student Assistance
22 Commission for allowable uses of federal grant funds related
23 to college access, outreach, and training, including but not

1 limited to funds received under the federal Gaining Early
2 Awareness and Readiness for Undergraduate Program.

3 Section 115. The sum of \$300,000, or so much thereof as
4 may be necessary, is appropriated from the Federal Student
5 Incentive Trust Fund to the Illinois Student Assistance
6 Commission for the John R. Justice Student Loan Repayment
7 Program.

8 Section 120. The sum of \$5,000,000, or so much thereof as
9 may be necessary, is appropriated from the Education Assistance
10 Fund to the Illinois Student Assistance Commission for
11 financial assistance and administrative costs associated with
12 early childhood programs.

13 Section 125. The sum of \$4,000,000, or so much thereof as
14 may be necessary, is appropriated from the Nursing Dedicated
15 and Professional Fund to the Illinois Student Assistance
16 Commission for expenses related to the Nursing Education
17 Scholarship Law.

18 Section 130. The sum of \$1,100,000, or so much thereof as
19 may be necessary, is appropriated from the Energy Transition
20 Assistance Fund to the Illinois Student Assistance Commission
21 for costs associated with providing grants to eligible

1 individuals, for costs pursuant to the Energy Transition Act.

2 Section 135. The sum of \$6,000,000, or so much thereof as
3 may be necessary, is appropriated from the General Revenue Fund
4 to the Illinois Student Assistance Commission for costs
5 associated with Social Worker Scholarships and loan repayment
6 assistance.

7 Section 140. The sum of \$2,000,000, or so much of that
8 sum as may be necessary, is appropriated from the General
9 Revenue Fund to the Illinois Student Assistance Commission
10 for the IGROW Tech Scholarship Program.

11 Section 145. The sum of \$550,000, or so much thereof as
12 may be necessary, is appropriated from the General Revenue
13 Fund to the Illinois Student Assistance Commission for a
14 grant to the NDIGO Foundation to fund internships to train
15 students and youth in communications.

16 Section 150. The sum of \$250,000, or so much thereof as may
17 be necessary is appropriated from the Education Assistance Fund
18 to the Illinois Student Assistance Commission for costs
19 associated with the Human Services Loan Repayment program.

20 Section 155. The sum of \$2,500,000, or so much thereof as

1 may be necessary, is appropriated from the UNCF Scholarship
2 Fund to the Illinois Student Assistance Commission to grant
3 scholarships to public university and college students for
4 the United Negro College Fund scholarship program.

5 Section 160. The sum of \$2,500,000, or so much thereof as
6 may be necessary, is appropriated from the Illinois DREAM
7 Fund to the Illinois Student Assistance Commission to grant
8 scholarships to public university and college students for
9 the Illinois DREAM scholarship program.

ARTICLE 2

11 Section 5. The sum of \$200,000, or so much thereof as may
12 be necessary and remains unexpended at the close of business
13 on June 30, 2024, from appropriations heretofore made for such
14 purpose in Article 123, Section 505 of Public Act 103-0006 as
15 amended, is reappropriated from the State Coronavirus Urgent
16 Remediation Emergency Fund to the Illinois Student Assistance
17 Commission for the Golden Apple Scholars of Illinois Program,
18 including but not limited to, for purposes permitted by Section
19 9901 of the American Rescue Plan Act of 2021 and related federal
20 guidance, including prior years' costs.

21 Section 10. The sum of \$1,300,000, or so much thereof as

1 may be necessary and remains unexpended at the close of business
2 on June 30, 2024, from appropriations heretofore made for such
3 purpose in Article 123, Section 510 of Public Act 103-0006 as
4 amended, is reappropriated from the State Coronavirus Urgent
5 Remediation Emergency Fund to the Illinois Student Assistance
6 Commission for the Golden Apple Accelerators Program, including
7 but not limited to, for purposes permitted by Section 9901 of
8 the American Rescue Plan Act of 2021 and related federal
9 guidance, including prior years' costs.

10 Section 99. Effective date. This Act takes effect July 1,
11 2024.
