There is created a Debt 18 19 Collection Board consisting of the Director of Central 20 Management Services as chairman, the State Comptroller, and 21 the Attorney General, or their respective designees. 22 Board shall establish a centralized collections service to undertake further collection efforts on delinquent accounts 23 24 or claims of the State which have not been collected through the reasonable efforts of the respective State agencies. 25 26 The Board shall promulgate rules and regulations pursuant to the Illinois Administrative Procedure Act with regard to the 27 28 establishment of timetables and the assumption responsibility for agency accounts receivable that have not 29 30 been collected by the agency, are not subject to a current repayment plan, or have not been certified as uncollectible 31 as of the date specified by the Board. All contracts shall provide for a contingent fee based on the age, nature, amount and type of delinquent The Board may adopt a reasonable classification schedule for the various receivables. The contractor shall remit the amount collected, net of the contingent fee, to the respective State agency which shall deposit the net amount received into the fund that would have received the receipt had it been collected by the State agency. No portion of the collections shall be deposited into an Accounts Receivable Fund established under Section 6 of this Act. The Board shall act only upon the unanimous vote of its members.
