A restricted driving permit issued under Section shall be subject to cancellation, 3 4 revocation, and suspension by the Secretary of State in like manner and for like cause as a driver's license 5 issued under this Code may be cancelled, revoked, 6 suspended; except that a conviction upon one or more 7 8 offenses against laws or ordinances regulating 9 movement of traffic shall be deemed sufficient cause for the revocation, suspension, or cancellation of a 10 11 restricted driving permit. The Secretary of State may, as a condition to the issuance of a restricted driving 12 13 permit, require the applicant to participate in designated driver remedial or rehabilitative program. 14 Secretary of State is authorized to cancel a 15 16 restricted driving permit if the permit holder does not 17 successfully complete the program.

- (c-5) The Secretary of State may, as a condition of the reissuance of a driver's license or permit to an applicant whose driver's license or permit has been suspended before he or she reached the age of 18 years pursuant to any of the provisions of this Section, require the applicant participate in a driver remedial education course and be retested under Section 6-109 of this Code.
- 25 (d) This Section is subject to the provisions of the Drivers License Compact. 26
- The Secretary of State shall not issue a restricted 27 (e) driving permit to a person under the age of 16 years whose 28 driving privileges have been suspended or revoked under any 29 30 provisions of this Code.
