AN ACT concerning senior citizens and disabled persons.

Be it enacted by the People of the State of Illinois,represented in the General Assembly:

Section 5. The Senior Citizens and Disabled Persons
Property Tax Relief and Pharmaceutical Assistance Act is
amended by changing Section 4 as follows:

Sec. 4. Amount of Grant.

In general. Any individual 65 years or older or any 9 (a) individual who will become 65 years old during the calendar 10 year in which a claim is filed, and any surviving spouse of 11 such a claimant, who at the time of death received or was 12 13 entitled to receive a grant pursuant to this Section, which surviving spouse will become 65 years of age within the 24 14 15 months immediately following the death of the such claimant and which surviving spouse but for his or her age is 16 otherwise qualified to receive a grant pursuant to this 17 18 Section, and any disabled person whose annual household income is less than \$14,000 for grant years before the 1998 19 20 grant year, less than \$16,000 for the 1998 and 1999 grant years, and less than (i) \$21,218 for a household containing 21 22 one person, (ii) \$28,480 for a household containing 2 persons, or (iii) \$35,740 for a household containing 3 or 23 more persons for the 2000 grant year and thereafter and whose 24 household is liable for payment of property taxes accrued or 25 has paid rent constituting property taxes accrued and is 26 27 domiciled in this State at the time he or she files his or her claim is entitled to claim a grant under this Act. With 28 29 respect to claims filed by individuals who will become 65 years old during the calendar year in which a claim is filed, 30 31 the amount of any grant to which that household is entitled

1 shall be an amount equal to 1/12 of the amount to which the 2 claimant would otherwise be entitled as provided in this 3 Section, multiplied by the number of months in which the 4 claimant was 65 in the calendar year in which the claim is 5 filed.

(b) Limitation. Except as otherwise provided in 6 7 subsections (a) and (f) of this Section, the maximum amount 8 of grant which a claimant is entitled to claim is the amount 9 by which the property taxes accrued which were paid or payable during the last preceding tax 10 year or rent 11 constituting property taxes accrued upon the claimant's residence for the last preceding taxable year exceeds 3 1/2% 12 of the claimant's household income for that year but 13 in no event is the grant to exceed (i) \$700 less 4.5% of household 14 income for that year for those with a household income of 15 16 \$14,000 or less or (ii) \$70 if household income for that year is more than \$14,000. 17

Public aid recipients. If household income in one 18 (C) or more months during a year includes cash assistance in 19 excess of \$55 per month from the Department of Public Aid or 20 21 the Department of Human Services (acting as successor to the 22 Department of Public Aid under the Department of Human 23 Services Act) which was determined under regulations of that Department on a measure of need that included an allowance 24 25 for actual rent or property taxes paid by the recipient of that assistance, the amount of grant to which that household 26 is entitled, except as otherwise provided in subsection (a), 27 shall be the product of (1) the maximum amount computed as 28 specified in subsection (b) of this Section and (2) the ratio 29 30 of the number of months in which household income did not include such cash assistance over \$55 to the number twelve. 31 32 If household income did not include such cash assistance over 33 \$55 for any months during the year, the amount of the grant to which the household is entitled shall be the maximum 34

1 amount computed as specified in subsection (b) of this 2 Section. For purposes of this paragraph (c), "cash 3 assistance" does not include any amount received under the 4 federal Supplemental Security Income (SSI) program.

5 Joint ownership. If title to the residence is held (d) 6 jointly by the claimant with a person who is not a member of 7 his or her household, the amount of property taxes accrued 8 used in computing the amount of grant to which he or she is 9 entitled shall be the same percentage of property taxes accrued as is the percentage of ownership held by the 10 11 claimant in the residence.

(e) More than one residence. If a claimant has occupied 12 more than one residence in the taxable year, he or she may 13 claim only one residence for any part of a month. 14 In the 15 case of property taxes accrued, he or she shall prorate 1/12 16 of the total property taxes accrued on his or her residence to each month that he or she owned and occupied that 17 residence; and, in the case of rent constituting property 18 19 taxes accrued, shall prorate each month's rent payments to the residence actually occupied during that month. 20

21 (f) There is hereby established a program of 22 pharmaceutical assistance to the aged and disabled which 23 shall be administered by the Department in accordance with this Act, to consist of payments to authorized pharmacies, on 24 25 behalf of beneficiaries of the program, for the reasonable costs of covered prescription drugs. Each beneficiary who 26 pays \$5 for an identification card shall pay no additional 27 Each beneficiary who pays \$25 for an prescription costs. 28 29 identification card shall pay \$3 per prescription. In addition, after a beneficiary receives \$2,000 in benefits 30 during a State fiscal year, that beneficiary shall also be 31 32 charged 20% of the cost of each prescription for which 33 payments are made by the program during the remainder of the 34 fiscal year. To become a beneficiary under this program a

1 person must: (1) be (i) 65 years of age or older, or (ii) the 2 surviving spouse of such a claimant, who at the time of death received or was entitled to receive benefits pursuant to this 3 4 subsection, which surviving spouse will become 65 years of 5 age within the 24 months immediately following the death of 6 such claimant and which surviving spouse but for his or her age is otherwise qualified to receive benefits pursuant to 7 subsection, or (iii) disabled, and (2) be domiciled in 8 this 9 this State at the time he or she files his or her claim, and (3) have a maximum household income of less than \$14,000 for 10 11 grant years before the 1998 grant year, less than \$16,000 for the 1998 and 1999 grant years, and less than (i) \$21,218 for 12 \$28,480 for a a household containing one person, (ii) 13 household containing 2 persons, or (iii) \$35,740 for a 14 15 household containing 3 more persons for the 2000 grant year 16 and thereafter. In addition, each eligible person must (1) obtain an identification card from the Department, (2) at the 17 time the card is obtained, sign a statement assigning to 18 the 19 State of Illinois benefits which may be otherwise claimed 20 under any private insurance plans, and (3) present the 21 identification card to the dispensing pharmacist.

22 Whenever a generic equivalent for a covered prescription 23 drug is available, the Department shall reimburse only for the reasonable costs of the generic equivalent, less the 24 25 co-pay established in this Section, unless (i) the covered prescription drug contains one or more ingredients defined as 26 a narrow therapeutic index drug at 21 CFR 320.33, (ii) the 27 prescriber indicates on the face of the prescription "brand 28 medically necessary", and (iii) the prescriber specifies that 29 30 a substitution is not permitted. When issuing an oral prescription for covered prescription medication described in 31 32 item (i) of this paragraph, the prescriber shall stipulate "brand medically necessary" and that a substitution is not 33 permitted. If the covered prescription drug and 34 its

1 authorizing prescription do not meet the criteria listed 2 above, the beneficiary may purchase the non-generic equivalent of the covered prescription drug by paying the 3 4 difference between the generic cost and the non-generic cost 5 plus the beneficiary co-pay.

6 person otherwise eligible for pharmaceutical Anv 7 assistance under this Act whose covered drugs are covered by 8 any public program for assistance in purchasing any covered 9 prescription drugs shall be ineligible for assistance under this Act to the extent such costs are covered by such other 10 11 plan.

The fee to be charged by the Department for 12 the identification card shall be equal to \$5 per coverage year 13 for persons below the official poverty line as defined by the 14 United States Department of Health and Human Services and \$25 15 16 per coverage year for all other persons.

In the event that 2 or more persons are eligible for 17 anv 18 benefit under this Act, and are members of the same 19 household, (1) each such person shall be entitled to the pharmaceutical assistance program, 20 participate in 21 provided that he or she meets all other requirements imposed by this subsection and (2) each participating household 22 23 member contributes the fee required for that person by the 24 preceding paragraph for the purpose of obtaining an 25 identification card.
