- 19 Sec. 10-10. Board of education; Term; Vacancy. All
- 20 school districts having a population of not fewer than 1,000
- and not more than 500,000 inhabitants, as ascertained by any
- 22 special or general census, and not governed by special Acts,
- 23 shall be governed by a board of education consisting of 7
- 24 members, serving without compensation except as herein
- 25 provided. Each member shall be elected for a term of 4 years
- 26 except as otherwise provided in subsection (a-5) of Section
- 27 11B-7 for the initial members of the board of education of a
- 28 combined school district to which that subsection applies. If
- 5 members are elected in 1983 pursuant to the extension of
- 30 terms provided by law for transition to the consolidated

Thereafter members elected in such districts shall be elected to a 6 22 23 year term. If at the regular school election held in the first odd-numbered year after the determination to elect 24 25 members for 6 year terms 4 members are elected, 3 shall serve for a term of 6 years and one shall serve for a term of 226 years; and of the members elected at the next regular school 27 election 2 shall serve for terms of 6 years and 2 shall serve 28 for terms of 2 years. Thereafter members elected in such 29 30 districts shall be elected to a 6 year term. If at the regular school election held in the first odd-numbered year 31 32 after the determination to elect members for a 6 year term 5 members are elected, 3 shall serve for a term of 6 years and 33 34 2 shall serve for a term of 2 years; and of the members

1 elected at the next regular school election 2 shall serve for 2 terms of 6 years and 2 shall serve for terms of 2 years. Thereafter members elected in such districts shall be elected 3 4 to a 6 year term. An election for board members shall not be 5 held in school districts which by consolidation, annexation or otherwise shall cease to exist as a school district within 6 6 months after the election date, and the term of all board 7 8 members which would otherwise terminate shall be continued until such district shall cease to exist. Each member 9 on the date of his or her election, shall be a citizen of the 10 11 United States of the age of 18 years or over, shall be a resident of the State and the territory of the district for 12 at least one year immediately preceding his or her election, 13 shall be a registered voter as provided in the general 14 15 election law, and shall not be a school trustee or a school treasurer, and shall not be a child sex offender as defined 16 in Section 11-9.3 of the Criminal Code of 1961. When the 17 board of education is the successor of the school directors, 18 all rights of property, and all rights regarding causes of 19 action existing or vested in such directors, shall vest in it 20 21 as fully as they were vested in the school directors. of members are subject to Section 2A-54 of the Election Code. 22 23 Nomination papers filed under this Section are not valid unless the candidate named therein files with the secretary 24 25 of the board of education or with a person designated by the board to receive nominating petitions a receipt from the 26 county clerk showing that the candidate has filed a statement 27 required interests as by the Illinois 28 economic 29 Governmental Ethics Act. Such receipt shall be so filed 30 either previously during the calendar year in which his nomination papers were filed or within the period for the 31 filing of nomination papers in accordance with the general 32 election law. 33 34 Whenever a vacancy occurs, the remaining members shall

1 notify the regional superintendent of that vacancy within 5 2 days after its occurrence and shall proceed to fill the vacancy until the next regular school election, at which 3 4 election a successor shall be elected to serve the remainder of the unexpired term. However, if the vacancy occurs with 5 6 less than 868 days remaining in the term, or if the vacancy 7 occurs less than 88 days before the next regularly scheduled election for this office then the person so appointed shall 8 serve the remainder of the unexpired term, and no election to 9 fill the vacancy shall be held. Should they fail so to act, 10 11 within 45 days after the vacancy occurs, the regional superintendent of schools under whose supervision and control 12 the district is operating, as defined in Section 3-14.2 of 13 this Act, shall within 30 days after the remaining members 14 have failed to fill the vacancy, fill the vacancy as provided 15 16 for herein. Upon the regional superintendent's failure to fill the vacancy, the vacancy shall be filled at the next 17 regularly scheduled election. Whether elected or appointed 18 19 by the remaining members or regional superintendent, the successor shall be an inhabitant of the particular area from 20 21 which his or her predecessor was elected if the residential requirements contained in Section 11A-8, 11B-7, or 12-2 of 22 23 this Act apply.
