Be it enacted by the People of the State of Illinois,represented in the General Assembly:

- Section 5. The State Finance Act is amended by adding

7 <u>Sec. 5.596.</u> The Rotary Club Fund.

8 Section 10. The Illinois Vehicle Code is amended by9 adding Section 3-663 as follows:

11 <u>Sec. 3-663. Rotary Club plates.</u>

12 <u>(a) The Secretary, upon receipt of all applicable fees</u> 13 <u>and applications made in the form prescribed by the</u> 14 <u>Secretary, may issue special registration plates designated</u> 15 <u>as Rotary Club license plates.</u>

16 The special plates issued under this Section shall be 17 affixed only to passenger vehicles of the first division or 18 motor vehicles of the second division weighing not more than 19 <u>8,000 pounds.</u>

20 <u>Plates issued under this Section shall expire according</u>
21 <u>to the multi-year procedure established by Section 3-414.1 of</u>
22 <u>this Code.</u>

(b) The design and color of the special plates shall be
 wholly within the discretion of the Secretary. Appropriate
 documentation, as determined by the Secretary, shall
 accompany each application.

<u>deposited into the Rotary Club Fund and \$15 shall be</u>
 <u>deposited into the Secretary of State Special License Plate</u>
 <u>Fund, to be used by the Secretary to help defray the</u>
 <u>administrative processing costs.</u>

5 For each registration renewal period, a \$25 fee, in 6 addition to the appropriate registration fee, shall be 7 charged. Of this fee, \$23 shall be deposited into the Rotary 8 Club Fund and \$2 shall be deposited into the Secretary of 9 State Special License Plate Fund.

10 (d) The Rotary Club Fund is created as a special fund in 11 the State treasury. All moneys in the Rotary Club Fund shall 12 be paid, subject to appropriation by the General Assembly and 13 approval by the Secretary, as grants for charitable purposes 14 sponsored by the Rotary Club.
