AN ACT concerning military personnel.

Be it enacted by the People of the State of Illinois,represented in the General Assembly:

Section 5. The Military Leave of Absence Act is amended
by changing Section 1 and by adding Section 1.1 as follows:

6 (5 ILCS 325/1) (from Ch. 129, par. 501)

Sec. 1. Any full-time employee of the State of Illinois, a unit of local government, or a school district, other than an independent contractor, who is a member of any reserve component of the United States Armed Forces or of any reserve component of the Illinois State Militia, shall be granted leave from <u>his or her public</u> State employment for any period actively spent in such military service, including:

14 (1) basic training;

15 (2) special or advanced training, whether or not within16 the State, and whether or not voluntary; and

17 (3) annual training.

During <u>these</u> such leaves, the employee's seniority and other benefits shall continue to accrue.

20 During leaves for annual training, the employee shall continue to receive his or her regular compensation as a 21 22 public State employee. During leaves for basic training and up to 60 days of special or advanced training, if the such 23 employee's compensation for military activities is less than 24 25 his or her compensation as a public State employee, he or she 26 shall receive his or her regular compensation as a public 27 State employee minus the amount of his or her base pay for military activities. 28

Sec. 1.1. Home rule. A home rule unit may not regulate its employees in a manner that is inconsistent with this Act. This Section is a limitation under subsection (i) of Section 6, of Article VII of the Illinois Constitution on the concurrent exercise by home rule units of powers and functions exercised by the State.

7 Section 90. The State Mandates Act is amended by adding
8 Section 8.27 as follows:

9 (30 ILCS 805/8.27 new)
10 Sec. 8.27. Exempt mandate. Notwithstanding Sections 6
11 and 8 of this Act, no reimbursement by the State is required
12 for the implementation of any mandate created by this
13 amendatory Act of the 93rd General Assembly.

Section 99. Effective date. This Act takes effect uponbecoming law.
